1. Description of the Plan

The following description of the Northern Light Health Retirement Partnership 403(b) Plan (formerly the EMHS Retirement Partnership 403(b) Plan) (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a defined contribution plan sponsored by Northern Light Health (NLH). Substantially all employees of NLH and certain affiliated organizations named as participating employers in the Plan's adoption agreement (collectively, the Employer) are eligible to participate in the Plan. Employees are eligible immediately upon hire. Employees who complete 1,000 hours of service in the 12 months following their date of hire, and have attained age 21, are eligible to receive employer matching contributions beginning January 1 or July 1 following their one-year anniversary. Fidelity Management Trust Company serves as the Plan's custodian and maintains the Plan's investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides that eligible employees can contribute to the Plan through payroll deferrals at specified percentages of their compensation (as defined under the Plan). Participants may defer up to 84% of their compensation subject to Internal Revenue Service (IRS) limits. Under current IRS regulations, amounts contributed by participants are excluded from the participants' taxable income until such amounts are received by them as a distribution from the Plan. However, the Plan also provides that the employer, when extending the benefits of the Plan to any employee, may place limitations on the amount of employee contributions to comply with certain statutory limitations.

Except for those affiliated organizations mentioned below, employees of the employer who are eligible and participate in the Plan receive an employer matching contribution of 50% (100% for certain grandfathered participants) on the first 4% of the participant's eligible compensation.

Employees of Mercy Hospital and Northern Light Home Care and Hospice who are eligible and participate in the Plan receive an employer matching contribution of 50% (75% for participants with 15 or more years of service) on the first 5% of the participant's eligible compensation. Participants who meet certain eligibility requirements also receive an employer nonelective contribution of 2% (3% if, on the last day of the plan year, the employee earns an hourly wage of \$13.50 or less) of the participant's eligible compensation.

Participants employed by Maine Coast Hospital who meet certain requirements will receive an employer matching contribution of 25% of the first 4% of eligible participants' compensation. Maine Coast Hospital participants may also receive a discretionary non-elective contribution. This discretionary non-elective contribution was 1.25% of the participant's eligible compensation (3% for union employees) for 2024 and 2023.

Participants employed by Seabastcook Valley Hospital who meet certain requirements will receive an employer matching contribution of 50% of the first 7% of participant's eligible compensation.

Participants employed by A.R. Gould Hospital who meet certain requirements will receive an employer matching contribution of 100% on the first 1% of the participant's eligible compensation (2% for participant's with at least five or more years of service). Participants who meet certain eligibility requirements also receive an employer nonelective contribution ranging from 2% - 3.5% dependent upon years of service.

Participants employed by Mayo Hospital who meet certain requirements received an employer matching contribution of 100% of the first 2% of the participant's eligible compensation. Mayo Hospital participants may also receive a discretionary matching contribution.

Investment Options – Participants may direct their contributions, employer match contributions and any related earnings into various investment options. Investment objectives are as stated in the prospectus. The Plan currently offers several mutual funds and a guaranteed annuity contract as investment options for participants.

Vesting – Participants are fully vested at all times in their employee elective deferral account and are not subject to forfeiture for any reason. Participants are fully vested in employer contributions after three years of vesting service.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$269,703 and \$76,765, respectively. Forfeited balances of terminated participants will be used to reduce administrative fees and future employer contributions. During the years ended December 31, 2024 and 2023, \$89,305 and \$245,782, respectively, of forfeitures were used.

Payment of Benefits – Participants receive distributions upon the occurrence of the following events: (i) termination of employment, (ii) attaining normal retirement age, (iii) becoming disabled, (iv) demonstration by the participant to the plan administrator that the participant is experiencing hardship, as defined in applicable regulations promulgated or to be promulgated pursuant to Section 403(b) of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or his/her delegate, or (v) attainment of age 59½. Participants may elect to receive part or all of his/her distribution in a lump sum, installment, an annuity, or have the amounts rolled over. Absent an election by the participant, distributions of less than \$1,000 are made in a lump sum; distributions between \$1,000 and \$7,000 (\$5,000 in 2023) are automatically rolled over to an IRA; and amounts over \$7,000 (\$5,000 in 2023) are maintained in the Plan.

Participant Accounts – Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, rollovers and allocations of (1) employer discretionary contributions, and (2) plan earnings, and charged with an allocation of Plan losses and expenses. Allocations are based on participant earnings of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants – Participants may borrow from their own contributions up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's accounts and bear interest at rates that range from 4.25% to 9.50%. Interest rates are set at prime plus 1% at the time of the loan. Principal and interest is paid ratably through a monthly debit from the participant's savings or checking account.

2. Summary of Significant Accounting Policies

Method of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various mutual funds and a group annuity contract which invests in various securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits – Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in mutual funds are stated at net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. See Note 8 for discussion of fair value measurement.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses – The Plan allows for payment of any expenses incurred in administering the Plan to be paid by either the Employer or the Plan. For the years ended December 31, 2024 and 2023, respectively, the Plan paid for \$1,092,397 and \$1,045,768 of administrative expenses related to plan administration, with remaining expenses paid for by the Employer. Expenses paid for by the Employer are not reflected in these financial statements.

3. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

4. Information Certified by the Custodian of the Plan

The Plan's financial statements and supplemental schedule were derived from information prepared and certified by Fidelity Management Trust Company, the custodian of the Plan, and furnished to the plan administrator. This information is disclosed in the following:

5. Party-in-Interest Transactions

ERISA defines a party-in-interest to include any person who provides services to the Plan. Plan investments include shares of mutual funds sponsored and managed by Fidelity Investments (Fidelity). Fidelity Management Trust Company, an affiliate of Fidelity, is the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Services Agreement (MSA) between the Employer and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the years ended December 31, 2024 and 2023, \$152,606 and \$136,969, respectively, were remitted to the Plan and \$29,128 and \$27,934, respectively, were applied to the payment of administrative expenses. The remaining unallocated balance of \$159,748 and \$81,015 as of December 31, 2024 and 2023, respectively, is included in investments at fair value in the accompanying financial statements.

Participants are directly charged a quarterly flat fee of \$10.75 for 2024 and 2023. Total record keeper fees paid to Fidelity were \$774,109 and \$745,237 for the years ended December 31, 2024 and 2023, respectively. Audit and retirement consultant fees paid by the Plan were \$318,288 and \$300,531 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status of the Plan

The Plan utilizes a prototype 403(b) plan document. The IRS approved the prototype plan document, and the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

8. Fair Value Measurement

The framework for measuring fair value in accordance with U.S. GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
