INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the
Praxis Engineering Technologies, LLC. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Praxis Engineering Technologies, LLC. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

(1) Plan Description

The following description of the Praxis Engineering Technologies, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

(a) General

The Plan, established January 1, 2002, was a defined contribution plan covering substantially all full-time, part-time, and seasonal employees of Praxis Engineering Technologies, LLC, a subsidiary of General Dynamics Information Technology, a General Dynamics Corporation business unit. Under the provisions of the Plan, an employee could become a participant on the first day of employment or upon reaching age 18, whichever came later. Effective December 31, 2018, General Dynamics Corporation became the Plan Sponsor (the Employer; the Plan Sponsor). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2024, the Plan's assets were merged into the General Dynamics Corporation 401(k) QACA Plan (the QACA Plan). As a result of the merger, the Plan's participants, formerly eligible to participate in the Plan became eligible to participate in the QACA Plan effective January 1, 2025.

(b) Contributions

Eligible employees could elect to defer from 1% to 75% of eligible compensation as pre-tax deferrals or Roth deferrals or after-tax contributions, up to the statutory limits defined by the Internal Revenue Code (IRC), and have such deferrals remitted by the Employer to his or her account under the Plan. After-tax contributions were permitted up to the statutory limits defined by the IRC. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan had an Employer matching contribution of 100% of the first 3% of eligible compensation contributed to the Plan, and 50% of the next 3 to 6% of eligible compensation contributed to the Plan. The Plan was intended to be a safe harbor plan as defined in the IRC.

Each year, the Employer could make a discretionary profit-sharing contribution on behalf of all participants. The contribution was calculated based on each participant's compensation, as defined by the Plan. Total discretionary profit-sharing contributions made by the Employer for the years ended December 31, 2024 and 2023 were \$1,351,569 and \$1,469,258, respectively. These amounts are reflected in Contributions receivable - Employer at each respective period end.

(c) Participant Accounts

Each participant directed his or her contributions to be invested in various funds. Changes to investment elections could be made according to rules set by the Plan Document. Each participant's account was credited with the participant's contributions and allocations of (a) the Employer's

contributions, if any, and (b) Plan earnings and losses, less an allocation of administrative expenses. The benefit to which a participant was entitled was the vested balance of his or her account.

(d) *Vesting*

Participants were immediately vested in their elective contributions and actual earnings thereon. Vesting in the Employer contributions portion of their accounts was based on years of continuous service. Any participant employed on or prior to December 31, 2018 was always 100% vested on discretionary employer profit-sharing contributions. Participants hired after December 31, 2018 were 100% vested on their discretionary profit-sharing contributions after three years of credited service.

Participants were 100% vested on their safe harbor Employer contributions after two years of credited service. A year of credited service was a plan year in which the Participant is employed for consecutive twelve months. Upon termination of employment due to death, disability (approved by Social Security), or satisfied the conditions for Early Retirement Age, as defined in the Plan Document, a participant became fully vested in their account.

(e) *Payment of Benefits*

A participant could elect to receive an amount equal to the value of the Participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over the life expectancy of the Participant and/or designated beneficiary. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

(f) *Forfeitures*

Forfeitures could be used to offset Employer contributions. At December 31, 2024 and 2023, participants' forfeited non-vested accounts were not significant. Forfeitures used during 2024 to reduce Employer contributions were not significant. The remaining balances of forfeitures available to offset future matching contributions and administrative expenses as of December 31, 2024 and 2023, were \$175,322 and \$174,964, respectively.

(g) *Notes Receivable from Participants*

The Plan permitted participants to borrow the lesser of \$50,000 or 50% of the vested amount in their accounts (subject to limits defined in the Plan Document and by the IRC). Loans were secured by the remaining vested portion of the participants' account. Participants were permitted to obtain up to two loans from the Plan, which bore the prime rate of interest plus 1% as determined by the Employer. Principal and interest were paid ratably through automatic payroll deductions. Participant loans were recorded at amortized cost, which was the remaining unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

(h) *Transfer Due to Merger*

Effective December 31, 2024, the Plan was merged into the QACA Plan. The account balances, Employer contributions receivable, and notes receivable from participants were merged into the QACA Plan in the amounts of \$104,956,249, \$1,351,569, and \$552,879, respectively.

(i) *Risks and Uncertainties*

The Plan invested in various investments. Investments were exposed to various risks such as interest rate, market, liquidity, and credit risks, as well as risk associated with global events. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

(2) *Summary of Significant Accounting Policies*

(a) *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) *Use of Estimates*

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

(c) *Investment Valuation and Income Recognition*

As of December 31, 2024, the Plan held no investments due to the merger, as discussed in Note 1(h). Prior to the merger, the Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Investment income consists of dividend income, interest income and net appreciation (depreciation) in the fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) *Payment of Benefits*

Benefits are recorded when paid.

(e) *Administrative Expenses*

Certain administrative expenses were paid by the Employer on behalf of the Plan. Expenses that were paid by the Employer are excluded from these financial statements. The administrative expenses paid by the Employer on behalf of the Plan were not significant for the year ended December 31, 2024.

Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

(f) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amount allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

(3) Certified Investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments, at fair value, and notes receivable from participants at December 31, 2024 and 2023, and interest and dividend income, interest on notes receivable from participants and net appreciation in fair value of investments for the year ended December 31, 2024, that are disclosed in the accompanying financial statements, Note 4 and the supplemental schedules were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. This information has not been audited by independent accountants.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the assets or liabilities;
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies: Valued at the closing price reported on the active market in which the individual securities are traded (Level 1).

Pooled separate account: Investments in units of the pooled separate account are valued at the net unit value as reported by the pooled separate account, which is obtained from pricing services or other pricing sources. The inputs used by the pricing services are reviewed quarterly or when the pricing vendor issues updates to its pricing methodologies (Level 2). Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net unit value per unit.

Units of collective trusts: The fair values of these private investment securities are determined using the net asset value as provided by the fund managers (Level 2). Investments in collective trusts are redeemable daily at net asset value, and there are no restrictions on redemptions except for the Emerging Markets Fund Class R1 which requires a written notice of five business days for directed withdrawals that exceed \$1 million.

Due to the merger of the Plan into the QACA Plan, the Plan's investments were liquidated and transferred to the QACA Plan. As a result, the Plan held no assets as of December 31, 2024. (5) Party-in-Interest Transactions

The Plan invested in investment funds managed by Putnam Fiduciary Trust Company (Putnam). Prior to the merger discussed in Note 1(h), Putnam was an affiliate of Empower Annuity Insurance Company of America, a third-party administrator of the Plan. Prior to the merger discussed in Note 1(h), these funds were

considered party-in-interest investments. Fees paid by the Plan to various service providers also qualified as exempt party-in-interest transactions.

Notes receivable from participants and excess contributions payable are also considered exempt party-in-interest transactions.

(6) Plan Termination

Prior to the merger of the Plan into the QACA Plan, the Employer had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would have become one hundred percent vested in their accounts.

(7) Tax Status

The Internal Revenue Service (IRS) issued an opinion letter on June 30, 2020, indicating that the volume submitter plan adopted by the Plan Sponsor, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Sponsor and the Plan's counsel believe the Plan was designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Under the IRS statute of limitations, the Plan is no longer subject to income tax examinations for years prior to 2021.


