Notes to Financial Statements

Year Ended September 30, 2024

1. Description of plan:

The following description of 401(k) Profit Sharing Plan for Employees of Beacon Group, Inc. (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in October 1985 and has been amended since that date.

General:

The sponsor of the Plan is Beacon Group, Inc. (Sponsor or Organization). The Plan is a defined contribution plan covering all employees of the Sponsor with the exception of highly compensated employees, collectively bargained employees, non-resident aliens with no U.S. source income, leased employees, and employees with severe disabilities who are provided with vocational training, unless they are subject to the Service Contract Act. Service Contract Act employees are eligible for the deferral provisions of the plan, and receive prevailing wage employer contributions in lieu of employer matching or profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Sponsor elected to transfer administrative and custodial services from Mutual of America to Lincoln Financial Group (Lincoln) effective April 2, 2024. All assets and liabilities associated with the Plan and participants' accounts were transferred to Lincoln as of the effective date of the Lincoln plan.

Participant contributions:

Under the contribution provisions of the Plan, the participants may elect to defer a percentage of their pretax or after-tax annual compensation up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Employees who have completed one month of service are eligible to participate in the 401(k) provisions of the Plan. The Plan permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

The Plan offers automatic enrollment. Eligible employees will be enrolled at a contribution rate of 4% of eligible pretax compensation unless the employee elects to decline participation or to defer a different percentage of pretax or after-tax compensation, subject to current statutory limits determined annually and prescribed by the IRS.

1. Description of plan (continued):

Employer contributions:

Employer matching and base profit sharing contributions for those employees that are not subject to the Service Contract Act are at the Sponsor's discretion. The Sponsor may choose to contribute and allocate to each active participant's account a matching and/or base profit sharing contribution equal to a percentage of wages, a percentage of salary deferrals or a uniform dollar amount. The Organization's Board of Directors determines the contribution percentage or amount, if any, at the end of each plan year. The Plan required participants complete three consecutive months of service and 250 hours of service to be eligible for employer matching contributions. The Plan was amended effective April 2, 2024, eliminating the 250 hour service requirement for employer matching contributions. Participants must have completed one year of service with at least 1,000 credited hours and be employed on the last day of the plan year to be eligible for base profit sharing contributions. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions.

For 2024, the Plan Sponsor elected to make quarterly matching contributions up to 4% of eligible wages, allocated to eligible employees that are not subject to the Service Contract Act. There were no profit sharing contributions made for 2024.

Employees subject to the Service Contract Act receive prevailing wage employer contributions, calculated monthly based on the required contribution rates for the employment classifications under the applicable Federal, state or municipal prevailing wage laws. Service Contract Act employees are immediately eligible for these employer contributions.

Participants' accounts:

Each participant's account is credited with the participant's elective deferral, employer and rollover contributions, actual earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their elective deferral contributions, including rollovers, plus actual earnings thereon. For employees that are not subject to the Service Contract Act, vesting in the employer base profit sharing and matching contribution portion of the participants' accounts plus actual earnings thereon is based on years of elapsed time. Participants vest at 20% annually beginning with the completion of the second year of elapsed time and are fully vested after 6 years of elapsed time or once the normal retirement age is met. Under the elapsed time method, the Plan defines a period of service as years and any fraction of a month being considered as one-twelfth of a year on a basis that 365 days equal one year. Upon the death or total disability of any participant prior to retirement, the participant's account balance shall become fully vested. Employees subject to the Service Contract Act are immediately vested in prevailing wage contributions.

1. Description of plan (continued):

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increment into any of several investment options. Participants may change their investment options at any time.

Participant loans:

The Plan allows for participants to obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% or \$50,000, if less, of the vested portion of the participant's account and must be a minimum of \$1,000. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the repayment period will be extended to ten years. All loans will provide for the repayment of interest at prime plus 1% on the date of the loan. The participant's individual account serves as collateral for the loan, and in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statement of net assets available for benefits as notes receivable from participants.

Payment of benefits:

On termination of service due to death, disability, retirement or election at age 59 1/2, a participant who has a vested account balance exceeding \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account, a partial lump sum, or installment payments as soon as administratively feasible following their termination of employment. Participants with vested account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. Mandatory automatic distributions under the plan in excess of \$1,000 may be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions. Participants with vested account balances less than \$1,000 will have their entire balance distributed to them in a lump sum, even if they did not consent to a distribution.

Forfeitures:

Forfeitures of terminated participants' nonvested account balances may first be used to pay plan expenses and are then treated as a reduction of the employer's matching or base profit-sharing contributions. At September 30, 2024 and 2023, there were \$27,014 and \$0 of nonvested amounts to be used in future periods.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the vested portion of his/her individual account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administration expenses and are expensed when they are incurred.

2. Summary of significant accounting policies (continued):

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated the events that have occurred subsequent to September 30, 2024 through June 24, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor has adopted a non-standardized pre-approved profit sharing plan as published by Lincoln Retirement Services Company LLC, which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan qualified, and the related trust tax-exempt.

Prior to April 2, 2024, the Sponsor had adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan as published by Mutual of America Financial Group, which obtained its latest opinion letter on November 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the closing price reported in the active market in which the individual securities are traded.

Interest-bearing cash: Consists of highly liquid instruments that generate interest income. The carrying value of interest-bearing cash is its fair value.

Pooled separate accounts: These funds' assets are invested and reinvested primarily in mutual funds. Investments are valued using pricing data provided by outside valuation service providers. Each account is valued at its net asset value, which is used as a practical expedient to estimate fair value. The net asset value of the accounts' units is determined daily and includes adjustments for investment fees.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured using the NAV per share practical expedient:

The investment strategies for the various types of pooled separate accounts are as follows:

Equity funds: These funds consist of professionally managed investment products primarily invested in equity instruments to create a diversified pool of securities to achieve growth objectives.

Fixed income funds: These funds consist of professionally managed investment products primarily invested in debt instruments with the objective of generating income.

Target date funds: These funds consist of a blend of investments that are re-balanced over time to address retirement goals. Funds with longer horizons are invested more aggressively to achieve growth objectives while shorter-term funds are invested in more conservative securities with the objective of generating income.

5. Investment certification:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest income, dividend income and other income for the year ended September 30, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. as of September 30, 2024, and for the period April 3, 2024, through September 30, 2024, and Mutual of America Life Insurance Company as of September 30, 2023, and for the period October 1, 2023, through April 2, 2024.

6. Related party transactions and party in interest transactions:

Exempt party in interest transactions:

Certain Plan investments are managed by Lincoln Financial Group Trust Company and Mutual of America Life Insurance Company. The Plan paid certain expenses to Lincoln, Mutual of America Life Insurance Company and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

6. Related party transactions and party in interest transactions (continued):

Related party transactions:

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

Non-Exempt party in interest transactions:

The Sponsor failed to timely remit to the Plan certain employee deferral contributions, including loan repayments, totaling \$30,970 for the year ended September 30, 2024. Under ERISA, these are considered non-exempt party in interest transactions. The late remittances were the result of administrative oversight, which has since been addressed by management.

7. Investment contract with insurance company:

In 2024, the Plan entered into a benefit-responsive group fixed annuity investment contract with Lincoln National Life Insurance Company (Lincoln National). Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

7. Investment contract with insurance company (continued):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events may include the following: any charges billed to the contract owner that haven't been paid to Lincoln National within 30 days, the Plan ceases to meet the requirements of the IRC for purchasers of this contract, any time following the end of the third contract year that the contract owner's balance is less than \$15,000, any time following the end of the third contract year where there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000, or the contract owner fails to furnish requested information or other documentation, misrepresentation of material information is discovered, the issuer discontinues the offering of the contract form to the public or the Plan terminates its record keeping agreement with Lincoln Financial Group.

8. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

9. Risks and uncertainties:

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
