### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sternberg, Inc 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefit for the year ended September 30, 2024 and 2023, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sternberg, Inc 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sternberg, Inc 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***NOTE 1-PLAN DESCRIPTION***

The following brief description of the Sternberg, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for more a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan which covers all full-time employees of the Company who have completed 3 months of service and attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA).

Effective October 1, 2015, the DJ Leasing LLC Plan was merged into the Plan. Assets transferred to the Plan as a result of the merger was \$923,615.

CONTRIBUTIONS

Participants may contribute up to 15 percent of their eligible compensation. The maximum contribution allowed for each participant for the calendar year 2024 and 2023 was \$23,000 and \$22,500. The maximum contribution allowed for each participant age 50 and over for the calendar year 2024 and 2023 was \$30,500 and \$30,000. The Company may contribute additional amounts at the option of the Company's Board of Directors.

PARTICIPANT ACCOUNTS

Each Plan participant has three separate accounts within the Plan:

DEFERRAL ACCOUNT

Consists of pre-tax elective deferral contributions made by employees and the corresponding earnings on these contributions.

PROFIT-SHARING ACCOUNT

Consists of employer's discretionary contributions and the corresponding earnings on these contributions.

ROLLOVER ACCOUNT

Consists of new participant's vested fund balances rolled over from a prior retirement plan as well as the corresponding earnings on these balances.

***NOTE 1-PLAN DESCRIPTION (CONTINUED)***

***INVESTMENT OPTIONS***

Participants may direct the investment of their account balances in any of six investment options. Participants may change their investment options quarterly.

***PAYMENT OF BENEFITS***

On termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in the form of an installment.

***VESTING***

Employees are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of service using the six year grading schedule.

***FORFEITURES***

Forfeitures are allocated to participants at the end of the fiscal year in proportion to their compensation as a percentage of the compensation of all eligible participants.

***ADMINISTRATIVE EXPENSES***

All trustee expenses incurred by the Plan are the responsibility of the Plan. However, at the discretion of the Plan Sponsor, some expenses may be paid by the Plan Sponsor.

***RISKS AND UNCERTAINTIES***

The Plan holds various investment instruments, including, but not limited to, mutual funds and money market funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes can materially affect participants' account balances and the amounts reported in the financial statements.

***NOTE 2-SIGNIFICANT ACCOUNTING POLICIES***

***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared under the accrual method of accounting.

***INVESTMENT VALUATION AND INCOME RECOGNITION***

Investments are recorded at fair market value as determined by quote market prices of the securities held in the funds. The unrealized appreciation or depreciation of the investments, based upon the quote market value at September 30 is recorded as an increase or decrease in net assets available for benefits.

***VALUATION OF INVESTMENTS***

The Plan's investments are stated at fair value. Quoted market prices are used to value investments.

***PAYMENT OF BENEFITS***

Benefits are recorded when paid.

***USE OF ESTIMATES***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***DATE OF MANAGEMENT'S REVIEW***

Management has evaluated subsequent events through June 2, 2025, the date on which the financial statements were available to be issued.

***NOTE 3-TAX STATUS***

The Internal Revenue Service has determined and informed the Company by letter dated February 2, 1998 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

***NOTE 4-SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN***

The following information was certified by Reliant Trust Company as of September 30, 2024 and 2023, the trustee of the Plan, as permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

***5 - PARTY - IN - INTEREST TRANSACTIONS***

As of September 30, 2024 and 2023, Plan investments included units held in a collective trust managed by LPL Financial. Transaction with this entity qualify as exempt party - interest transactions. Fees paid by the Plan to LPL Financial were \$25,827 and \$23,178 for September 2024 and 2023, respectively. Fees paid by the Plan to ADP, Inc. were \$25,222 and \$25,960 for 2024 and 2023, respectively.

***Note 6 - FAIR VALUE MEASUREMENTS:***

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to process.

Level 2 - Inputs to the valuation methodology include

- \* Quoted prices for similar assets and liabilities in active markets;
- \* Quoted prices for identical assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;  
and
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2022.

*Interest bearing cash and mutual funds* - These investments consist of various publicly-traded money market funds and mutual funds. The fair values are based on quoted market prices

*Pooled separate accounts* - These investments are measured using the NAV practical expedient. The NAV practical is based on the fair value of the underlying assets owned by the PSA, less its liability and divided by the number of units outstanding.

*Guaranteed interest accounts* - These investments have a guarantee of principal and interest. The fair value is determined by the principal and interest earnings based on the minimum guaranteed interest rate.

*Investment contracts* - These investments are valued using the market approach and observable inputs, such as trad prices, multiple quotes, related yield curves and other assumptions.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 8 - TAX STATUS**

Management believes that the Plan is qualified under Section 401 of the Internal Revenue code, and therefore is exempt from taxation under Section 501(a). The prototype sponsor has provided the Company with a determination letter from the Internal Revenue Service wherein the Plan was deemed to be accepted under Section 401.

Generally, contributions to a qualified plan are deductible by the Company when made, are tax exempt, and participants are not taxed on their benefits until withdrawn from the plan.

Management is unaware of any variations in the operations of the Plan from the terms of the Plan documents as amended. Management believes the Plan is qualified under the applicable sections of the Internal Revenue Code and ERISA.

There are no material tax positions taken by the Company which require recognition or disclosure under Financial Accounting Standards Board Interpretation No. 48 "Accounting for Uncertainty in Income Taxes." The Company's Annual Return/Report of Employee Benefit Plan for year 2022, 2023 and 2024 are subject to examination by taxing authorities.

**NOTE 9 - ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are held by the 2024 and 2023 trustee, Reliant Trust Company.

For 2024 and 2023 the recordkeeping services were provided by ADP.

Company contributions are managed by the custodian, which invests cash received, interest and dividend income and makes distributions to participants.

Administrative functions are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.
