Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MORSECORP Inc 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF PLAN

The following description of MORSECORP Inc 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution 401(k) plan covering substantially all employees of MORSECORP, Inc. (the Plan Sponsor) (the Company). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitors investment performance, and reports to the Plan Sponsor's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees are eligible to participate in the Plan and receive the Plan Sponsor's safe harbor matching contributions on their first day of employment upon achieving the age of twenty-one. Employees covered by a collective bargaining agreement and non-resident aliens are excluded from participating in the Plan. Employees will also become eligible for the Plan Sponsor's discretionary non-elective contributions, if any, when they have completed 1,000 hours of service and are employed by the Plan Sponsor on the last day of the contribution period.

c. Contributions

Each year, participants may contribute up to 92% of pre-tax annual compensation, as defined in the plan document, to the maximum allowed by the Internal Revenue Code (IRC). The Plan allows for catch-up contributions for participants who have attained age fifty by the end of the plan year. The Plan allows participants to make post-tax (Roth) contributions. Participants may contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution of 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of the next 2% of eligible compensation. During 2024, the Company made safe harbor matching contributions of \$809,957. The Plan also allows for discretionary non-elective contributions based on the Company's approval which is determined annually. For the year ended December 31, 2024, there were no Plan Sponsor discretionary non-elective contributions made to the Plan.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor contributions, if any, and plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings or losses, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are fully vested in their own contributions, the Plan Sponsor's safe harbor matching contributions, plus actual earnings or losses thereon. Participants vest in the Plan Sponsor discretionary non-elective contributions based on a six-year graduated schedule as follows:

3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Participants become fully vested upon attainment of normal retirement age, death or disability.

f. Payment of Benefits

Upon normal retirement at age 65 or termination of services, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested account balance, installments, or a partial payment, or leave their balance in the Plan if the balance is over \$5,000. There is no option for early retirement. Participants with account balances less than \$1,000 will be distributed automatically. Participants with account balances with a value greater than \$1,000 but less than \$5,000 will automatically have their entire amount rolled over to an individual retirement account (IRA). Effective January 1, 2024, the Plan Administrator adopted the optional SECURE Act 2.0 provision to increase the limit of involuntary force-out distributions from \$5,000 to \$7,000. There are also retirement benefits available upon disability or death.

The Plan allows for in-service withdrawals upon attainment of age 59 ½, disability, under the active military distribution provision, and under the qualified reservist distribution provision. Hardship distributions are not allowed.

g. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the loan term may be up to ten years. The interest rate is set at a commercially reasonable rate determined by the Plan Administrator. Participants may only have one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions. There were no notes receivable from participants as of December 31, 2024 and 2023.

h. Forfeitures

Forfeitures represent non-vested Plan Sponsor discretionary non-elective contributions of participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor contributions and plan expenses. There were no unallocated forfeited accounts as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds. Mutual fund investments are stated at fair market value as determined by the qualified institution based upon the last reported sales price on the last business day of the plan year. Gains and losses are recognized as incurred upon sale or maturity of investments or based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income, including interest income on notes receivable from participants, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual funds includes realized and unrealized gains and losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. During the year ended December 31, 2024, there were no defaulted loans.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Asset management and fees related to the administration of notes receivable from participants and processing of distributions charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of mutual funds.

Subsequent Events

Subsequent events have been evaluated through June 25, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price, and accordingly, these investments are valued using observable inputs. The mutual funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. During 2024, the Plan paid the qualified institution administrative expenses totaling \$22,523.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.
