Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the PM Pediatrics Management Group, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 23, 2024 and December 31, 2023, and for the period from January 1, 2024 through September 23, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As described in Note 1 to the financial statements, the Plan merged into the Aon Pooled Employer Plan (PEP) effective September 23, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the PM Pediatrics Management Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, which was established on March 1, 2003, is a defined contribution plan under Internal Revenue Code Section 401(k), covering all eligible partners and employees of PM Pediatrics Management Group, LLC (the Sponsor). Effective February 8, 2016, the Plan was amended to allow for employees hired as part of the acquisition of Express Pediatrics: Walk in Urgent Care for Children, LLC to become eligible to participate immediately in the Plan. Effective July 1, 2024, the Plan was amended to allow service credit for employees hired as part of the acquisitions of Kindermender, LLC, UrgiKids, and Nite Light Pediatric Center, LLC to count toward service requirements for Plan eligibility.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a defined contribution plan covering substantially all employees who have completed six months of service and are at least 21 years of age.

Investments of the Plan are held by a trust established under the Plan with Principal Life Insurance Company (Principal Life) and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust). The trust invests all contributions and allocates to each participant account its proportionate share of investment income (loss).

Contributions: The Plan agreement provides for the participants to contribute a minimum of 1%, up to a maximum of 100% of pre-tax annual compensation, as defined in the Plan. A participant's total contributions in any year may not exceed the maximum amounts for that year as specified in the Internal Revenue Code. Highly compensated employees may be limited to a smaller contribution. The Plan also accepts Roth 401(k) deferrals as contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

The Sponsor makes a matching contribution of 50% of each participant's contribution which does not exceed 4% of the participant's eligible compensation. For the period from January 1, 2024 through September 23, 2024, the Sponsor made matching contributions of \$1,049,154.

The Plan agreement also provides for the Sponsor's profit-sharing contributions in such amount, if any, as determined by the Sponsor, in its sole discretion, and shall be made from the profits of the Sponsor. There were no profit-sharing contributions made to the Plan during the period from January 1, 2024 through September 23, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) Plan earnings (or losses) and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants shall have a vested percentage in their Sponsor contribution accounts according to a graded vesting schedule based on years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
At least 2 but less than 3	50%
At least 3 but less than 4	75%
4 or more years	100%

A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are available only from accounts deferred through salary reduction and vested Sponsor matching amounts. The loans are secured by the balance in the participants' accounts and bear interest at a rate based on the prime rate on the date of the loan plus 1.5%. Principal and interest are paid ratably through payroll deductions. Loans must be repaid over a period not to exceed five years. Loans used for the purposes of acquiring a primary residence are to be repaid over a period not to exceed twenty years.

Payment of Benefits: Participants' benefits under the Plan are payable to participants, their beneficiaries, or their estates upon the termination of employment, normal retirement, late retirement, disability, or death. Active participants may also take distributions from the Plan upon attainment of age 59½, or in certain circumstances, participants may take hardship withdrawals, as defined by the Plan. Benefits are payable in the form of lump-sum distributions. Participants are entitled to receive a distribution of their rollover accounts at any time.

Forfeitures: Forfeited non-vested accounts are used to reduce future employer contributions. For the period from January 1, 2024 through September 23, 2024, \$107,169 of forfeited accounts were used to reduce employer contributions. Forfeiture account balances were \$8 and \$2,807 at September 23, 2024 and December 31, 2023, respectively.

Plan Transfer Due to Merger: Effective September 23, 2024, the Plan was merged into the AON Pooled Employer Plan (PEP). In connection with the merger, all assets of the Plan were transferred to the PEP on September 23, 2024. All participants of the Plan became participants in the PEP as of the merger date.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: Investments are reported at fair value, other than the guaranteed investment contract, which is recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit responsive investment contract because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, credit, liquidity, and overall market risk, including global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefit payments to participants are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 23, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 through September 23, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair values of participation units held in the collective trusts are based on their net asset values, as reported by the managers of the collective trusts, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The Plan is also able to transact at net asset value daily with the collective trusts without redemption restrictions.

Pooled separate accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. The Plan holds units of pooled separate accounts and a guaranteed interest account issued by Principal Life and invests in collective trust funds held by Principal Global Investors Trust Company, an affiliate of Principal Life. Transactions within these investments are considered party-in-interest transactions, as well as any direct or indirect expenses paid for by the Plan. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions.

NOTE 7 - GUARANTEED AND TRADITIONAL INVESTMENT CONTRACTS

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value, as this is the relevant measurement. Contract value, as reported to the Plan by Principal Life represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date without 90-day notice to Principal Life.

The interest crediting rate is updated semi-annually based on contract provisions. The minimum crediting rate is 1%.

The contract was liquidated in connection with the merger into the PEP effective September 23, 2024, and the assets were transferred to the successor plan as discussed in Note 1. This did not limit the Plan's ability to transact at contract value prior to or at liquidation date.

NOTE 8 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has been amended since the latest opinion letter; however, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 8 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 23, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
