## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees and Participants of  
Private Education Employers' Trust Welfare Benefit Plan

### **Opinion**

We have audited the accompanying financial statements of Private Education Employers' Trust Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Private Education Employers' Trust Welfare Benefit Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. DESCRIPTION OF THE PLAN

The following description of the Private Education Employers' Trust Welfare Benefit Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan.

General

The Plan provides health benefits to eligible employees of the employers participating within the Plan and their covered dependents. At June 30, 2024 and 2023, nine employers were participating within the Plan. Certain Plan assets are held in a voluntary employees' beneficiary association ("VEBA") trust. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 as amended ("ERISA").

Insured benefits

The Plan provides health (medical and prescription drug) benefits. Currently such benefits are provided on a fully insured basis. The Plan purchases an annual insurance contract for these insured benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA") if they so elect. At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums may change. Premiums for all insured benefits were paid from the general assets of the participating employers for the years ended June 30, 2024 and 2023.

Contributions

Participating employers pay an amount equal to the premiums for all covered employees, an allocable share of administrative expenses and an additional amount to establish and maintain a premium stabilization reserve. Participating employers may, at their sole discretion, require their employees to contribute toward the required contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and use of estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the valuation policies and reports to the Trustees of Private Education Employers' Trust. See Note 4 for discussion of fair value measurements.

Benefit obligations

Health care costs incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. The Plan does not provide for post retirement benefits, except as provided by COBRA, and is at the expense of the retiree.

Subsequent events

Management has evaluated subsequent events for the Plan through June 24, 2025, the date the financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology included:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

- *Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes an insurance broker, Cammon Company, to contract with an insurance carrier. Commission and fees of \$315,592 and \$308,164 were paid by the insurance carrier to Cammon Company for the years ended June 30, 2024 and 2023, respectively.

6. INCOME TAXES

The trust established under the Plan to hold the Plan's net assets is qualified, pursuant to Internal Revenue Code Section 501(c)(9), and accordingly, the trust's net investment income is exempt from income taxes. The Plan's trustees believe that the trust, as amended, remains qualified and operating as designed.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur within the near term.

8. TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Plan's Board of Directors has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner.
