**Part I Annual Report Identification Information**

The Aerospace Retiree Medical Plan for Retiree Casuals was established effective 1/1/2024. The initial filing for the plan is a short plan year to align the fiscal year with The Aerospace Welfare Benefits Master Trust (EIN/PN: 95-2102389/005) of October 1 to September 30. In order to align with the 2023 filing for the MTIA (October 1, 2023 to September 2024), the initial filing for The Aerospace Retiree Medical Plan for Retiree Casuals is also a 2023 filing. The beginning date listed on the initial filing is 12/31/2023 instead of the plan effective date of 1/1/2024 to permit a 2023 filing.
