To the Retirement Committee and Plan Administrator Veterans Trading Company, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Veterans Trading Company, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Veterans Trading Company, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements

1. Description of the Plan

The following description of the Veterans Trading Company, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2002, and is a defined contribution plan covering all eligible employees of Veterans Trading Company, Inc. (the Company or Employer). Employees, other than individuals not otherwise classified by the Company as common law employees, are eligible to participate in the Plan upon reaching three months of service. The Plan is intended to be a qualified plan under the Internal Revenue Code (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Eligible employees automatically become participants and are enrolled into the Plan with a 5% deferral rate, unless they elect otherwise. Participant contributions are subject to an annual limit of the lesser of 60% of eligible compensation or \$23,000 (100% and \$30,500, respectively, for participants aged 50 or older). Participants may also make contributions by rollover of distributions from other qualified retirement plans. The Plan allows participant contributions to be designated as Roth contributions and accepts rollovers of Roth designated contributions.

The Company contributes a safe harbor matching contribution of 100% of the amount of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the amount of the participant's next 2% of elective deferrals. The Plan also allows for profit-sharing contributions at the Company's discretion. During the year ended December 31, 2024, the Company elected to make a total profit-sharing contribution of \$301,880.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of earnings, and is charged with withdrawals, and an allocation of losses and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing portion of their accounts plus actual earnings thereon is based on years of continuous service. A year of service requires completion of 1,000 hours of service. A participant is 100% vested after six years of credited service for profit sharing contributions (with 20% vesting each year beginning with two years of service under a six-year graded vesting schedule).

Participant-Directed Options for Investments

Investments are self-directed by the participants of the Plan. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment allocations at any time.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their Plan accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear fixed interest rates ranging from 4.25% to 9.50%, which are commensurate with prevailing rates at the time the funds are borrowed as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to 30 years. A participant may have no more than one outstanding loan at any one time, with not more than two notes approved in any 12-month period. As of December 31, 2024, participant loans have maturities ranging from April 2026 through December 2051.

2. Summary of Significant Accounting Policies

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The Plan Document permits the use of forfeitures to either reduce future Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, there was no forfeiture account balance. During the year ended December 31, 2024, there were no forfeiture amounts available to be used for Company contributions or administrative expenses.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides various investment options to its participants. Investment securities, in general, are exposed to a number of risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with the Plan's investment securities, it is reasonably possible that changes in the values of the Plan's investment securities will occur in the near term and such changes could result in investment balances materially different from the balances reported in the financial statements.

Investment Valuations and Income Recognition

The Plan's mutual funds, common/collective trust funds, pooled separate accounts and participant directed brokerage accounts are stated at fair value. The Plan's guaranteed investment contract is stated at contract value. Shares of mutual funds are stated at quoted market prices. The fair value of units of common/collective trust funds and pooled separate accounts are not based on quoted market prices, but are determined based on the net asset value per share that is based on the values of the underlying investments. Participant directed brokerage accounts are stated at quoted market prices or the net asset value per share that is based on the values of the underlying investments, depending on if the participant has invested in mutual funds or common/collective trust funds and pooled separate accounts.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held as of the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest, and are secured by the participants' account balances. Interest income is recognized over the terms of the notes at the rate specified in the loan documents. Fees related to the notes are recorded as administrative expenses when they are incurred. If a participant defaults, the carrying amount of the note receivable from the participant is eliminated and a benefit payment is recorded at the time the participant has a distributable event.

Administrative Expenses

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Company. During the year ended December 31, 2024, the Plan paid \$31,794 of administrative expenses. Certain administrative expenses are paid by the Company. Investment related expenses are included in net appreciation in the fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid by the Plan.

Subsequent Events

The Plan's management has evaluated events and transactions for potential recognition and disclosure through June 26, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date, based on the Plan's principal or, in the absence of a principal, most advantageous market for the specific asset or liability.

GAAP requires investments to be classified into a three-level hierarchy. The levels in the hierarchy have been established according to the types of inputs to valuation techniques used to measure fair value. Investments are classified in the hierarchy in their entirety based upon the lowest level of the input that was significant to their fair value measurement. Descriptions of the inputs that define the three levels of the hierarchy are as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1, including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.
- Level 3 Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Principal Fixed Income Guaranteed Option

The Plan's guaranteed investment contract investment is referred to as the Principal Fixed Income Guaranteed Option, which is a fully benefit-responsive guaranteed investment contract issued by Principal Life Insurance Company (Principal). The contract guarantees a specified rate of return to the participants in the Plan. The guaranteed rate is reset on a semi-annual basis and is never allowed to be set below a guaranteed minimum interest rate established by the contract. The assets under the contract are backed by the general assets of Principal, and accordingly the contract is a traditional guaranteed investment contract.

The Plan may transact at contract value with the Principal Fixed Income Guaranteed Investment Option, according to the terms defined in the contract, at any time. Certain events limit the ability of the Plan to transact at contract value. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options and (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestiture or spin-off of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA). The Plan Administrator does not believe that the occurrence of any event, which would limit the Plan's ability to transact at contract value with participants, is probable.

If the Plan Sponsor terminates the contract, Principal will pay out the value of that Plan's interest in the contract, subject to a surrender charge. Such notification of termination is irrevocable. Termination of the Plan's interest is made pursuant to the Plan Sponsor's request. The contract with Principal terminates on the date when 1) no guaranteed interest balances have been established that are accepting deposits and 2) there are no guaranteed interest balances with a value greater than zero under the contract. Provisions relating to annuities in the course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made.

4. Exempt Party-In-Interest Transactions

Plan investments include units of common/collective trusts, pooled separate accounts and a guaranteed investment contract managed by affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee of the Plan's investments, and therefore, the Plan's common/collective trust, pooled separate account and guaranteed investment contract transactions qualify as party-in-interest transactions. Fees paid by the Plan to service providers during the year ended December 31, 2024, totaling \$31,794, are party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions. The party-in-interest transactions described above are exempt from the prohibited transaction rules of ERISA.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants become 100% vested in their accounts.

6. Federal Income Tax Status

The Plan uses a prototype plan document sponsored by the trustee of the Plan. The trustee obtained an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Plan management has concluded that as of December 31, 2024, there are no uncertain tax positions that require either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule:

- Investment assets of the Plan
- Investment transactions, including investment earnings (losses)
- Notes receivable from participants and associated transactions
