## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Keiro Northwest 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Keiro Northwest 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Keiro Northwest 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Keiro Northwest 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024 and 2023

### NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN

The provisions of the Keiro Northwest 403(b) Plan (the Plan) were effective October 1, 2004. The Plan has been amended to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document, available from the Plan Sponsor, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Keiro Northwest (the Organization). A participant is eligible to make elective contributions on the first day of the month on or after becoming an employee. After 60 days of eligible service and attaining age 18, employees are eligible to receive employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Contributions

Participants may elect to contribute up to 100% of their pre-tax and Roth after-tax eligible compensation to the Plan, within statutory limits. These contributions are paid to the Plan after each pay period. Participants may elect to change or stop the payroll deductions at any time. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are funded to the Plan after each pay period.

The Organization may make discretionary matching contributions. During 2024, the Organization made matching contributions equal to 50% of the first 2.5% of participant deferrals. The Organization may also make additional discretionary contributions to the Plan. During the year ended December 31, 2024, there were no additional discretionary contributions made to the Plan.

#### Participant Accounts

Individual participant accounts are maintained by the Plan's third party administrator. Each account is credited with the participant's contribution, the Organization's contributions, allocations of investment income and losses on the individual account balances, and administrative expenses. Loan and distribution fees are deducted from the respective participants' accounts. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants direct employee and employer contributions among various mutual funds and a guaranteed interest account.

## **NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)**

### **Vesting**

Participants are immediately vested in their own contributions and rollover contributions plus actual earnings thereon. Vesting in the Organization's discretionary contributions is based on years of credited service, as defined in the Plan document, with 0% vesting with less than three years of service and 100% vesting after three years of service. Upon normal retirement (65), death, or disability, participants become fully vested in all benefits.

### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time of the loan issuance as determined by the Plan Administrator. Interest rates are between 10% and 10.5% on notes receivable outstanding at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

Benefits may be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the value of the participant's vested account may be paid in a lump-sum. Under certain hardship circumstances or attainment of age 59 ½, participants may request a lump-sum distribution of their vested account balances prior to retirement.

### **Subsequent Events**

Effective May 1, 2025, the Plan Administrator elected to change the Plan's record keeper from Principal Life Insurance Company (Principal) to Mutual of America Retirement Services, LLC (Mutual of America), and change the Plan's trustee from Principal Trust Company (Principal Trust) to Mutual of America Securities, LLC (Mutual of America Securities). As a result of these changes, the Plan's assets (approximately \$1,715,000) were liquidated and transferred from Principal Trust to Mutual of America Securities on April 30, 2025, and placed in participant-directed investments. The Principal Guaranteed Option will be terminated and paid out in six installments over the next five years, beginning on July 16, 2025, or the next open market date.

The Plan has evaluated subsequent events through June 20, 2025, the date the financial statements were available to be issued.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies used by the Plan:

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest, if any. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If an active participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees for individual transactions such as distributions and loans are deducted from the respective participant's account. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

## **NOTE 3 – FAIR VALUE MEASUREMENTS**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

### NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The Plan's investments reported at fair value consist solely of mutual funds which are valued as of December 31, 2024 and 2023 using level one measurement.

### NOTE 4 – GUARANTEED INTEREST ACCOUNT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract (guaranteed income fund) with Principal Life Insurance Company (Principal Life). The contract is a guaranteed income fund and is reported at contract value. Contract value is the relevant measure for insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the insurance company general account synthetic investment contract is \$607,190 and \$773,622 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is established by the contract issuer and may not be less than 3%.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The guaranteed investment contract may be terminated by Plan management at any time with a written, twelve months' notice. Principal Life may terminate the contract when the contract is no longer accepting deposits and there are no balances remaining under the contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

- Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan)
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (i.e., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974

#### **NOTE 4 – GUARANTEED INTEREST ACCOUNT WITH INSURANCE COMPANY (continued)**

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

#### **NOTE 5 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule on page 13, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest from guaranteed interest account, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), the trustee of the Plan.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of participation in mutual funds and a guaranteed interest account that are managed by affiliates of Principal Trust, the trustee of the Plan. Therefore, transactions with Principal Trust and its affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services. Additionally, these affiliates collect revenue sharing from the Plan's investments to pay for administrative services.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed an intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **NOTE 8 – INCOME TAX STATUS**

The Plan operates under provisions of a Pre-Approved Plan, which received an opinion letter from the Internal Revenue Service dated March 3, 2017, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of employees. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **NOTE 10 – PROHIBITED TRANSACTIONS**

During years 2021 through 2024, the Organization failed to remit to the Plan's trustee certain participant contributions totaling \$39,249 within the period prescribed by the Department of Labor (DOL) regulations. The Plan sponsor has remitted late participant contributions totaling \$21,059 during 2023 and 2024, with related lost earnings remitted in 2024. The Plan sponsor has remitted late participant contributions totaling \$18,158 during 2021 and 2022, but has not yet remitted related lost earnings. The Plan sponsor has not remitted late contributions totaling \$32 nor related lost earnings.
