## INDEPENDENT AUDITORS' REPORT

To the Pension & Investment Committee of  
AAA NCNU 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of AAA NCNU 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

**1. Description of Plan**

The following description of AAA NCNU 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and/or Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan was adopted by AAA Northern California, Nevada & Utah (the “Company” and “Plan Sponsor”) on January 1, 2012, and was most recently restated effective March 21, 2022. The Plan was amended on December 9, 2022, retroactive to January 1, 2020, for Coronavirus Aid, Relief, and Economic Security Cares Act provisions. The Plan is defined as a contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code (“IRC”) Section 401(k). Employees of the Company and designated related employers are eligible to participate in the Plan upon employment. Excluded employees, described as residents of Puerto Rico, employees covered by a collective bargaining agreement for which retirement benefits have been negotiated, employees hired through a contractual arrangement with an external agency, independent contractors, certain nonresident aliens who have earned no income from sources within the United States of America (“U.S.”), leased employees, and employees not otherwise classified by the Company as a common law employee, are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC.

The Plan allows employees from related employers, AAA NCNU Car Care Plus, Inc.; A3 Labs LLC; A3 Mobility, LLC; AAA MountainWest, Inc.; AAA Arizona Inc.; and A3 Smart Home LP, to participate in the Plan, subject to meeting the Plan’s eligibility requirements.

***Plan Administration***

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) was the appointed trustee for the Plan in 2024 and 2023, and acted at the direction of the Plan’s administrator.

***Contributions***

Employees who elect to participate in the Plan may contribute a portion of their salary up to 75% of their eligible compensation for that period, or up to the limits imposed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to make Roth 401(k) contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes safe harbor matching contributions based on employee elective deferrals. The Company matches 100% of the first 6% of the participant’s eligible compensation, which is deferred each pay period. Additionally, the Plan allows qualified non-elective contributions at the discretion of the Plan Sponsor. For the year ended December 31, 2024, the Company made a discretionary employer contribution to eligible employees based on 6% of eligible compensation. To be eligible, the employee must have been employed on December 31, 2024, or terminated their employment from the Company in 2024, due to disability, retirement, or death. For the year ended December 31, 2024, the discretionary employer contributions totaled \$23,226,802. Participants direct the investment of their contributions into various investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, rollovers from other qualified plans, Company matching contributions, as well as an allocation of the Company's non-elective contribution and Plan earnings or losses. Participants are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participant contributions, rollovers, Company matching contributions, and net earnings on these contributions, are fully vested when made or earned.

Discretionary Company contributions, if any, as well as all earnings on these contributions vest according to the following schedule:

Participants are fully vested upon retirement, death, disability, or Plan termination.

***Notes Receivable from Participants***

Participants are allowed one note receivable at any time and may borrow from their fund accounts a minimum of \$1,000 and up to 50% of the value of their account balance, or \$50,000, whichever is less. Note receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which have a maximum term of 15 years. The notes receivable are secured by no more than 50% of the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the note receivable originates. Interest rates on notes receivable from participants ranged from 3.25% to 10.5% per annum as of December 31, 2024. Principal and interest are paid in equal installments through payroll deductions, personal checks from employees on leave, or cashier's checks for the full payoff of the notes receivable.

***Payments of Benefits***

When participants leave the Company, upon retirement or for any other reason, those participants (or their beneficiaries) may receive the vested value of their account in a single lump-sum payment. The Plan also allows for in-service withdrawals upon a participant attaining the age of 59½, for an emergency, birth or adoption, federally declared disaster, or for a hardship. In addition, the Plan allows for withdrawals of any rollover contributions at any time.

***Payments of Benefits***, continued

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. Mandatory distributions of account balances under \$7,000 will be made as soon as possible. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan's administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan's administrator.

***Investment Options***

Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of mutual funds, a brokerage link account, and a money market fund offered by the Plan. Participants may change their investment options at any time.

***Forfeitures***

Forfeitures that occur during a Plan year will be used to pay expenses related to the administration of the Plan and to reduce future Company discretionary contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$859,637 and \$935,110, respectively. For the year ended December 31, 2024, forfeited funds of \$804,830 were used to reduce Company contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension & Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3, *Fair Value Measurements*, for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and benefits paid to participants, are charged directly to the participant's account, and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Information Certified by the Trustee***

Fidelity Management Trust Company prepared and certified as complete and accurate the Plan's schedule of investment assets, notes receivable from participants, transactions, and net realized and unrealized gains and losses on investments, and interest and dividend income, which was used to prepare the accompanying financial statements and supplemental schedule.

**3. Fair Value Measurements**

Accounting standards for fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash and cash equivalents*: Valued based on redemption values on the last business day of the Plan year.

*Mutual funds and exchange-traded funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stock, preferred stock, and options*: Valued at the closing price reported on the active market on which the individual securities are traded.

*Government bonds*: Valued at the price reported on the market on which the individual securities are traded.

*Self-directed brokerage accounts*: Primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices, using their respective published rates on the open market and are deemed to be activity traded.

**5. Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments in mutual funds are managed by Fidelity Management Trust Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**6. Tax Status**

The Plan uses a non-standardized pre-approved plan document sponsored by FMR, LLC. FMR, LLC received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the non-standardized pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

**7. Plan Termination**

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distributions will be made to participants as described in the Plan agreement, and participants would become 100% vested in their Company contributions.

**8. Risks and Uncertainties**

The Plan provides for various investment options in any combination of mutual funds, a money market fund, and self-directed brokerage accounts offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**10. Subsequent Events**

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through June 9, 2025, the date which these financial statements were available to be issued.

Effective January 1, 2025, the Plan increased the catch-up limit to \$10,000 for employees aged 60-63. The SECURE 2.0 Act of 2022 allows the Plan to make this change and operate in good faith prior to an actual Plan amendment.

Effective March 19, 2025, the Plan's Pension & Investment Committee approved the addition of auto enrollment and auto escalation for new employees beginning August 1, 2025.

In April 2025, the Company changed its name to American Automobile Association of Northern California, Nevada & Utah dba AAA Mountain West Group.

Effective May 6, 2025, the Company approved the addition of auto portability to the Plan's provisions whereby a terminated participant's account balance of less than \$7,000 can be transferred to an active account at a new employer's plan.

Management concluded that no other material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in these financial statements.
