### **Independent Auditor's Report**

To the Board of Trustees of the International Brotherhood of Electrical Workers Local #141 Vacation Plan:

#### **Opinion**

We have audited the financial statements of the International Brotherhood of Electrical Workers Local #141 Vacation Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### **Responsibilities of Management for the Financial Statements**

**1. Description of the Plan**

The following description of the International Brotherhood of Electrical Workers Local #141 Vacation Plan (the Plan) provides only general information. Users of these financial statements should refer to the Plan document for a more complete description of the Plan's provisions.

*General*

The Plan, which became effective December 13, 1994, is open to any person who has completed an hour of service for an employer who is subject to the terms of the Collective Bargaining Agreement (the Agreement) between the Wheeling Division of the West Virginia – Ohio Valley Chapter of the National Electrical Contractors Association (Association), and Local Union #141 International Brotherhood of Electrical Workers (the Union), for work performed on and after January 1, 1995. The Plan is subject to provisions of the Employee Retirement Income Security Act (ERISA).

*Contributions*

The Agreement provides, among other things, for employees of Union contractors to contribute to the Plan \$7.00 per hour paid through May 2023. Effective June 1, 2023, the contribution rate increased to \$7.25 per hour. Effective June 1, 2024, the contribution rate increased to \$8.00 per hour.

*Funding Policy*

The Plan's funding policy is that a specified dollar amount is deposited into the Plan for each hour paid. According to the Agreement, contributions must be funded no later than the 15<sup>th</sup> day of the month following the date when the wages are paid. Contributions postmarked later than such date (or if not postmarked, or not received by the 20<sup>th</sup> of such month) shall be subject to the Plan's delinquency provisions.

*Vesting*

Participants are immediately fully vested in the balances in their accounts.

*Payment of Benefits*

All contributions are transferred to individual participant savings accounts at a bank in the same month in which they are received, which is the month following when the hours are worked. The Plan does not maintain individual participant accounts.

*Plan Expenses*

The administrative expenses of the Plan are paid from the proceeds of an administration fee. The administrative fee is determined by the Plan trustees and reviewed and adjusted from time to time as necessary. The fee in effect for 2024 and 2023 is \$100 per participant, and is charged annually. In 2025, the fee has been increased to \$125 per participant.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting. Contributions are recorded by the Plan in the period the wages are earned. Benefits are recorded when paid.

### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## **3. Plan Termination**

The Trustees intend to continue the Plan indefinitely, but reserve the right to discontinue the Plan at any time, provided it will not be undertaken in such a manner as to constitute a violation of any applicable provision of ERISA. In the event of the termination or partial termination of the Plan or the complete discontinuance of contributions, all amounts received on behalf of participants shall immediately become distributable, until such funds are completely exhausted. In no event shall any of the Plan's funds revert to any participating employer.

## **4. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated September 3, 1997, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter.

The IRS has since changed its determination process to only issue determination letters for new or terminated plans. Therefore, the letter received September 3, 1997 will be the letter in effect going forward.

The plan administrator and the Plan's legal counsel believe that the Plan is currently designed and operating in compliance with the applicable provisions of the IRC. Therefore, no provision for federal income tax is reflected in the financial statements.

## **5. Parties – In – Interest**

Parties-in-interest are defined by IRC Section 4975(e)(2) and ERISA Section 3(14)(c) to include any entity that provides services to the Plan and employers whose employees are covered by the Plan. Therefore, the following general parties-in-interest relationships exist:

- All disbursements included in the accompanying financial statements
- All contributions received by the Plan

No other specific parties-in-interest transactions have been identified.

**6. Concentration of Credit Risk**

Funds in either interest bearing or non-interest bearing accounts are eligible for Federal Deposit Insurance Corporation (FDIC) insurance up to a legal maximum of \$250,000. As of both December 31, 2024 and 2023, the Plan did not have accounts in excess of the FDIC insured limit.

**7. Concentration of Revenue Risk**

The Plan receives substantial amounts of its contribution revenue from a limited number of employers. These contractors all work within a specific geographical area. A significant decline in the availability of work in this specific area could have an adverse effect on the Plan. For years ended December 31, 2024 and 2023, the Plan's largest four employers accounted for approximately 85% and 82% of the Plan's contribution revenue, respectively.

**8. Classification Differences**

Forms 5500 and 990 include certain assets and liabilities that differ from amounts shown on the accompanying financial statements. These differences relate to classifications only and have no effect upon net assets available for benefits for the years ended December 31, 2024 and 2023.

**9. Subsequent Event**

Management has evaluated subsequent events through the date that the financial statements were issued, June 12, 2025, and determined that no events occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in the financial statements.
