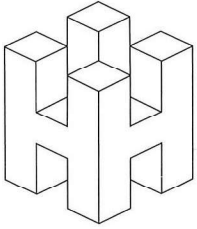

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KLINGER COMPANIES, L.L.C. 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Klinger Companies, L.L.C. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - DESCRIPTION OF PLAN

The following description of Klinger Companies, L.L.C. 401(k) Plan provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a multiple-employer 401(k) plan covering all non-union full-time and part-time employees of the companies who are age eighteen or older. The employers of the Plan are Klinger Holding Company, Inc., Klinger Companies, L.L.C., Gleeson Constructors & Engineers, L.L.C., Klinger Constructors, LLC, W. A. Klinger, L.L.C., Younglove Construction, L.L.C., Klinger Properties, Inc., and Blue Sky Pilot Services, L.L.C. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of all contributions into various investment options offered by the Plan. The Employers match 50% of the first 8% of salary deferred by the participant. Additional discretionary amounts may be contributed at the option of the Employers' management. The Employers made an additional discretionary contribution for 2024 and 2023 of 4% bringing the total Employers' match to 8% to participants who deferred at least 8% of eligible compensation.

Participant Accounts - Each participant's account is credited with the participant's contributions, the employers' contributions, and an allocation of Plan earnings and participant forfeitures, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus any actual earnings accrued thereon. Vesting in the employers' contribution portion of their account is based on years of service. A participant is 100% vested after three years of service.

Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant will become fully vested automatically. A participant with a vested balance of \$7,000 or less will automatically receive a lump sum distribution from the Plan. A participant with a vested balance greater than \$7,000 may elect to receive a distribution in any form allowed by the Plan.

Recent Legislative Update - On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms introduced with the 2019 SECURE Act, focusing on increasing participation in the retirement system and facilitating the accumulation of more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows accounting standards set by the Financial Accounting Standards Board, commonly referred to as the FASB. The FASB sets generally accepted accounting principles (GAAP) that the Plan follows to ensure the Plan consistently reports its net assets and changes in net assets available for benefits. References to GAAP issued by the FASB in these footnotes are to the FASB *Accounting Standards Codification*, sometimes referred to as the Codification or ASC.

The following are the significant accounting policies followed by the Plan.

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Net appreciation in the fair value of investments is based on the fair value of investments at the beginning of the year, or cost, if purchased during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(Cont.) Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Voluntary Withdrawals - Participants may apply for a hardship withdrawal for reasons stipulated in the Plan document. While an employee is employed by one of the Employers, the amount of elective deferrals and vested employers' matching contributions may be withdrawn with written consent from the Plan Administrator.

Payment of Benefits - Benefit payments are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Employers and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 - INVESTMENTS (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Principal Trust Company, the trustee of the Plan, that all of the information is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Fair Value Measurements - FASB Accounting Standards Codification 820 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and establishes a hierarchy that categorizes and prioritizes the factors to be used to estimate fair value. The three levels of factors used are as follows:

- * Level 1 - Quoted prices in active markets for identical assets or liabilities.
- * Level 2 - Factors other than Level 1 that are observable, either directly or indirectly, such as outside comparable sales.
- * Level 3 - Unobservable factors that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual Funds:

Valued at the daily closing price as reported by the fund.

Collective Investment Trusts:

Net asset value of the Collective Investment Trusts is measured using quoted prices of underlying assets of the trust. Net asset value for all trusts is available to current investors on the Plan website and is deemed to have a readily determinable fair value and value similar to mutual funds.

Pooled Separate Accounts:

Net asset value of the Pooled Separate Accounts is measured using quoted prices of underlying assets of the fund. Net asset value for all trusts is available to current investors on the Plan website and is deemed to have a readily determinable fair value.

Stable Value Collective Investment Trusts:

Net asset value of the Stable Value Collective Investment Trusts is based on contract value for which a portion of the net assets is attributable to fully benefit-responsive investment contracts. Net asset value for all trusts is available to current investors on the Plan website and is deemed to have a readily determinable fair value and value similar to mutual funds.

Note 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 5 - TRANSACTIONS WITH PARTIES IN INTEREST

The Plan pays several vendors for recordkeeping, administrative services, claims processing, custodianship of its investments, benefit consulting services, legal services, and audit services. Transactions with the providers of these services would be considered to be transactions with parties in interest. Furthermore, the Plan receives contributions from the participants' employers and these contributions would also constitute transactions with parties in interest.

Note 6 - FEDERAL INCOME TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Administrator has concluded that any uncertain tax positions would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded in the statement of changes in net assets available for benefits or accrued in the statement of net assets available for benefits.
