Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 1st Electric 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 1st Electric 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the 1st Electric 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees, except collective bargaining, non-resident alien and leased employees, of 1st Electric Contractors, Inc. (the "Employer") who are age 18 and have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participation in the Plan begins on the first day of the quarter coinciding with or following the date the eligibility requirement is met. The trustees are responsible for oversight of the Plan. The Plan's trustees monitor the appropriateness of the Plan's investment offerings and investment performance.

The Plan's custodian, The Standard Insurance Company, was responsible for the custody, administration and management of the Plan's assets as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The U.S. Congress enacted the SECURE Act which includes provisions that impact benefit plans. Provisions of the SECURE Act are operationally available at this time but Plan documents will not require formal amendment until 2025. SECURE increased the RMD age from 70 ½ to 73, allows for long-term part-time employees to participate and allows for in service withdrawals for childbirth and adoption expense. The Plan is not currently operating according to these provisions and the Plan will be formally amended before the required 2025 deadline.

Participant Contributions. Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan. Participants may designate their contributions as either pre-tax or Roth deferrals. Participants, who have attained the age of 50 prior to the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions, as well as the Sponsor's contributions, into various investment options offered by the Plan.

The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 1% of eligible compensation and an annual increase of 1% that is ultimately capped at 4% unless the participant made an affirmative election otherwise.

Employer Contributions. The Employer contributes a safe-harbor match contribution up to 4% of each participant's eligible compensation. For the year ended December 31, 2024 and 2023, the Employer contributed \$274,978 and \$245,101 respectively. In addition, the employer may make discretionary additional matching contributions of up to 6% of a participant's eligible compensation. The Employer did not make any additional matching contributions for the year ended December 31, 2024 and 2023. In addition, the Employer may also make a discretionary non-elective profit sharing contribution. To be eligible for the discretionary profit sharing contribution, participants must be age 21, must be employed on the last day of the Plan year and must meet the age requirement prior to the first or seventh month of the Plan year. For the year ended December 31, 2024 and 2023, the Employer contributed a \$10,000 and \$10,000, respectively profit-sharing contribution.

Vesting. Participants are immediately vested in their contributions and Employer safe harbor contributions, including earnings thereon. All Employer's discretionary matching and profit sharing

contributions, including earnings thereon, become vested upon death, disability or attaining age 65 or according to the following schedule:

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits. Participants who terminate employment with the Employer prior to retirement receive a distribution of their account balance in the event their vested account balance is less than \$5,000. In the event their vested account balance is greater than \$5,000, the participants can elect to receive their distribution, to roll over the distribution, or to retain their account balance with the plan. Participants may request an in-service distribution once attaining age 59 ½ or for hardship as defined by the Plan.

Participants who retire or participants' beneficiaries, in the event of death, have several options available under which they may receive benefits. Such benefits include receiving payment in a lump sum or selecting from various periodic payment options which are available to the participant and/or the participant's beneficiary as more fully described in the Plan documents.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment contracts held by a defined contribution plan are required to be reported at contract value. The Statement of Net Assets Available for Benefits presents the contract value of the fully-benefit responsive investment contracts.

Estimates. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments in registered investment companies are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in guaranteed investment contracts are stated at contract value as described in Note 5. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Employer. No such officer or employee receives compensation from the Plan. Certain transaction based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Standard Insurance Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB 820 are described as follows:

Level 1— Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: These accounts invest primarily in domestic stocks where a majority of the securities have observable Level 1 quoted pricing inputs. The NAV of the pooled separate accounts are not publicly quoted but are available to current investors. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. Therefore, the investments are deemed to have a “readily determinable fair value.” The NAV is calculated in a manner consistent with GAAP for investment companies and valued similarly to mutual funds. Pooled separate accounts can typically be redeemed on a daily basis.

The preceding method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5– GUARANTEED INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract with Standard Insurance Company who maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments (principally longer term fixed-income securities) and charged for Plan withdrawals and transaction fees charged by the custodian. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. The crediting rate for the year ended December 31, 2024 was 2.66%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The custodian may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time.

NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the plan administrator and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain registered investment company funds may make revenue sharing payments to the Standard Insurance Company which collects the funds for the benefit of the plan. The revenue sharing payments may reduce the plan expenses or be allocated among participants.

NOTE 7 - TAX STATUS

The Internal Revenue Service approved a master proto-type plan by a letter dated June 30, 2020, under which the Plan operates, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9 – CONCENTRATIONS OF CREDIT RISK/RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balance and amounts reported in the accompanying statement of net assets available for benefits.
