## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Rocket Lawyer 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

Rocket Lawyer Incorporated (the Company) established the Rocket Lawyer 401(k) Plan (the Plan), effective January 1, 2010, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The following description of the Plan provides only general information. Plan participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan Administrator. The Plan is administered by a Plan Committee, which consists of Company employees. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower) serve as the Plan's record keeper and trustee, respectively. Empower holds, invests and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Company has engaged LPL Financial LLC dba Sequoia Benefits (Sequoia) as an investment advisor. Sequoia assists the Plan's Retirement Committee in selecting investment options offered under the Plan and monitoring investment performance.

#### *Eligible Participants:*

Eligible employees, as defined by the Plan agreement, age 18 or older, may participate in the Plan after completing one month of service.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferral and Roth after-tax contributions up to 100% of their annual compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

Company employees are eligible for matching contributions after 12 months of service. The Company made matching contributions of \$433,478 to the Plan in 2024, which represents 100% of a participant's deferral, up to the greater of a maximum of 4% of eligible gross annual compensation or \$4,000.

#### *Contributions:* (continued)

The Plan sponsor makes an annual true-up so the aggregate matching contributions made during any Plan year to reflect an amount equal to the matching contributions had they been computed based on participant year-to-date eligible compensation contributed to the Plan. As of December 31, 2024, a true-up matching contribution of \$38,730 was due, which was funded in March 2025.

The Company may also make discretionary non-elective contributions, as determined by the Company's Board of Directors. The Company has not made any non-elective contributions through December 31, 2024.

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts are credited with the participant contributions, Company matching contributions, discretionary non-elective contributions (if any), rollovers, and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are immediately fully vested in their contributions, plus actual earnings (less any losses) thereon. Vesting in Company contributions is based on years of service. Participants fully vest in Company matching contributions after two years of service and non-elective contributions at the rate of 20% after two years of service, then 20% annually thereafter with full vesting occurring after six years or upon retirement, disability, or death.

#### *Forfeitures:*

The non-vested portion of terminated participant account balances is forfeited upon distribution of the vested account balances. Forfeitures are retained in the Plan and may be used to reduce Company contributions or pay Plan administrative expenses. The Plan had forfeitures of \$208 as of December 31, 2024 (\$36,752 as of December 31, 2023). Forfeitures of \$53,271 were used to offset Company matching contributions in 2024.

#### 1. Description of Plan (continued)

##### *Notes Receivable from Participants:*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their account balance up to \$50,000 for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participants may only have one note outstanding at any time. Participant notes are evidenced by a written note, secured by the vested balance in the participant account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator under the Plan's note policy. Interest rates on notes outstanding as of December 31, 2024 range from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Note receivable transactions with participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

##### *Liability for Corrective Distributions:*

Liability for corrective distributions represents contributions made by certain participants in excess of the allowable limit that must be refunded for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2024 liability of \$58,953 was refunded in 2025.

##### *Payment of Benefits:*

On termination of service for any reason participants may elect to receive a lump-sum cash distribution equal to the value of their account balance. The Plan may elect to distribute terminated participant account balances without participant consent if the balance is \$5,000 or less. Account balances greater than \$1,000 distributed to a participant before normal retirement age, as defined by the Plan agreement, will be automatically rolled into individual retirement accounts on behalf of the participants without participant consent. Benefits are recorded when paid.

#### *Plan Expenses:*

All of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain account maintenance and note fees are paid by the Plan and charged to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in these financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions to the Plan or to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

Investments consist of mutual funds, a money market fund, pooled separate accounts and a common/collective trust. These investments are accounted for as follows:

*Mutual Funds and Money Market Fund:* These funds are reported at fair value, which is the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

*Pooled Separate Accounts:* The investment in the pooled separate accounts are expressed in units. The value of the separate accounts is recorded at the close of each business day at fair value, as determined by the issuer based on the fair value of the underlying investment held by the separate account. The unit value is calculated by dividing the value of the entire account by the total number of units in the account. The value of the separate account on any date is determined by multiplying the number of units held by the unit value.

*Common/Collective Trust (CCT):* The Cohen & Steers Global Realty Shares Class P is a CCT that is composed primarily of common stocks and other equity securities issued by real estate companies, including REITs. Units held in the CCT are valued using the NAV practical expedient of the CCT, as valued by the issuer. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCT and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

##### *Fair Value Measurement: (continued)*

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

##### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold or held during the year.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment and notes receivable information presented on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

As of December 31, 2023, all Plan investments are classified as Level I within the fair value hierarchy.

5. Income Tax Status

The Plan is a pre-approved plan. The Internal Revenue Service (IRS) has determined, by a letter dated June 30, 2020, that the plan submitted for review was qualified under applicable provisions of the Code. The Plan has been amended since receipt of the letter. However, the Plan and the Plan sponsor believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
