Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Blue Ocean Tech LLC (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

YEAR ENDED DECEMBER 31, 2024

DESCRIPTION OF THE PLAN

The following description of the Blue Ocean Tech LLC (the Plan) provides only general information. Participants should refer to the Adoption Agreement for a more complete description of the Plan.

General

The Plan was established January 1, 2021 as a 401(k) plan. The Plan was amended by the Plan Sponsor on March 30, 2022 for legislative and regulatory changes. The purpose of the Plan is to provide retirement benefits to the employees of Blue Ocean Inc. (the Employer) and the employees of Logistics Plus Inc., a wholly-owned subsidiary of Blue Ocean Inc. The Employer serves as Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees become eligible to participate in the Plan after completing six months of service with no minimum hours requirements and reaching the age of twenty-one. Entry dates are the first of every month following the employee's completion of eligibility requirements. Participants must be employed as of the last day of the Plan year to be eligible to receive any employer paid profit sharing contributions.

Vesting

Participants are vested immediately in their contributions and the Employer's contribution portion of their accounts plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer safe harbor matching contributions, as well as allocations of the Employer's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may invest in any of the investment options offered by the Plan. All employee and employer contributions are participant-directed.

Contributions

Employee contributions - Each year, employees may contribute between 1% and 90% of pretax annual compensation, as defined in the Plan. Employees may also elect to make Roth contributions utilizing after-tax contributions. Employees who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled employees have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the employee, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 10%.

Employer safe harbor matching contributions - The Employer matches 100% of employee contributions, up to 4% of eligible compensation deferred to the Plan each pay period.

Contributions (Continued)

Employer profit sharing contributions - The Employer may elect to make discretionary profit sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Notes Receivable from Participants

Participants may borrow against their vested balance. The minimum loan is \$500 and the maximum is the lesser of 50% of the vested interest in the participant's account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. The loan is treated as a segregated investment of the participant and interest earned on the loan is allocated to the participant. Loan terms generally range up to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the participant's vested account balances and other assets of the participant, if necessary. The loans bear interest at the prime rate plus 2%. The interest rate on outstanding loans ranges from 7.50 to 10.50%. Principal and interest is paid through bi-weekly payroll deductions.

Payment of Benefits

A distribution can be made to a participant upon death, disability, retirement, or termination of employment. A participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump sum amount, or in annual installments, as defined by the Plan. A participant may defer receipt of distribution until a later date unless their vested account balance is \$5,000 or less, in which case the Plan Administrator will direct the trustee to distribute it as a lump sum without the participant's consent. A distribution will also be made if the participant is required by law to receive minimum required distributions. Participant consent is required for distributions of vested account balances which exceed \$5,000.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. The Plan's trustee, Reliance Trust Company, certifies the fair market value of all investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the Fair Value Measurements Note for further discussion.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions.

Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

FAIR VALUE MEASUREMENTS

The Plan follows Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic *Fair Value Measurement*. The Topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trust: units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. The Plan invests in the Invesco Stable Asset Fund and may redeem units in the CT daily. There are no redemption restrictions or notice periods for the Invesco Stable Asset Fund.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

PLAN TERMINATION

Although it has not expressed intent to do so, the Employer has the right under the Plan to suspend contributions, discontinue contributions or terminate the Plan at any time. In the event of Plan termination, all Employer contributions and forfeitures allocated to individual participants shall become fully vested. Assets are to be used first to satisfy all Plan liabilities. The remaining assets are to be allocated proportionately to participants based upon the relationship of each individual's account balance to the sum of all account balances.

INCOME TAX STATUS

The Plan document is a non-standardized pre-approved profit sharing plan that received its latest opinion letter from the Internal Revenue Service (IRS) on October 6, 2020, in which the IRS stated that the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving its latest opinion letter. However, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan Administrator has also considered FASB ASC Topic *Income Taxes* and believes the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The tax years that remain open for examination by the appropriate taxing authorities for the Plan as of December 31, 2024, are 2023, 2022 and 2021, generally three years from the date the return was filed.

PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Notes receivable from participants also qualify as exempt party-in-interest transactions.

Certain professional fees for the administration of the Plan were paid by the Employer on behalf of the Plan in the amount of \$37,630 for the year ended December 31, 2024.

During the year ended December 31, 2024, fees of \$14,446 were paid by Plan participants to the trustee, which represent exempt party-in-interest transactions.

SUBSEQUENT EVENTS

FASB ASC Topic *Subsequent Events* requires disclosure of the date through which subsequent events have been evaluated, as well as whether that date is the date the financial statements were issued or the date the financial statements were available to be issued. Subsequent events have been evaluated by the Plan Administrator through June 28, 2025, which is the date the financial statements were available to be issued.
