NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

1. THE PLAN

The following description of The United Group of Companies, Inc. Employee Savings Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, safe harbor, 401(k) plan covering substantially all employees of The United Group of Companies, Inc. (the Company) as defined below and became effective October 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by two individuals of the Company who also serve as the Plan trustees. Voya Retirement Insurance and Annuity Company (Voya) is the custodian of the Plan's assets, and Intac Actuarial Services, Inc. is the record-keeper for the Plan.

Eligibility

Each employee of The United Group of Companies is eligible to participate upon completion of one year of service and after they have attained the age of twenty-one. Newly eligible employees of the Company may begin participation in the Plan on the first day of the plan quarter immediately following the satisfaction of the eligibility requirement.

Contributions

Participants may make contributions up to the maximum percentage of compensation and dollar amounts permissible under the Internal Revenue Code. The Company makes a safe harbor matching contribution equal to 100% of the employee's salary deferral that does not exceed 3% of their compensation, plus 50% of the employee's salary deferral between 3% and 5% of their compensation. The Company may also make additional discretionary contributions. Participants are eligible to receive an additional discretionary employer contribution, if one is declared and made, upon the completion of 1,000 hours of service and if they are employed on the last day of the Plan year. The Plan has an automatic enrollment provision in which all newly eligible employees are automatically enrolled to contribute 3% of their salary into the Plan.

Participant Accounts

Each participant's account is credited with an allocation of (a) the employee's contributions, (b) the Company's contribution, (c) Plan earnings/(losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. Benefit payments are deducted directly from each participant's account.

Vesting

Participants are immediately vested in their voluntary contributions and employer matching and additional discretionary contributions plus actual earnings/losses thereon.

1. THE PLAN (Continued)

Notes Receivable from Participants

Under the terms of the Plan Agreement, participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may choose an amortization schedule of up to five years, unless the note is used for the purchase of a primary residence, in which case the amortization schedule may be a reasonable period equal with the period permitted by commercial lenders of similar loans. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through biweekly payroll deductions. Interest on notes receivable from participants range from 5.25% to 10.50%. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or delay receipt of benefits, if the vested account balance is greater than \$1,000.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59 ½. Participants may also withdraw any of their rollover contribution balance at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from elective deferral accounts. All hardship withdrawals must comply with specific rules relating to hardships, which are uniformly applicable to all participants.

Forfeiture Accounts

Forfeitures may be used to reduce employer contributions, or to pay any administrative expenses of the plan, if the employer elects not to pay such expenses directly. The remaining forfeitures, if any, shall be allocated to participant's accounts. As of September 30, 2024 and 2023, the balance of forfeited nonvested accounts available to be used to reduce future employer contributions was \$4,585 and \$1, respectively. For the years ended September 30, 2024 and 2023, employer contributions were reduced by \$0 and \$1,310, respectively, using forfeitures.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's interest in the pooled separate accounts is valued using the net asset value (NAV) practical expedient, based on the fair value of the underlying investments at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported net asset value. The underlying assets consist of a money market account, mutual funds, domestic and foreign equity securities, and fixed income securities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan's investment in the fully benefit-responsive guaranteed investment contract is reported at contract value as reported by Voya.

The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The majority of Plan administrative expenses are paid by the Plan. The primary administrative expenses incurred for 2024 and 2023 were investment advisory/management fees and professional fees.

3. FAIR VALUE MEASUREMENTS

Investments Measured using the Net Asset Value per Share Practical Expedient

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The pooled separate accounts are valued at their “accumulation unit value” (AUV). The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund’s dividends, and the separate account charges. The pooled separate accounts’ unit prices are not publicly available, and units are not publicly traded, therefore, the pooled separate account unit prices and the resulting valuation cannot be verified against quoted prices publicly available. As a result, fair value is measured using the net asset value per share practical expedient as of September 30, 2024 and 2023. There are no participant redemption restrictions for these investments.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at September 30, 2024 and 2023, was \$528,436 and \$1,468,431, respectively. The average yield and crediting interest rate was approximately 3.0% at both September 30, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3.0%. Such interest rates are reviewed twice per year for resetting. Also, there are no events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at an amount different than contract value.

6. TAX STATUS

The Plan is designed from a prototype plan offered by Ascensus, LLC. The Internal Revenue Service has determined and informed Ascensus, LLC, by letter dated June 30, 2020, that the written form of the underlying prototype plan document is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for its own determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. PARTY-IN-INTEREST TRANSACTIONS

Voya is the custodian of the Plan's assets. As such, transactions between the custodian and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through June 27, 2025, which is the date the financial statements were available to be issued.
