### 1. Description of plan

The following description of the GrayCo, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. The Plan document and adoption agreement should be referred to for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, sponsored by GrayCo, Inc. (the Company), subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective January 1, 1994, was amended January 1, 2008 and again on January 1, 2022. The plan covers all eligible employees of the Company and its affiliates who have attained the age of twenty-one. Employees become eligible after completing 90 days of service and can enroll on the subsequent January 1, April 1, July 1, or October 1 upon meeting the service requirement.

#### Contributions and funding

Each year, participants may contribute up to 100% of pretax annual compensation, up to the maximum limits per the Internal Revenue Service (IRS). Eligible compensation includes all compensation earned during the year, excluding non-taxable and taxable fringe benefits, compensation received or deferred under a non-qualified deferred compensation arrangement and certain incentive compensation. Participants may also contribute amounts representing rollover distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has elected to make a safe harbor non-elective contribution of 3% of the participant's eligible compensation regardless of whether the participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company.

The discretionary profit sharing contribution related to the plan year ending December 31, 2024 has been accrued in the amount of \$41,881 and is expected to be remitted in 2025. The discretionary profit sharing contribution related to the plan year ending December 31, 2023 was accrued in the amount of \$41,289 and was paid during the year ended December 31, 2024. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

#### Participant accounts

Each participant's account is credited with the participant's and Company's contributions as well as allocations of Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on participant investment results, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be derived from the participant's vested account.

#### Investment options

Upon enrollment in the Plan, a participant may direct the custodian to invest all account funds in specific assets, funds or other investments permitted under the Plan and the Participant Direction Procedures.

#### Vesting

Participants are 100% vested in contributions made through salary deferral, the Company's safe harbor contribution and rollover accounts, plus earnings thereon. Vesting in the Company's profit sharing contributions, if made, is based on years of continuous service. Participants are vested 20% after completion of two years of credited service and vest an additional 20% each year thereafter until fully vested at the completion of six years of credited service. Participants become 100% vested in all accounts upon death, disability, or retirement.

Accumulated forfeited balances on profit sharing contributions as of December 31, 2024 and 2023 totaled \$3,814 and \$2,540, respectively. These funds can be used to reduce future plan expenses or as employer contributions.

### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. Loan terms range from one to five years, or up to fifteen years if the loan qualifies as a home loan, and are secured by the participants' account and bear interest at the prime rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis with interest rates ranging from 4.25% - 9.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit is recorded.

### **Payment of benefits**

Upon termination, a participant may elect to receive either a lump-sum amount equal to the value of their vested interest or a direct rollover into another qualified plan or individual retirement account. Absent such elections by the participant, the plan administrator may transfer participant accounts with a value greater than \$1,000 but less than \$5,000 to a designated rollover IRA account. Accounts with \$1,000 or less may be paid directly to the participant less applicable tax withholdings. Hardship distributions are permitted upon demonstration of financial hardship. Benefits are recorded when paid.

### **Administrative expenses**

Most costs and expenses of administering the Plan are paid by the Plan Sponsor such as insurance, legal and audit fees. The Plan bears the costs of certain fees such as those paid to the investment managers from their respective funds and certain fees paid directly by the participants. Investment related expenses are allocated to participants based on the participant's investment balance and are included in net appreciation of investments.

## **2. Summary of significant accounting policies**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates and assumptions.

### **Investment valuation and income recognition**

The Plan's investments are stated at fair value and net asset value in the financial statements. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net asset value is based on the fair value of the underlying investments held by the fund less its liabilities as reported by the fund manager.

Security transactions are recorded on the settlement date, generally the third business day following the transaction date. This method does not result in significant differences from the trade date method. Investment results are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment results from mutual funds includes the Plan's gains and losses on investments bought, sold and held during the year.

### 3. Information prepared and certified by the custodian

The Plan Sponsor has elected the alternative method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the investment information certified by Empower Trust Company, LLC and the affiliated companies as of and for the years ended December 31, 2024 and 2023, were not audited by the independent auditors except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

The Plan's financial information that was certified by Empower Trust Company, LLC included investments of \$20,864,846 and loans of \$91,335 as of December 31, 2024 and investments of \$19,435,126 and loans of \$89,125 as of December 31, 2023.

Empower Trust Company, LLC also certified to the completeness and accuracy of \$3,255,695 and \$3,438,760 of investment results and \$6,311 and \$4,517 of interest income on notes receivable related to the aforementioned investments and loans for the years ended December 31, 2024 and 2023, respectively, as well as the schedule of assets (held at end of year) as of December 31, 2024.

### 4. Fair value measurement

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

Registered investment companies (mutual funds): Mutual funds are priced, and trades are executed at the published net asset value daily, or the public offering price for accounts trading under rights of accumulation (ROA). The net asset values used for valuation purposes are widely available.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investments at net asset value

Investments at net asset value consist of common/collective investment trusts (CIT) and one stable value fund. The common/collective investment trusts may invest in corporate bonds, US Treasury obligations, asset-based and mortgage-backed securities and at times may invest in loan participations and insurance contracts. The stable value fund may invest in money market instruments, bond funds and insurance company separate accounts. These investments are valued by determining the net asset value (NAV) which is the price at which the CIT can be redeemed as of the measurement date. There are restrictions on withdrawals from the fund. In certain cases, transfers and redemptions may be restricted for 90 days.

### 6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 7. Party-in-interest transactions

The Plan's assets are invested in funds managed by Empower Trust Company, LLC and affiliated companies. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan investments have internal expenses that compensate Empower Trust Company, LLC and affiliated companies.

### 8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Income tax status

The Plan was adopted under a prototype plan sponsored by Empower. The prototype plan has received an opinion letter dated June 30, 2020 from the IRS as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by the Plan.

The Plan Sponsor is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for years ended December 31, 2021 through 2024.
