## Independent Auditor's Report

The Participants and Investment Committee  
Des Moines University Defined Contribution 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Des Moines University Defined Contribution 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 3 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income (loss) and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

#### Note 1. Plan Description

The following description of the Des Moines University Defined Contribution 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General and eligibility:** The Plan, as restated January 1, 2020, is a defined contribution plan covering substantially all employees of Des Moines University Osteopathic Medical Center (University or Plan Sponsor) who work 20 hours or more per week and are not student employees, as well as former plan participants later rehired by the University. Employees may enter the Plan and are also eligible for University matching contributions upon their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

**Contributions:** Each year, participants may elect to contribute a portion of their eligible compensation, as defined by the Plan, subject to certain IRC limitations. Deferrals may be made using pre-tax, Roth or a combination of both. The University provides matching contributions based on the employee group the participant belongs to. The University matching contributions are limited as follows:

- Salaried/exempt employees: the lesser of 100% of deferrals (up to 10% of eligible earnings) or \$1,917 per month; and
- Hourly/nonexempt employees: the lesser of 100% of deferrals (up to 10% of eligible earnings) or \$885 per biweekly pay period.

Rollover contributions are also allowed by the Plan.

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the University's matching contributions and an allocation of Plan earnings, and is charged with withdrawals and fees applicable to early withdrawal, if any. Allocations are based on participant account balances or specific participant transactions, as defined in the Plan.

**Investment options:** Effective July 1, 2014, participants direct the investment of their contributions into various investment options offered by the Plan through Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. For the period January 1, 2009 through June 30, 2014, contributions could be directed into various investment options offered by the Plan through Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF). Prior to January 1, 2009, contributions could also be directed into various investment options offered by the Plan through Equitable Financial Life Insurance Company (Equitable Financial Life Insurance Company). The amounts contributed are currently deposited into one or more of approximately 30 investment options offered by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

**Vesting:** Participants are immediately vested in their contributions and University matching contributions plus actual earnings thereon.

**Payment of benefits:** Upon a participant's termination from the Plan, the participant may elect to receive either a lump sum payment equal to the vested value of his or her account or installment payments over various periods as elected by the participant. Participants may also request hardship or in-service withdrawals.

#### Note 2. Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary and Investment Committee determines the Plan's valuation policies, utilizing information provided by the issuer and/or custodians of the Plan. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the University. No such officer or employee receives compensation from the Plan. Certain other administrative expenses of the Plan, including third party administrator fees and audit fees, are paid by the Plan Sponsor.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through June 30, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Excluded Investments

The Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's (DOL) Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. Investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. The total amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

The Plan has been drafted to satisfy the requirements under the IRC as they pertain to 403(b) Plans. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

#### **Note 6. Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8. Fair Value Measurements**

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual funds:** Mutual funds are reported at the daily closing price as reported by each fund, based on daily net asset value, and are classified within Level 1 of the valuation hierarchy.

**Variable annuity contracts:** Invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives and are valued at the net asset value (NAV) of units held by the Plan in each account at year end. The NAV is used as a practical expedient to determine fair value for non-CREF variable annuity contracts. Non-CREF investments measured at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy. The CREF variable annuity contract funds are valued at the daily unit value published on NASDAQ. The fund is not traded on this exchange. The value of the unit holder's investment increases and decreases with the returns on the underlying assets in the fund.

**Pooled separate accounts:** Daily unit values are published on NASDAQ. The fund is not traded on this exchange. The value of the unit holder's investment increases and decreases with the return on the underlying assets in the account.

**Fixed annuity contracts, nonbenefit-responsive:** This account represents allocated fixed-rate annuity contracts with TIAA and CREF. Contributions to the annuity purchase a contractual or guaranteed amount of future benefits for the participant. Fixed annuity contracts that are nonbenefit-responsive are reported at contract value which approximates fair value. This determination is based on TIAA and CREF's credit rating and yield during 2024 and 2023 being comparable to similar alternative investments and the interest rate, which re-sets annually, being comparable to a 10-year treasury bond.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (e) This category seeks a favorable long-term rate of return that reflects the investment performance of the financial markets while giving special consideration to certain social criteria.

#### Note 9. Investment Contracts With Insurance Companies

The Plan has fixed annuity investment contracts with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, TIAA and CREF and Equitable Financial Life Insurance Company. Contributions made to the investment contracts are maintained in the general accounts of the respective insurance companies. The contracts are credited with earnings on the underlying investments and are charged for participant withdrawals and applicable withdrawal charges.

The Plan has certain investment contracts that are fully benefit-responsive and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract as contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. These contracts are included in the financial statements at contract value as reported to the Plan by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, TIAA and CREF and Equitable Financial Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their financial obligations may be affected by future economic and regulatory developments.

For the Principal Fixed Income Guaranteed Option Accounts, there are no reserves against the contract values for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with Principal Life, but generally may not be less than 1.55%, depending on the underlying contract. Such interest rates are reviewed for resetting on an annual basis, and more frequently, as appropriate.

For the TIAA and CREF Traditional Annuity, there are no reserves against the contract values for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with TIAA and CREF, but generally may not be less than 3%, depending on the underlying contract. Such interest rates are reviewed for resetting on an annual basis, and more frequently, as appropriate.

For the Equitable Financial Life Insurance Company Guaranteed Interest Accounts, the crediting interest rate is based on a formula agreed upon with Equitable Financial Life Insurance Company and varies based on the underlying contract type, contract series and state in which the contract is issued, but may not be less than a range of 2.25% to 3%. Such interest rates are reviewed for resetting on an annual basis, and more frequently, as appropriate.

Certain events limit the Plan's ability to transact at contract value with the issuers. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion or equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestiture or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (d) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA of 1974. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

#### **Note 10. Related-Party Transactions**

Certain Plan investments are managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, TIAA and CREF, and Equitable Financial Life Insurance Company. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, TIAA and CREF, and Equitable Financial Life Insurance Company are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **Note 11. Net Assets Available for Benefits**

In November 2007, the DOL issued amended regulations eliminating an exemption granted to 403(b) Plans from annual Form 5500 reporting, disclosure and audit requirements under Title I of ERISA. The removal of this exemption subjected the Plan to audit and expanded Form 5500 reporting requirements for the first time beginning with the Plan's year ended December 31, 2009. The Plan and TIAA and CREF have not maintained sufficiently detailed accounting records relating to the Plan's annuity and custodial accounts issued to current and former employees prior to January 1, 2008. Accordingly, the completeness of the Plan's net assets available for benefits as of December 31, 2024 and 2023, and changes in net assets available for benefits for the year ended December 31, 2024, could not be verified.
