INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying financial statements of Jensen Construction Company Group Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of cash receipts, disbursements and changes in net assets available for benefits (cash basis) as of and for the years ended September 30, 2024 and 2023, and the related notes to the financial statement.

Note 1 - Significant Accounting Policy

Basis of accounting: Jensen Construction Company Group Trust's (the Trust) accounts are maintained on a cash basis and the statement of cash receipts, disbursements and changes in net assets (cash basis) available for benefits reflect only cash received and disbursed. Therefore, receivables and payables, which may be material in amount, are not reflected in the accompanying financial statement.

Note 2 - Trust Description

The Trust provides self-insured medical (including prescriptions) and dental to participating employees of The Rasmussen Group, Inc., Central Iowa Trucking, Inc., Argee Transportation Co., Central Iowa Ready-Mix, Inc., RGI Materials, Inc., Circle V Specialized, Inc., Grimes Asphalt & Paving Corp., Concrete Supply Inc. TransCo Ready Mix, LLC and Jensen Crane Services, Inc., (the Companies). The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For a more complete description of the trust provisions, the participants should refer to the trust agreement.

Note 3 - Contributions, Funding Policy and Benefits

The Trust provides that the Companies and participating employees make contributions to the Trust sufficient to cover all participant claims and administrative service fees to an independent third party. For the years ended September 30, 2024 and 2023, the self-insured Trust received contributions from the Companies and participating employees sufficient to cover all participant claims. The amount contributed by the Companies was determined at the discretion of the individual board of directors. The Companies and participating employees paid monthly premiums and administrative service fees to the independent third party. For years ended September 30, 2024 and 2023, claims were processed and paid by an independent third party, but the responsibility for payments to participants and providers is retained by the Trust.

Note 4 - Eligibility

Permanent full-time employees become eligible for participation the first day of the month following 60 days of employment.

Note 5 - Income Tax Status

The IRS has issued a determination letter dated August 24, 1988, stating the Trust is qualified and exempt from income tax under Section 501(c)(9) of the Internal Revenue Code. The Trust has been amended since receiving the determination letter. However, the Trustee and the Trust's legal counsel believe that the Trust is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Trust was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effect of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to September 30, 2021.

Note 6 - Stop-Loss Recoveries

The self-insured Trust has obtained stop-loss insurance for varying exposures of specific and aggregate losses. Stop-loss recoveries netted with claims paid for the years ended September 30, 2024 and 2023 were approximately \$845,000 and \$1,266,000, respectively.

Note 7 - Benefit Obligations

Trust liabilities for health claims reported but not paid and incurred but not reported are estimated based upon prior claims experience. Those amounts, net of stop-loss recoveries, as of September 30, 2024 were approximately \$685,000. Actual results could differ from these estimates.

Note 8 - Trust Termination

Although it has not expressed any intent to do so, the Plan may be terminated by the trustees at any time, subject to the provisions set forth in ERISA.

Note 9 - Administration of Trust Assets

The Trust's assets are held by a trustee of the Trust. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Trust.

Note 10 - Estimates

The preparation of financial statements in conformity with cash receipts and disbursements principles requires the trust administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 11 - Party in Interest Transactions

Fees paid by the Trust for legal, accounting, and administration included in administrative expenses totaled \$0 for the year ended September 30, 2024.

Note 12 - Participating Companies

In February of 2024, the Sponsor of the Plan acquired Ideal Ready Mix Company, Inc. and L&W Quarries, Inc. Employees of both companies will be eligible to participate in the Plan on January 1, 2025.

Note 13 - Date of Management's Review

The Trust has evaluated all subsequent events through June 26, 2025, the date the financial statements were available to be issued.
