NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Retirement Plan for Employees of Cedar Chemical Corporation (the Plan) provides only general information. Participants should refer to the Summary Plan Description for more detailed and comprehensive information.

Plan Termination

Effective April 30, 2024, the Plan was terminated. All accrued benefits as of the termination date became non-forfeitable. Following the termination date, the Plan purchased individual annuities for all affected participants and their accrued benefit balances were transferred to these annuities.

General

Prior to termination, the Plan was a non-contributory defined benefit pension plan covering certain former employees of Cedar Chemical Corporation, a subsidiary of Trans Resources, LLC (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Effective October 1, 2022 the Plan was amended in its entirety and restated.

The Plan was administered by the Company.

Pension Benefits

Prior to termination of the Plan, certain former employees receiving benefits or were entitled to receive vested benefits, as described in the Plan documents. Those former employees became eligible to participate after they had attained the age of 21 or completed 1 year of service, whichever came first. No other person may become a participant in the Plan as the Plan was frozen as of December 31, 2001. After that date, no additional benefits accrued to any of the participants and participants became fully vested. The basic formula for the Plan was 1.82% of the final average compensation times credited service up to 25 years.

As all participants were vested in full, all were entitled to pension benefits upon retirement. Pension benefits were provided to participants under several types of retirement options based upon years of continuous service and age.

Prior to the termination of the Plan, participants may request and receive an actuarially reduced benefit prior to their normal retirement date following the attainment of age 55 and achieved 5 years of service. The normal retirement benefit was a joint annuity for a married participant and a life annuity for an unmarried participant. Options for survivors and other annuities were available. Benefits were usually paid on a monthly basis from Plan assets.

Normal Retirement

Prior to termination of the Plan, normal retirement age was the first day of the month coinciding with or following a participant's 62nd birthday. A participant's normal retirement benefit was based on predetermined amounts as described in the Plan documents. In lieu of the normal form and amount of monthly benefit specified, and subject to certain Plan provisions, a participant may elect a retirement income or deferred vested benefit of the actuarially equivalent value of (a) a smaller monthly benefit payable to the participant during the participant's lifetime and, if another person the participant had designated is living at the time of the participant's death, payment of 100 percent, 75 percent or 50 percent (as elected by the participant prior to commencement of benefits) of that amount to such other person for their lifetime, or (b) a smaller monthly payment payable to the participant during the participant's lifetime and if the participant dies within a period of 5, 10 or 15 years (as elected by the participant prior to the commencement of benefits) from the participant's annuity commencement date, a continuing monthly payment of the same amount to a person or persons designated by the participant for the balance of such elected period, provided, however, that if the participant designates someone other than the participant's spouse, the option shall be designed so that the lump sum actuarially equivalent value of the monthly benefit payable to the participant under the option over the participant's life expectancy shall be greater than 50 percent of the lump sum actuarially equivalent value of the monthly benefit that otherwise would be payable to the participant on a life annuity basis.

Early Retirement

Prior to termination of the Plan, upon the participant's election, the early retirement date was the first day of the month coinciding with or following the date on which a participant has both attained age 55 and achieved 5 years of service. The amount of a participant's monthly retirement income shall be actuarially reduced in accordance with the Plan documents to reflect the early commencement of benefits.

Death Benefits

Prior to termination of the Plan, for married participants, a surviving spouse would receive the qualified joint and survivor annuity, computed as if the participant had elected to commence receiving retirement income at the earliest date allowed under the Plan. No death benefits would be payable in the case of an unmarried participant who dies prior to such participant's retirement date.

Funding

Prior to termination of the Plan, no contributions would be required from any participant. The employer would pay to the Plan from time to time such contribution amounts necessary to provide the benefits under the Plan, determined by the application of accepted actuarial methods and assumptions. The methods of funding would be consistent with Plan objectives and the compliance requirements of ERISA. The contributions during 2024 and 2023 met the minimum funding requirement.

Records Maintenance

The Plan's records were in the custody of Trans Resources, LLC. Trans Resources, LLC performed the various administrative functions necessary for the operation of the Plan, including the processing of employer contributions and the payment of administrative expenses. Principal Life Insurance administered the retirement benefits.

Plan of Liquidation

Contributions into the Plan ceased on July 17, 2024. Participants were given an election to roll their account balance into an annuity contract administered by American United Life Insurance Company.

Adoption of the Liquidation Basis of Accounting

As a result of the termination described in Note 1, the Plan changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting. All Plan assets were fully distributed, therefore, there are no Plan assets at period end. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Concentration of Credit Risk

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consisted primarily of employer contribution receivable.

The Plan investments consisted of pooled separate accounts which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual security.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits were those future periodic payments, including lump-sum distributions that were attributable, under the Plan's provisions, to the services rendered by the participants through the valuation date. Accumulated plan benefits included benefits expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries. Benefits under the Plan were based on the participant's total credited services, which was the sum of (a) past service credits and (b) paid benefit credits. Benefits under all circumstances (retirement, death, disability and termination of employment) were included, to the extent that they were deemed attributable to participant service rendered to the valuation date.

As described in Note 1, upon termination of the Plan, individual annuity contracts were purchased for all affected participants. The total value of accrued benefits was approximately \$22,964,000. This purchase was presented as a transfer to American United Life Insurance Co. in the accompanying statement of changes in net assets available for benefits.

NOTE 3. INVESTMENTS, AT FAIR VALUE

Principal Life Insurance Company, the custodian, held the Plan's investments through termination of the Plan. The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of September 16, 2024 and December 31, 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the period ended September 16, 2024 and year ended December 31, 2023, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Period) as of September 16, 2024 and Form 5500 Schedule H, Line 4j - Schedule of Reportable Transactions.

The Plan's investments consisted of pooled separate accounts. During the period ended September 16, 2024 and year ended December 31, 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the period and year) (depreciated) appreciated in value by (\$143,872) and \$3,844,817, respectively (reported as net (depreciation) appreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits in liquidation).

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

- Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

➤ Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

➤ Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to measure fair value as of September 16, 2024 and December 31, 2023.

The following is a description of the valuation methods used for investments measured at fair value.

Pooled separate accounts: The fair value of the investments in the pooled separate accounts is determined by the fund custodian based on the fair value of the underlying securities within the fund, which represents the net asset value of the shares held by the Plan at year end.

As of September 16, 2024, all investments held by Principal Life Insurance Company had been liquidated.

NOTE 5. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Trans-Resources, LLC was the Plan's sponsor.

Additionally, certain Plan investments may have included shares of investments managed by Principal Life Insurance, the Plan's custodian and, therefore, these transactions qualified as party-in-interest transactions; however, they were exempt from the prohibited transactions rules under ERISA.

NOTE 6. ACCUMULATED PLAN BENEFITS

The actuarial present value of accumulated plan benefits is determined by an actuary from Principal Life Insurance, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The actuarial assumptions used to determine the actuarial present value of accumulated plan benefits are as follows:

Expenses

The expected expenses included in target normal cost was an estimate based on prior year expenses paid from Plan assets, with an updated estimate of PBGC premiums. This was the best estimate available of upcoming year's expenses at the time of valuation.

Asset Valuation Method

The actuarial value of assets was determined using a smoothing method which spread the asset gains/(losses) over 2 years. The gain/(loss) for each period was determined as the actual return during the period, less the expected return based on an assumed earnings rate chosen by the actuary but limited by PPA to the applicable third segment rate. The resulting value was restricted to a corridor of 90% to 110% of the fair market value. The discounted value of any receivable contributions was included in the actuarial value of assets. This was the same methodology that had been used in prior years.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions were made, and the actuarial present value of accumulated plan benefits were reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which were subject to change. Due to uncertainties inherent in the estimations and assumptions process, it was at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 9. TAX STATUS

The Plan was exempt from Federal income taxes under Internal Revenue Code (IRC) Section 501(a) and, therefore, no provision for Federal income taxes had been made.

In addition, the Plan was required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan was tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Board believes the Plan is no longer subject to such audits for tax periods prior to 2021.

NOTE 10. SUBSEQUENT EVENTS

The Employee Retirement Income Security Act (ERISA) requires that the Pension Benefit Guaranty Corporation (PBGC) perform a compliance audit on terminating plans. As of June 30, 2025 the PBGC compliance audit is ongoing and the Board is unable to determine the final outcome.

The Board has evaluated subsequent events for the Plan through June 30, 2025, the date the financial statements were available to be issued.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
