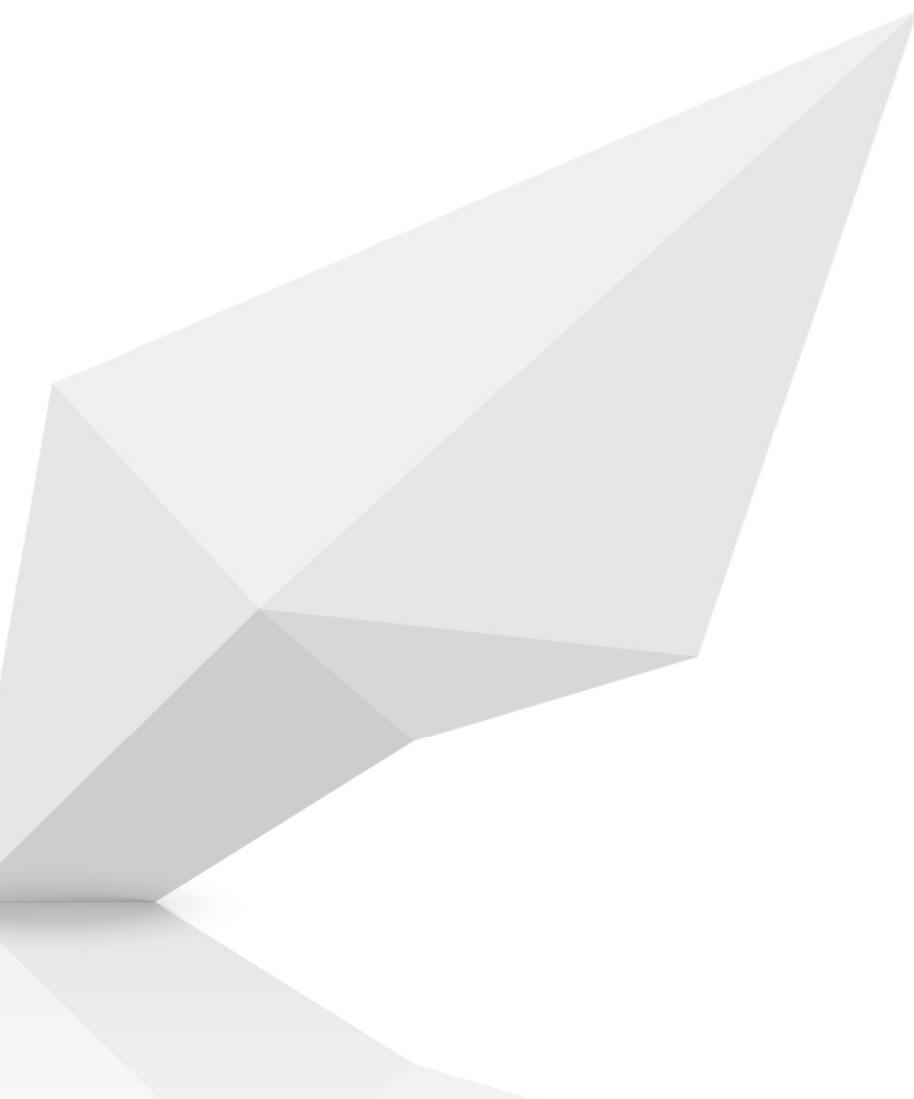

Note 1: Description of Plan

The following description of the Royal Management Corporation Lexington Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Royal Management Corporation and any affiliated employer who has adopted the Plan (collectively the "Company"). The following are affiliated employers who adopted the provisions of the Plan:

Effective July 5, 2022, the Company restated and amended a Volume Submitter Plan to be in accordance with the Internal Revenue Service (IRS) legislative requirements and maintain the Plan's qualified status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Note 1: Description of Plan (Continued)

Eligibility

Employees of the Company who have completed three months of service and are age 21 or older, except for union employees covered under a collective bargaining agreement and nonresident aliens, are eligible to participate in the Plan. Eligible employees may enter the Plan at the date of satisfaction of the eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their annual compensation on either a pretax or after tax (Roth) basis, as defined by the Plan, subject to maximum deferral limitations established by the IRS. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to participants who have completed one year of service during the plan year, equal to a uniform percentage of an eligible employee's salary deferrals, a percentage that is determined each year, not to exceed 3% of a participant's eligible compensation. The Plan also provides for the Company to make a discretionary profit-sharing contribution to eligible employees, as defined by the Plan, who are employed on the last day of the plan year. Allocation of the discretionary profit-sharing contribution, if any, to participant accounts will be based on a ratio of participant's compensation as a percentage of the total compensation for all eligible participants. During the year ended December 31, 2024, the Company did not elect to make any discretionary matching or profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, if any, and allocations of (a) the Company's profit-sharing contributions, if any, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the first year of service. Participants become fully vested after five years of service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a partial or a lump-sum distribution. If the value of the vested benefit is \$5,000 or less, a lump-sum distribution will be made. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42,581 and \$10,824, respectively. Forfeitures are used to reduce future Company contributions, pay administrative expenses of the Plan, or reallocate to active participants in accordance with the plan document. During the year ended December 31, 2024, administrative expenses of \$4,115 were paid from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through June 10, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the the Plan Sponsor amended its name to Royal Management Company LLC and the Plan was amended to change the Plan name from Royal Management Corporation Lexington Retirement Savings Plan to Royal Management Lexington Retirement Savings Plan.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market fund: Valued using \$1 as the net asset value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Fully Benefit-Responsive Investment Contracts

The Plan invests in a FBRIC with Transamerica Life Insurance Company ("Transamerica") in the form of a group annuity contract (GAC) that invests in a stable value fund. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed. The FBRIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but there is no minimum crediting rate. The average yield and crediting interest rate was 1.65% for the year ended December 31, 2024. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Transamerica including plan termination and other events as specified in the GAC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer were probable of occurring. The GAC does not permit Transamerica to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, Transamerica and Transamerica Trust Company ("TTC"), the custodians of the Plan. Reliance Trust Company and Transamerica, the custodians, held the Plan's investment assets as of December 31, 2023 and executed investment transactions from January 1, 2023 through June 28, 2024. Transamerica and TTC, the custodians, held the Plan's investment assets and executed transactions as of December 31, 2024 and for the period from June 29, 2024 through December 31, 2024.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Transamerica Retirement Solutions, LLC. Transamerica Retirement Solutions, LLC is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, certain expenses are charged to the Plan by service providers for investment advisory services. These transactions also qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the record-keeping services and investment advisory services were \$87,697 for the year ended December 31, 2024.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 8: Tax Status

The Company adopted a volume submitter defined contribution plan sponsored by Transamerica Retirement Solutions Corporation. The IRS has determined and informed the Company by a letter dated June 30, 2020, that the volume submitter plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
