### 1. Description of Plan

Effective January 1, 1996, the College Board (the "Board" or "Employer") adopted the College Entrance Examination Board Retirement Plan (the "Plan") under Section 401(a) of the Internal Revenue Code ("IRC"). The following brief description and summary of major plan provisions of the Plan provides only general information about the Plan. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General and Eligibility***

The Plan is a defined contribution plan covering all full-time employees of the Board who are at least 21 years of age with at least six months and part-time employees who are at least 21 years of age and have completed one year of service. Full-time and Part-time employees hired after April 1, 2016 are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Employer Contributions***

The Board contributes 13% of each participant's eligible compensation as defined in the Plan Document not to exceed the IRC annual limit. Contributions are subject to certain limitations as specified in the Plan document.

#### ***Participant Accounts***

Each participant's account is credited with Employer contributions and an allocation of Plan earnings (losses) thereon. Allocations of Plan earnings (losses) are based on each participant's account balances. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account. Each participant's account is charged with an allocation of administrative expenses.

#### ***Vesting***

Participants hired prior to January 1, 2009 are 100% vested in all Board contributions once they enter the Plan. Full-time and Part-time employees hired on or after January 1, 2009 are fully vested in Employer contributions on their anniversary date after working 1,000 hours in each of two twelve-month periods calculated from the date of hire.

#### ***Investment Options***

Participants have the option to direct contributions and the balance accumulated in their accounts among various investment options which include: College Retirement Equities Fund ("CREF") variable annuity accounts, Teachers Insurance and Annuity Association of America ("TIAA") and CREF registered investment companies, the TIAA Traditional Annuity Account, and a TIAA Real Estate Account, which is a pooled separate account.

**1. Description of Plan (*continued*)**

***Payment of Benefits***

Benefits are paid upon retirement, death, disability or termination of employment. Upon termination due to death, disability, retirement, after reaching age 59 ½ or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Participants may elect to receive benefits from several options available as set forth in the Plan document.

***Forfeitures***

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participant's account balances will be forfeited as of the termination date. The forfeited account can be restored in the participant's account if the participant is reemployed within the lesser of five years or the aggregate number of years credited to the participant for the period prior to his or her termination of employment date.

Any forfeitures not restored may be used by the Plan to reduce future Employer contributions by the Board or pay Plan expenses. At December 31, 2024 and 2023, forfeited account balances held in nonparticipant directed accounts were \$4. During 2024, no forfeitures were used to reduce Employer contributions.

***Revenue Credit Account***

The Plan and TIAA entered into a revenue sharing arrangement whereby a portion of the revenue earned by TIAA for certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay for Plan expenses, the Plan created a Revenue Credit Account. The Revenue Credit Account is an account within the Plan that is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The Revenue Credit Account balance was \$45,150 and \$731 as of December 31, 2024 and 2023. During 2024, \$69,236 was used to reduce Plan expenses and \$98,088 was allocated to participants from the Revenue Credit Account.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account is an unallocated contract. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value, which is derived from a discounted cash flow analysis and other factors, approximates fair value. The unallocated contract is stated at fair value. Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the plan at year end. The TIAA Real Estate Account is a pooled separate account that is valued at the net asset value of shares held by the Plan at year end, which is considered to be readily determinable, as determined by the issuer. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of the Plan are deducted from the value of the participants’ assets and certain expenses are paid by the Employer on behalf of the Plan. Expenses relating to investment management are paid directly by the respective investment vehicle and are included as a reduction to net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 23, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA - required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends in the statement of changes in net assets available for benefits for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

TIAA and CREF has been authorized by TIAA, FSB to certify the investments and investment information for which TIAA, FSB is the directed trustee. TIAA and CREF has been authorized by TIAA, FSB through July 14, 2023 to certify the investments and investment income information for which TIAA, FSB is the directed trustee and custodian. TIAA Trust, N.A. served as the directed trustee and custodian from July 15, 2023 through December 31, 2024.

***TIAA Traditional Annuity Account***

The TIAA Traditional Annuity Account is composed of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity, the Supplemental Retirement Annuity, and the Retirement Choice Plus contracts. The non-benefit responsive contracts are: the Group Retirement Annuity, the Retirement Annuity ("RA") and the Retirement Choice contracts. The Plan utilizes the RA contracts, which are reported at fair value. There were no contracts at contract value at December 31, 2024 and 2023. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: RA – 3.65%-6.50%.

Under the RA contract, lump-sum withdrawals are not allowed and all other withdrawals and transfers must be paid in ten annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

***TIAA Traditional Annuity Account (continued)***

The TIAA Traditional Annuity Account represents approximately 15% and 16% of the Plan's net assets available for benefits, as of December 31, 2024 and 2023, and represents an obligation from TIAA to repay as amounts come due. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 2024), Standard and Poor's (AA+ as of May 2024), A.M. Best Company (A++ as of July 2024), and Fitch Ratings (AAA as of August 2024).

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan subject to the provision of ERISA. In the event of a Plan termination, participant accounts will become 100% vested in their Employer contributions.

**6. Purchases of Annuity Contracts**

During the year ended December 31, 2024, the Plan purchased annuity contracts issued by TIAA and CREF in the amount of \$1,361,851 for terminated participants that selected annuity contracts as their distribution option. As a result, the entire distributed balance of the participants' account as well as all benefits, rights, and features associated, will be guaranteed by TIAA and CREF. The payment start date and frequency of the annuity was determined by the participant. The participant could choose between single life annuities and joint life annuities and the amount of the guaranteed annuity accumulation.

Purchased annuities are contracts under which TIAA and CREF are obligated to pay benefits to named employees or their beneficiaries. Funds of the Plan that were used to purchase the annuity contracts are recorded under deductions on the statement of changes in net assets available for benefits.

**7. Tax Status**

The Plan has received a favorable determination letter from the Internal Revenue Service ("IRS") dated October 7, 2020, stating that the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since receiving the determination letter, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Party-in-Interest Transactions**

Certain investments are managed by TIAA and CREF. TIAA is the record-keeper and a custodian and CREF is a custodian for the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Board may also be participants in the Plan or perform administrative services to the Plan at no cost to the Plan.

**9. Prohibited Transaction**

During the Plan year ended December 31, 2024, the Plan erroneously paid an expense of another plan, amounting to \$19,215, from Plan assets. This is a prohibited transaction and is reported as such on the supplemental Schedule G, Part III – Schedule of Nonexempt Transactions. In 2024, the Plan Sponsor corrected the prohibited transaction in accordance with the applicable guidance issued by the Department of Labor for this matter.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
