INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
Fareway Stores, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fareway Stores, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Fareway Stores, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, which became effective December 29, 1985, is a defined contribution plan established to provide retirement benefits for employees. Substantially all employees are eligible to become a participant on the first Plan entry date coinciding with or next following completion of three months of service and attainment of age 21. The Plan is administered by the Trustee Committee appointed by Fareway Stores, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Transamerica Retirement Solutions Corporation (Transamerica) is the recordkeeper of the Plan. State Street Bank and Trust Company (SSBT) is the Custodian of the Plan.

Contributions

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Each year, participants may contribute up to 50% of their annual compensation subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan automatically enrolls newly eligible employees at 6%, with a 1% automatic escalation annually (to a maximum of 10%), unless an alternate election is made. The Company matches 33.33% of the first 6% of compensation a participant contributes to the Plan. Additionally, profit sharing contributions may be made at the sole discretion of the Company's Board of Directors. No profit sharing contributions were made during the years ended December 31, 2024 or 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is increased or decreased by the participant's contributions, withdrawals and an allocation of Plan earnings (losses), net of administrative expenses and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined, in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their elective deferrals and earnings thereon. Vesting in the Company's contribution portions of a participant's account, plus earnings thereon, is based on years of continuous service according to the following schedule:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$239,000 and \$273,000, respectively. Forfeited profit sharing and matching balances will be used to reduce future employer contributions and Plan expenses. During the years ended December 31, 2024 and 2023, employer contributions and Plan expenses were reduced by approximately \$415,000 and \$356,000, respectively, from forfeited accounts.

Additionally, the Plan has no unallocated expense account balance as of December 31, 2024 and 2023.

Payment of Benefits

Participants who have separated from service are entitled to a lump-sum distribution of the value of their accounts beginning at normal retirement age or upon separation from employment. Normal retirement age is the earlier of (1) age 55 provided the participant has completed five years of service, or (2) the age at which the participant completes 20 years of service. Participants still employed by the Company may also receive a distribution of all or a portion of their account balance related to their contributions beginning at the age of 59½. Effective January 1, 2023, the Plan adopted an amendment to the Plan document to allow for in-service withdrawals by participants of any vested portions of any Company contributions beginning at the age of 59½. Prior to January 1, 2023, the Plan did not allow for in-service withdrawals of any Company contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's elective deferrals or rollover account balance. The loans are secured by the balance in the participant accounts and carry interest rates ranging from 4.25% to 10.50%, with terms ranging from 12 to 132 months and are due through October 2034. Certain outstanding loans as of December 31, 2024 are the result of the Plan Merger described in Note 7. These loans transferred in as a result of the Plan Merger and were allowed to continue based on their original terms, which may be different from the terms allowed for loans borrowed under the Plan. Principal and interest are paid ratably through payroll deductions. Loans are not allowed on any Company contributions.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments including mutual funds and investment contracts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. At December 31, 2024 and 2023, there were no amounts allocated to participants who had elected to withdraw from the Plan but were not paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments held as well as bought and sold during the year.

Administrative Expenses

The costs of administering the Plan are shared between the Plan participants and the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment-related expenses are included within net appreciation in fair value of investments. During the years ended December 31, 2024 and 2023, the Plan paid Transamerica approximately \$290,000 and \$182,000, respectively, for Plan administration. During the years ended December 31, 2024 and 2023, the Plan paid approximately \$244,000 and \$244,000, respectively, in investment advisory and investment management fees.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Money market and mutual funds:* Valued based on quoted prices of identical assets in active markets.
- *Collective investment trust:* The fair values of units held in the collective trust fund are valued based on quoted redemption values, also known as net asset values (NAV), determined by using available market information and appropriate valuation methods, as provided by the Custodian and represent the value at which the Plan (or the participant) could initiate a transaction with the Custodian.
- *Life insurance contracts:* Valued at the cash surrender value of the underlying insurance contract.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in methodologies used at December 31, 2024 and 2023.

The life insurance policies held by a separate insurance company were not certified as of and for the years ended December 31, 2024 and 2023. Therefore, the investments and related investment income are excluded from the above table and not subject to the exemption allowed for certified investments.

NOTE 5 — FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Transamerica. Transamerica received a letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 6 — EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by Transamerica or SSBT. Transamerica and SSBT are the recordkeeper and custodian of the Plan, respectively, and therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to Transamerica. These transactions are party-in-interest transactions under ERISA.

NOTE 7 — PLAN MERGER

During the year ended December 31, 2023, the Plan adopted an amendment to the Plan document to allow Webster City Custom Meats, Inc. 401(k) Salary Savings and Retirement Plan (WCCM Plan), a defined contribution plan of Webster City Custom Meats, Inc., a wholly-owned subsidiary of the Plan sponsor, to merge into the Plan. During the year ended December 31, 2024, participant account balances of \$4,352,832 were received by the Plan from the WCCM Plan.

NOTE 8 — SUBSEQUENT EVENTS

The Plan's management evaluated all subsequent events through July 1, 2025, the date the financial statements were available to be issued.
