Note 1 - Description of Plan

The following description of the Avion Solutions, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Avion Solutions, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

Eligibility

Participation in the Plan is available to all eligible employees of the Company. Eligible employees do not include employees covered by a collective bargaining agreement, nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, and reclassified independent contractors.

Contributions

Participant Salary Deferral - Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants are automatically enrolled to defer 6% of their compensation unless they choose a different percentage or elect not to defer. The automatic elective deferral contribution shall increase by 1% after each subsequent yearly date up to a maximum automatic elective deferral contribution of 10%. Participants 50 years old or older during the Plan year are eligible to make catch-up contributions, up to maximum amounts established by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer Discretionary Match - The Company may elect to make a discretionary match contribution based on eligible compensation. For the year ended December 31, 2024, the Company contributed to the Plan an amount equal to 100% of the participants' contributions that were not in excess of the first 3% of the participants' compensation. The Company made discretionary matching contributions in the amount of \$844,803 for the year ended December 31, 2024.

Employer Profit-Sharing - The employer may also elect to make a discretionary profit-sharing contribution based on eligible compensation. The Company made no discretionary profit-sharing contribution for the year ended December 31, 2024.

Employer Qualified Nonelective - The Company in its discretion may make additional qualified nonelective contributions for the benefit of all eligible participants who are not highly compensated employees, have completed 1,000 hours of service during the Plan year, and are employed by the Company on the last day of the Plan year. The company did not make any qualified nonelective contributions during 2024.

Investment Options

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offered mutual funds, pooled separate accounts, and a guaranteed investment account.

Investment Options - Continued

As of December 31, 2023, the plan also offered common investment trust funds which invest in various combinations of stocks, bonds, and other investment securities.

Vesting

Effective June 1, 2021, participants are vested immediately in their voluntary contributions and employer qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions portion of participants' accounts, plus actual earnings thereon, is immediate. Employees terminated prior to this effective date are subject to the previous vesting schedule.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the 12-month period ending on the day before the new loan is made or 50% of their vested account balance. The loans are secured by no more than 50% of the vested balance in the participant's account and bear a fixed interest rate of the prime rate plus 1%, which is commensurate with local prevailing rates as determined at the time of issuance by the Plan Administrator. A loan is considered in default if a scheduled payment is not made by the end of the cure period, defined as the repayment period allowed by the Plan Administrator which will not extend beyond the last day of the calendar quarter following the calendar quarter during which the last scheduled installment payment was due but not made. Principal and interest are paid ratably, not less frequently than quarterly, through payroll deductions. Loan terms may not be greater than five years unless the loan is used for purchase of primary residence. The maximum number of loans a participant may have outstanding at any time is two.

Payment of Benefits

Benefits commence upon one of several dates: retirement, disability, death, or termination of employment. Benefits are distributed by means of either direct rollover, lump sum distribution, or by one of various conventional annuity options.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1,578, respectively. These accounts will be used to reduce future employer contributions or plan expenses. The amount of forfeitures used to reduce employer contributions and plan expenses was \$48,413 for the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed income account is fully benefit-responsive and is reported at contract value. Contract value represents the accumulated contributions plus accrued net earnings less distributions. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Fees related to the administration of notes receivable from participants and payment of benefits to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Administrative Expenses - Continued

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan are allocated to the participant's account, in accordance with the Plan Document, and are included in administrative expenses.

Note 3 - Information Prepared and Certified by Principal

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company, Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively "Principal").

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, which was prepared by or derived from information provided by the Custodians and furnished to the Plan Administrator.

Principal Life Insurance Company also certified to the completeness and accuracy of \$4,996,182 of net appreciation in fair value of investments and \$1,190,806 of interest and dividends related to the aforementioned Plan assets for the year ended December 31, 2024.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies (Mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts (PSA): Valued at NAV based on the fair value of the underlying investments held in such separate account as determined by the Custodian using generally accepted accounting practices and applicable law. The majority of the underlying securities are mutual funds. The NAV of the PSAs are not publicly quoted but are available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSAs can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies.

Common investment trust funds (CIT): Valued at the NAV of units of a collective trust. The NAV, as provided by the Custodian, is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies.

Note 5 - Guaranteed Investment Contract with Insurance Company (Unaudited)

The Plan's investments include a benefit-responsive guaranteed contract with Principal Life Insurance Company. The Principal Fixed Income Guaranteed Option is a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company to Principal Trust Company as custodian. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has a surrender charge of 5% that may be charged if a plan terminates its interest in the contract. As of December 31, 2024, the Plan Sponsor has no intention to terminate the contract; therefore, contract value represents fair value.

The Principal Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. The guaranteed crediting rate is determined by calculating the weighted average of its underlying guaranteed interest funds; however, it may not be less than 1%. The crediting rate established in the contract is reset on a semiannual basis. There are no reserves against contract final value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, changes to the Plan's prohibition on competing investment options, deletion of equity wash provisions, and the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 - Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the Custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Plan Merger

Effective August 1, 2024, the Synectic Research and Analysis, Inc. 401(k) was merged into the Avion Solutions, Inc. 401(k) Plan. As a result of the merger, approximately \$22.4 million in plan assets were transferred into the Avion Solutions, Inc. 401(k) Plan. The merger was accounted for as a transfer of net assets, and the assets were recognized at fair value on the date of the transfer.

Note 11 - Risks and Uncertainties

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that

such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 12 - Transfer of Plan Assets

During 2024 the ESOP Plan distributed the accounts of all terminated employees as a rollover to the Plan. Assets totaling \$1,361,791 were transferred into the Company's 401(k) Retirement Plan during 2024 as a result of non-elective distributions.

During 2024, the Company permitted qualified participants in the Company's 401(k) Plan to make a balance transfer of Employer Match into the Company's Employee Stock Ownership Plan. Plan assets totaling \$465,889 were transferred into the ESOP Plan during 2024.

Note 13 - Subsequent Events

Plan Merger

During 2025, Avion Solutions, Inc. acquired Tennessee Valley Research Group, Inc. As a result of the acquisition, Tennessee Valley Research Group, Inc. 401(k) Plan was merged into Avion Solutions Inc. 401(k) Plan, effective June 9, 2025.

Date of Management's Review

Management has evaluated subsequent events through June 24, 2025, the date which the financial statements were available to be issued.
