The rates have changed since the prior year. In the prior year, the segment rates were:

4.75%, 5.00%, and 5.74% for AFTAP and minimum contribution purposes.

2.13%, 3.62%, and 3.93% for maximum deductible contribution purposes.

4.84%, 5.15%, and 4.85% for PBGC standard target purposes.

The net effect of these changes had an insignificant impact on the liabilities used to determine the plan's minimum funding requirements.

- Accrued Pension	Actuarial equivalent of the balance of the Participant's Cash Balance Account as of Valuation Date projected to his Normal Retirement Date.

- Cash Balance Account	Hypothetical account established for each participant. Each plan year, the account is credited with participant's Contribution Credit in accordance with the plan. Account accumulates guaranteed earnings based on 30-year Treasury securities interest rate for the month preceding the first day of the plan year (not less than 4%).

- Contribution Credit
Contribution formula varies by participant. The minimum annual contribution for eligible participants is the amount equivalent to providing annual annuity of 0.50% of annual compensation, beginning at normal retirement age.

Contribution amounts this year range from 3.99% to 375.97% of expected compensation.

- Eligibility
Employees become eligible upon attainment of age 21 and completion of 1 year of service, and enter the plan on the January 1 or July 1 following completion of the eligibility requirements.

However, employees not listed in Section Two, Part B of the Plan Document are excluded from the Plan.
