## **INDEPENDENT AUDITOR'S REPORT**

Board of Trustees

### **Opinion**

We have audited the accompanying financial statements of the Southwestern Indiana Building Trades Sheet Metal Workers Substance Abuse and Safety Training Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits- cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits- cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits- cash basis of the Southwestern Indiana Building Trades Sheet Metal Workers Substance Abuse and Safety Training Trust Fund as of December 31, 2024 and 2023, and the changes in net assets available for benefits- cash basis for the year ended December 31, 2024, in accordance with the cash basis of accounting described in Note 2.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### **Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1- DESCRIPTION OF FUND**

The following description of the Southwestern Indiana Building Trades Sheet Metal Workers Substance Abuse and Safety Training Trust Fund (Fund) provides only general information. Employers should refer to the Agreement and Declaration of Trust and Various Collective Bargaining Agreements for a more complete description of the Fund's provisions.

**General:**

The Fund was established January 1, 2005, for the purposes of promoting the safety of its participants by establishing drug testing, employee assistance, safety training programs and background checks for sheet metal contractors located throughout Southwestern Indiana.

Participating employers are any employers subject to a Collective Bargaining Agreement (CBA) or a Special Agreement of the Fund. Participating employees are any individual employed by a participating employer who is covered by the CBA. Non-bargaining employees are allowed to participate through Special Agreements.

The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees the governance of the Fund

**Benefits:**

The Fund provides confidential drug and alcohol testing, and rehabilitation when test results show unacceptable levels of any substance that can impair an employee's ability to work safely and efficiently. In addition, the fund provides completion of a safety training program and background checks for the benefit of the employees and participants of the Fund.

The Fund contracts with an outside service provider to administer the tests and maintain the employee database. These tests can be performed due to pre-employment, post-accident, random selection, probable cause, return to duty, follow-up, and scheduled based on the terms of the Trust Policy.

There are no accumulated credits and thus no benefit obligations presented.

**Contributions:**

The Trust Policy provides those participating employers make contributions to the Fund of a specified amount for each hour worked. The employers' contribution rate is determined by the current CBA between the participating employers and labor organizations.

Effective December 31, 2024, the hourly contribution rate was as follows: Specialty Workers \$.00; Metal Fab Industrial Workers \$.03; Residential, Industrial Workers and Building Trades \$.08.

**NOTE 2- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Fund are prepared using the cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis of accounting, certain revenues and related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. Consequently, the Fund has not recognized employer contributions receivable or accounts payable and their related effects on the change in net assets available for benefits in the accompanying financial statements.

**Contractual Agreement**

The Fund entered into an automatically renewable contract with DISA Global Solutions. Under the contract, DISA Global Solutions has the exclusive right to administer drug and alcohol testing and employee assistance program services for the members of the Fund.

**Cash**

Cash consists of a noninterest bearing checking account.

**Administrative Expenses**

All expenses of maintaining the Fund are paid out of the Fund as directed by the Board of Trustees.

**Date of Management's Review of Subsequent Events**

Subsequent events were evaluated through June 29, 2025, which is the date the financial statements were available to be issued.

**NOTE 3- FUND TERMINATION**

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Fund to modify the benefits or terminate the Fund subject to the provisions set forth in ERISA. Termination of the Fund would not affect payment of benefits incurred prior to the termination date.

**NOTE 4- TAX STATUS**

The Internal Revenue Service has determined that the Fund is exempt from federal income tax under Section 501(c)(9) of the Internal Revenue Code.

Management has concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Fund is subject to examination by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.
