**Actuarial Cost Method**

The actuarial cost method used for determining the Plan's ERISA funding requirements is the Unit Credit method. Under this method, an accrued benefit is determined at each active participant's assumed retirement age based on compensation and service at both the beginning and the end of the current year. The Plan's normal cost is the sum of the present value of the excess of each active participant's accrued benefit at the end of the current year over that at the beginning of the current year. The Plan's accrued liability is the sum of (a) the present value of each active participant's accrued benefit at the beginning of the current year plus (b) the present value of each inactive participant's benefits.

**Asset Valuation Method**

The asset valuation technique determines valuation assets according to the asset averaging method described in IRS Notice 2009-22 using a 2-year averaging period. The Actuarial Value of Assets is equal to the average of the Market Value of Assets as of the valuation date and the expected Market Value of Assets for each of the immediately preceding 2 years, but not less than 90% nor greater than 110% of the Market Value of Assets as of the valuation date. The expected investment return for a plan year is based on the lesser of the expected rate of return on plan assets or the applicable statutory interest rate for the year.

**Normal Retirement Benefit:** A monthly Benefit payable on the normal retirement date in the Normal Benefit Form in an amount equal to 1.75% of Average Compensation (1.25% for Participants hired on or after October 1, 1996) multiplied by Years of Benefit Service up to 35 years, plus 1.25% of Average Compensation multiplied by Years of Benefit Service in excess of 35 years up to 5 years, minus 0.49% of Final Average Compensation (up to Covered Compensation) multiplied by Years of Benefit Service up to 35 years.
