### **1. Description of Plan**

The following description of the RPM Management Profit Sharing Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution profit sharing plan covering all non-union employees of RPM Management, LLC (the "Employer") who are 21 years of age or older and have completed 1,000 hours of service. The Plan allows participants to defer compensation and receive an employer matching contribution after 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

RPM Management, LLC is the Plan's sponsor and administrator, and is responsible for oversight of the Plan. Empower Trust Company, LLC is the custodian of the Plan.

#### ***Contributions***

Eligible employees may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. Participants may contribute to the Plan on a pre-tax basis and/or after-tax Roth basis, up to the maximum dollar limit as permitted by the Internal Revenue Code (the "Code"). Eligible participants may make "catch-up" contributions subject to certain limitations as defined by the Code. Contributions are funded to the Plan following each pay date. Participants may also make rollover contributions from other qualified plans.

The Employer may elect, at its discretion, to make matching or non-elective contributions to the Plan. Participants are eligible to receive Employer contributions if they have completed 1,000 or more hours and are active participants on December 31 of the Plan year. The entry dates for receiving the profit sharing contribution are January 1 or July 1 coinciding with or next following the date eligibility requirements are met. During 2024, the Employer matched 100% of each eligible participant's contributions (excluding rollovers) up to 6% of eligible compensation. The discretionary matching and profit-sharing contributions were recorded as an employer contribution receivable at December 31, 2024. The discretionary matching contributions were recorded as an employer contribution receivable at December 31, 2023. The Employer did not make any profit-sharing contributions for 2023.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, as well as an allocation of the Employer contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balances to any combination of the Plan's investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan *(continued)*

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of service. To earn a year of service, a participant must be credited with at least 1,000 hours of service during a Plan year. A participant vests at the following rate: 0% vested before completing two years of credited service, 20% vested after two years, 40% vested after three years, 60% vested after four years, 80% vested after five years, and 100% vested after six years of credited service.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan permits that up to two loans may be taken at one time. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loan interest rate is established by the administrator in a nondiscriminatory manner. Principal and interest is paid ratably through payroll deductions.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or for other reasons, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions may also be made in installments to comply with required minimum distribution rules required by the Code. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

#### *Forfeited Accounts*

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$14,571 and \$18,876. During 2024, \$14,000 of forfeitures were used to offset Employer contributions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting and Use of Estimates*

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **2. Summary of Significant Accounting Policies (continued)**

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except for the investment in the group annuity contract which is fully benefit responsive and valued at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payments of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is May 15, 2025.

### **3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions.

### **4. Investments**

At December 31, 2024 and 2023, the Plan's mutual funds totaling \$23,312,248 and \$20,723,273, that were measured at fair value on a recurring basis, were valued using level 1 inputs.

The Group Annuity Contract is valued at contract value and amounted to \$1,444,630 and \$1,608,794 at December 31, 2024 and 2023.

### **5. Group Annuity Contract**

The Plan has a fully benefit responsive group annuity contract with Empower Annuity Insurance Company of America ("EAIC"). The Key Guaranteed Portfolio Fund ("KGPF") is a general account product of EAIC. As a general account product offered through the group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of EAIC. The KGPF credits interest daily. The credited interest rate may change or stay the same each quarter. The quarterly credited rate applies to all money deposited in the KGPF, regardless of when it was deposited. Participants may transfer their account balances in the KGPF to any other investment option offered under the Plan at any time with no restrictions or penalties because the fund is designed to be the Plan's only guaranteed investment.

Upon termination of the EAIC group annuity contract, the Employer may choose the following options associated with the KGPF: 1) receive the payout of the fund in a lump sum with market value adjustment, 2) receive the payout of the fund in a lump sum at book value; if this option is selected, EAIC may defer payment to a future date, but no longer than 12 months and there are participant transfer restrictions that apply until the money is paid to the next provider, or 3) mutually agree in writing to any other payout option allowable under applicable law.

The principal and previously credited interest is guaranteed by EAIC. This guarantee is subject to EAIC's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+), Moody's (Aa3) Standard and Poor's (AA), and Fitch (AA-). These ratings are as of December 31, 2024.

The KGPF represents approximately 5% and 7% of the net assets available for benefits as of December 31, 2024 and 2023.

### **6. Tax Status**

The Internal Revenue Service has determined and informed the prototype document preparer by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since the letter was issued by the IRS, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **8. Party-in-Interest Transactions**

Certain investments of the Plan are managed by Empower Trust Company, LLC, the custodian of the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### **9. Risk and Uncertainties**

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
