**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Scottsdale Christian Academy Inc. 403(b) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Scottsdale Christian Academy Inc. 403(b) Retirement Plan (the Plan) provides only general information. The Plan is administered by a trustee and an administrator appointed Scottsdale Christian Academy, Inc. (Organization), the Plan's sponsor.

General – The Plan is a defined contribution plan originally effective July 1, 2001 and most recently amended on April 17, 2018 and restated effective January 1, 2010. The Plan covers all employees who normally work more than 20 hours per week excluding any student employees, of the Organization and excludes paraprofessionals and faculty teaching four classes or fewer from the matching portion of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a fixed dollar amount or percentage, limited by Plan provisions, of their compensation contributed as pre-tax contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year.

The Employer may make discretionary matching contributions. The percentage matched by the Employer for the years ended December 31, 2024 and 2023 ranged from 3% to 5%, with administrator positions hired prior to April 2021 receiving an additional 2%. A participant is eligible to receive an employer matching contribution after attaining the age of 21. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of contributions into various investment options offered by the Plan.

The Organization also provides a benefit for employees called a benefit option payment (BOP) in which regular full-time employees have the option to receive an amount up to \$1,000 deposited into their individual accounts as an employee contribution, in addition to any matching contributions. Full-time administrators may receive up to \$2,000 as an employee contribution.

Effective March 1, 2023, the plan adopted an amendment to include an auto-enrollment provision, whereby all employees, except those already participating in the Plan at an elective deferral rate at least equal to the automatic deferral percentage of 3%, are automatically enrolled in the Plan, unless they elect not to participate. Contributions are automatically invested into a designated balanced fund until changed by the participant.

**NOTE 1 – DESCRIPTION OF PLAN (CONT'D)**

Participant Accounts – Each participant's account is credited with the participant's contributions, the Organization's matching and BOP contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting – Participants are immediately vested in their contributions, the Employer matching contributions, and BOP contributions, plus actual earnings thereon.

Payment of Benefits – Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, installment, partial payment or an annuity option as elected by the participant. Plan allows for in-service distributions if a participant reaches age 59<sup>1/2</sup> and hardship distributions subject to Plan provisions.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. At December 31, 2024 and 2023, there were no outstanding notes receivable from participants.

Forfeited Amounts – Forfeited balances of terminated participants' accounts can be applied to pay administrative expenses, with the remaining balance available to reduce Company contributions. Forfeitures during the years ended December 31, 2024 and 2023, were \$120, and \$0, respectively. The ending balance of the forfeiture account as of December 31, 2024 and 2023 was \$125 and \$5, respectively.

Plan Termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the plan are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – The Plan's expenses are paid either by the Plan or the Organization, as provided by the Plan document. Expenses paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits – Benefits are recorded when paid.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for information on fair value measurements. The Plan's Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance companies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events - Subsequent events were evaluated through June 26, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Fair Value of Financial Instruments – The Plan applies generally accepted accounting principles (GAAP) for fair value measurements of financial assets that are recognized or disclosed at fair value in the financial statements on a recurring basis. GAAP defines fair values as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values for these instruments are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

Level 3 - Inputs that are unobservable inputs for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. A description of the valuation methodologies used for assets measured at fair value is as follows:

Pooled Separate Account – Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

Interest in Sub-Accounts of Variable Annuity Contracts – Valued by TIAA-CREF at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end.

Insurance Company General Accounts – Investments in the insurance company general account are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Funds under the investments contract that have been allocated and applied to purchase annuities (that is, Insurance Company is obligated to pay the related pension benefits) are excluded from the Plan's assets.

**NOTE 5 – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANIES**

The Plan holds investments in group annuity contracts with TIAA-CREF, AUL and Protective Life Insurance Company. The contracts' investments include pooled separate accounts and general accounts. The contracts with AUL and Protective Life Insurance Company are nonfully benefit responsive and are valued at fair value. TIAA-CREF maintains a portion of contributions in a "guaranteed account", which is called the Traditional Annuity. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA-CREF. For certain TIAA-CREF contracts held by the Plan, the guaranteed account is nonfully benefit responsive and therefore is included in the financial statements at fair value, (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses). For other TIAA-CREF contracts held by the Plan, the guaranteed account is fully-benefit responsive and is therefore included in the financial statements at contract value, which approximates fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 – TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The IRS has determined and informed the plan recordkeeper by a letter dated August 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan's federal information returns are subject to examination by taxing authorities generally for three after they were filed. As of December 31, 2024, the returns for 2021, 2022, 2023 and 2024 remain subject to examination.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA-CREF, AUL and Protective Life Insurance Company, the custodian and insurance company of the Plan; therefore, these transactions qualify as party-in-interest transactions. TIAA-CREF, AUL and Protective Life Insurance Company deducts certain fees directly from investment earnings for investment management services. These fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits. TIAA-CREF, AUL and Protective Life Insurance Company maintain and process participant data and account information. TIAA-CREF, AUL and Protective Life Insurance Company are the recordkeepers as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. There were \$51,920, \$248 and \$0 of fees paid by the Plan to TIAA-CREF, AUL and Protective Life Insurance Company, respectively, for the year ended December 31, 2024.
