# **COMPLETE CHILDREN'S HEALTH, P.C. 401(k) PROFIT SHARING PLAN NOTES TO FINANCIAL STATEMENTS For the years ending December 31, 2024 and 2023**

## **1. Plan Description:**

The following description of the Complete Children's Health, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Certain prior year amounts have been reclassified to conform with current year presentation.

### **General**

Complete Children's Health, P.C. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Complete Children's Health, P.C. (the Company). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Employees are eligible to make pre-tax and after-tax Roth salary reduction contributions and receive safe harbor matching contributions and discretionary non-elective employer contributions after attaining age 18. Eligible employees become participants on the first day of the month following the date on which the entry requirements are fulfilled. In order to receive discretionary non-elective employer contributions, the employee must work one year with at least 1,000 hours of service during the Plan year and must be employed on the last day of the year.

### **Contributions**

Each year, participants may make voluntary pre-tax and after-tax Roth salary deferral contributions up to 100% of their eligible compensation, up to the maximum amount allowed by law. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company makes safe harbor matching contributions of 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of each participant's deferrals in excess of 3% but not in excess of 5% of the participant compensation. The Company may make discretionary non-elective employer contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor matching contributions and discretionary non-elective employer contributions and, (b) Plan earnings and losses. The Company's safe harbor matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. Plan earnings and losses are allocated on the basis of actual results of the investment selected by each participant. Investments are maintained in individual member accounts managed by Union Bank & Trust Company (UBT).

**1. Plan Description, Continued:**

**Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds as investment options for participants.

**Vesting**

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of the accounts is based on years of continuous service. A participant is 25% vested after one year of credited service and vesting increases 25% per year until a participant is 100% vested after four years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance of the participant's account balance and bear interest at one percent above the prime interest rate. Principal and interest payments must be made through payroll deductions or through ACH payments.

**Payment of Benefits**

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

**Forfeitures**

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their non-elective employer contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses, reduce employer contributions, or reallocated to participants. As of December 31, 2024, there was \$215 of forfeited non-vest account balances. As of December 31, 2023, there was no balance in the forfeited non-vest account balances. During 2023, \$73 of forfeiture was used as employer contributions.

**2. Summary of Significant Accounting Policies:**

The following is a summary of the significant accounting policies followed in the preparation of these financial statements:

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America.

**Presentation of Participant-Directed Funds**

The Plan's presentation of participant directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified to distributions based upon the terms of the Plan document.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Other**

Audit fees are paid by the Company and are excluded from these financial statements. Investment management and recordkeeping expenses are paid by the Plan and are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participants' accounts are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Date of Management's Review**

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Subsequent events were evaluated through June 26, 2025, which is the date the financial statements were available to be issued.

**3. Investments:**

The Plan's investments were held in trust and administered by the trustee, Union Bank & Trust Company (UBT), for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

**Information Prepared and Certified by Trustee**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by UBT, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

FASB Accounting Standards Codification section 820, "*Fair Value Measurements and Disclosures*," establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

\*Investments measured at fair value using Net Asset Value (NAV) per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

*Level 1 Fair Value Measurements*

Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date. The fair values of mutual funds and common stock are based on quoted market prices, when available.

*Level 2 Fair Value Measurements*

Fair values are based on inputs other than quoted prices included in Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. There were no Level 2 inputs.

*Level 3 Fair Value Measurement*

Fair values are based on unobservable inputs used for valuing the asset or liability. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. There were no Level 3 inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Self-Directed Brokerage Accounts:* The self-directed brokerage accounts include investments in money market funds, mutual funds, corporate bonds and common stocks. The common stocks, mutual funds, corporate bonds and money market funds are valued at the closing price reported on the active market on which the individual securities traded.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* The estimated value of the common collective trust is at NAV. The use of NAV as fair value is deemed appropriate as the common collective trust does not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. FASB ASC 820, "*Fair Value Measurements and Disclosures*," allows NAV per share as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan's assessment that this common collective trust meets those requirements, since the participants have the ability to redeem this fund at NAV as of the measurement date on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

**5. Tax Status:**

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code (IRC) and is exempt from federal income taxation under Section 501(a) of the IRC.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**6. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and distribution to the participants of the account balances would be made as soon as practicable after the termination date.
