#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of **Touchstone Behavioral Health 401(k) Plan** (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following brief description of the **Touchstone Behavioral Health 401(k) Plan** (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**A. General** - The Plan is a defined contribution plan covering qualified employees of Touchstone Behavioral Health (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**B. Eligibility** - Employees are eligible to participate in the Plan if they have completed 90 days of service and are 21 years of age.

**C. Entry date** - Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan’s eligibility requirements.

**D. Contributions** - Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Under the safe harbor provisions of the Plan, the Company contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the discretion of the Company’s board of directors. No such additional discretionary contributions were made for the twelve-month period ended December 31, 2024.

**E. Participant accounts** - Each participant’s account is credited with the participant’s contributions and the Company’s safe harbor contributions, as well as allocations of the Company’s discretionary contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**F. Investment options** - Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

**G. Vesting** - Participants are vested immediately in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts is based on years of credited service as set forth in the following table:

**H. Notes receivable from participants** - Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance.

The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan will be 15 years. A participant may have no more than one outstanding loan at any one time.

**I. Payment of benefits** - Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or annual installments as defined in the plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified individual retirement account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the plan document.

**J. Administrative expenses** - The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**K. Plan termination** - Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer contributions.

**L. Forfeitures** - Forfeited balances of terminated participants' accounts can be applied to pay administrative expenses or reduce Company discretionary contributions. There were \$819 and \$918 of forfeited non-vested amounts in the Plan at December 31, 2024 and 2023, respectively. There were no forfeited non-vested amounts utilized by the Plan during the year ended December 31, 2024.

## 2. Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are as follows:

### *i. Basis of accounting*

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with U.S. generally accepted accounting principles (GAAP). Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment account (see Note 5).

### *ii. Management's use of estimates*

In preparing the financial statements in accordance with U.S. GAAP, management is required to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### *iii. Investment valuation and income recognition*

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as though held during the year.

### *iv. Risks and uncertainties*

The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

### *v. Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables are reclassified as benefit payments based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

### *vi. Payment of benefits*

Benefits are recorded when paid.

### *vii. Subsequent events*

Plan management has evaluated subsequent events through April 2, 2025, which is the date the financial statements of the Plan were available to be issued.

## **3. Fair value measurement**

Plan management utilizes the fair value hierarchy to apply fair value measurements. The fair value of a financial instrument is the price that would be received to sell an asset or pay to transfer a liability in an orderly transaction between market participants at the measurement date. Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that Touchstone has the ability to access.*

*Level 2 - Inputs to the valuation methodology include:*

- Quoted prices for identical or similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 - Inputs to the valuation methodology and model are unobservable and significant to the fair value measurements.*

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Information certified by the Plan's custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company and Empower Trust Company, LLC, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Interest and dividends
- Net appreciation or decline in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### 5. Investment contract with insurance company

The Plan has a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company (Empower Insurance) reported at contract value. Empower Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in the basis of accounting disclosure because the investment contract is fully benefit-responsive, contract value is the relevant measure for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Empower Insurance, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity was provisions, 3) bankruptcy of the Plan Sponsor or other events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The investment contract does not permit Empower Insurance to terminate the agreement prior to the scheduled maturity date.

### 6. Party-in-interest transactions

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, who are the custodians as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations. Fees paid to the custodians totaled approximately \$21,000 and other service providers totaled approximately \$30,000 for the year ended December 31, 2024.

### 7. Income tax status

The Plan has adopted an Empower Trust Company, LLC Prototype Plan (the "Prototype Plan"). The Prototype Plan received an opinion letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with applicable sections of the IRC. Management has not obtained an individual determination letter for the Plan. The Prototype Plan has been amended since receipt of the opinion letter. Management and the Plan Administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified, and the related trust remains tax-exempt, at December 31, 2024. Accordingly, no provision for income taxes has been made in the accompanying financial statements.
