## REPORT OF INDEPENDENT ACCOUNTANTS

*The Trustees*

*Portland Art Museum 401(k) Retirement Plan:*

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Portland Art Museum 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Portland Art Museum 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Portland Art Museum 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Portland Art Museum 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Portland Art Museum 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Portland Art Museum 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Other Matters*

*Supplemental Schedules Required by ERISA*

The supplemental Schedule H, Line 4i, Schedule of Assets (Held at End of Year) on pages 12 through 13 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

YEAR ENDED DECEMBER 31, 2024

---

1. Description of the Plan

The following is a brief description of the Portland Art Museum 401(k) Retirement Plan (the “Plan”), and is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established for the exclusive benefit of employees of the Portland Art Museum (the “Museum”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Ascensus Trust Company is the Plan’s custodian and, as such, has responsibility for managing the Plan’s assets, subject to the direction of the Trustees.

Plan Contributions – Participants may contribute a portion of their compensation by means of payroll deductions, either as a pre-tax salary deferral contribution or a Roth salary deferral contribution, subject to certain discrimination tests and the limits prescribed by the Internal Revenue Code. The Museum provides eligible participants with a safe harbor matching contribution of 100% of participant deferrals up to 4.0% of the participants’ eligible compensation, as defined by the Plan. Employer matching contributions totaled \$291,865 for the year ended December 31, 2024.

The Museum may also make discretionary profit sharing contributions to the Plan. If the Museum elects to make discretionary profit sharing contributions to the Plan, the amount of the contributions, and the frequency of contributions, will be determined at the Museum’s discretion. No discretionary profit sharing contributions were made to the plan for the year ended December 31, 2024.

Participants’ Accounts – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Museum’s contributions, and (b) Plan earnings; and charged with an allocation of administrative expenses. Allocations are based on the participant’s earnings or account balance, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are 100% vested in their salary deferral and employer safe harbor contributions at all times. Participants are vested in the Museum’s discretionary contributions to their accounts based on years of continuous service. A participant is 100% vested in the Museum’s discretionary contributions after three years of credited service.

Notes Receivable from Participants – Loans are permitted, with the approval of the plan administrator. Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Any loan by its terms requires that repayment (both principal and interest) be amortized in equal payments, not less frequently than quarterly, over a period not to exceed five years, except if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant’s account, and bear interest at the prime rate, as specified by *The Wall Street Journal*, plus 1.0% as of the date of the loan.

Payment of Benefits – On termination of service due to death, disability, or retirement, or upon reaching normal retirement age of 59.5, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in his or her account, or may elect to receive non-recurring partial payments from the vested portion of their account.

**Forfeiture Disposition** – The portion of a former employee’s equity in the Plan’s assets which is not vested is subject to forfeiture and reallocation in accordance with the provisions of the Plan. There were no forfeitures for the year ended December 31, 2024.

**Eligibility Requirements** – All employees of the Portland Art Museum are eligible to participate in the Plan and qualify for employer contributions after attainment of a minimum service requirement of one year and 1,000 hours of service. Employees may enter the Plan on January 1st, April 1st, July 1st, or October 1st after or coinciding with fulfillment of the service requirements.

**Plan Termination** – Although it has not expressed any intent to do so, the Museum has the right to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan’s termination, participants become 100% vested in the employer contributions.

**Operating Expenses** – The Plan’s assets are used to pay certain administrative expenses. Certain fees related to investment transactions are deducted directly from the participant accounts. The Museum may, at its discretion, pay certain administrative fees on behalf of the Plan. Fees paid by the Plan for investment management services totaled \$17,626 and \$13,685, respectively, for the years ended December 31, 2024 and 2023.

**Party-in-Interest Transactions** – Certain Plan investments are managed by Ascensus Trust Company, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, administrative fees paid to Ascensus Trust Company totaled \$2,439. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Tax Status** – The Museum has adopted a prototype plan document, and is relying on the prototype sponsor’s opinion letter from the Internal Revenue Service, dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the prototype plan has been amended since receiving the opinion letter, the Museum believes that the Plan is designed and currently is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

## 2. Summary of Accounting Policies

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Estimates** – The preparation of the Plan’s financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. In the opinion of management, such differences, if any, would not be significant.

Investments – Investments are carried at fair value. Net appreciation (decline) in the fair value of investments consists of the realized gains or losses and the unrealized appreciation (decline) of those investments. Security transactions are recorded on a trade date basis.

Risk and Uncertainties – Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants – Loans to participants are reported at their unpaid principal balances plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default according to Plan documents, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Concentration of Credit Risk – All of the Plan's assets are invested in mutual funds and money market funds.

Subsequent Events – Subsequent events have been evaluated by management through June 17, 2025, which is the date the financial statements were available to be issued.

Other Significant Accounting Policies – Other significant accounting policies are set forth in the financial statements and the following notes.

### 3. Information Prepared and Certified by the Custodian

The Plan has obtained certifications from Ascensus, as an agent of Ascensus Trust Company, that the information provided by them is complete and accurate. The information certified by them includes:

- Details and summaries of investments at fair value and other assets as of December 31, 2024 and 2023;
- Details and summaries of net increase in the fair value of Plan investments during the year ended December 31, 2024; and
- Details and summaries of interest during the year ended December 31, 2024.

### 4. Cash Equivalents, Investments, and Investment Return

As of December 31, 2024 and 2023, the Plan's investments were held in 32 funds at registered investment companies (i.e., mutual funds), and in one money market account. The underlying assets of these investments are as follows:

## 5. Fair Value Measurements

The accompanying financial statements report the Plan's investments at fair value. These assets have been classified, for disclosure purposes, based on a hierarchy defined by the Financial Accounting Standards Board ASC No. 820, *Fair Value Measurements and Disclosures*. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3).

At December 31, 2024, the Plan's financial assets that are reported at fair value on a recurring basis consist of investments, which are measured at fair value using quoted prices for identical assets (i.e., Level 1). See note 4.
