### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Scott Fetzer Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As further discussed in Note 1, the Plan was merged into the Marmon Employees' Retirement Plan effective December 31, 2024. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

### 1. Description of the Plan

The following description of The Scott Fetzer Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible salaried and certain eligible hourly employees of the companies listed in the next paragraph. The Plan covers eligible employees who have completed 60 days of service, as defined, and attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Scott Fetzer Company Administrative Committee oversees governance of the Plan. The Scott Fetzer Company Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

An eligible employee must be a salaried employee or certain classification of hourly employee of The Scott Fetzer Company, Adalet/Scott Fetzer Company, Carefree/Scott Fetzer Company, SFEG Corp., Halex/Scott Fetzer Company, Stahl/Scott Fetzer Company, Wayne/Scott Fetzer Company, Western/Scott Fetzer Company, United Consumer Financial Services Company, The Scottcare Corporation, World Book, Inc., World Book Encyclopedia Inc., Altaquip LLC and Powerex-Iwata Air Technology, Inc. (collectively, the Companies). The employee must also not be covered by a collective bargaining agreement and may not be a nonresident alien.

The Board of Directors of World Book, Inc., a participating employer of the Plan, approved a transfer of World Book, Inc. plan assets to the Plan. During February 2024, the Plan received a transfer of assets in the amount of \$1,485,608.

Effective December 31, 2024, the Plan merged into the Marmon Employees' Retirement Plan (Marmon Plan). Investment balances totaling \$83,525,902 were transferred to the trustee of the Marmon Plan on December 31, 2024. In addition, effective January 1, 2025, contributions began being remitted to the Marmon Plan.

#### *Contributions*

Each year, participants may contribute from 1 percent to 50 percent of pretax annual compensation for non-highly compensated participants and from 1 percent to 8 percent of pretax annual compensation for highly compensated participants, as defined in the Plan. Non-highly compensated participants may also contribute up to 8 percent of their after-tax annual compensation. In addition, the Plan adopted an after-tax (Roth) deferral provision effective January 1, 2019. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The Plan offers a 1 percent auto-escalation option if the participant elects.

For eligible employees initially hired after January 1, 1987, the Companies offer an employer match contribution. Hourly employees receive an employer match equal to 50 percent of the first 6 percent

of base compensation that a participant contributes to the Plan and salaried employees receive an employer match equal to a minimum of 35 percent of the first 6 percent of base compensation that a participant contributes to the Plan, unless a greater amount is determined by the employer and communicated to employees in writing. Effective January 1, 2019 the Plan was amended to adopt discretionary provisions which allow the participating employers to increase the matching provision from 35 percent to 50 percent. Effective May 1, 2020, the Plan was amended to allow the participating employers to elect the matching percentage contributed at the discretion of each employer. Certain employers elected to suspend matching contributions to the Plan upon this effective date. During 2021, several employers reinstated the matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

### ***Forfeited accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$28,604 respectively. These accounts are used to pay Plan expenses or reduce future employer contributions. During 2024 and 2023, forfeited non-vested accounts totaling \$47,816 and \$19,227, respectively, were used to pay Plan expenses. Employer contributions were reduced by \$435,326 and \$2,552 during 2024 and 2023, respectively, from forfeited non-vested accounts.

### ***Payment of benefits***

Upon attaining age 59 ½ or termination of service, whether voluntary or involuntary, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan provides for automatic rollover provisions. If the participant's account is between \$1,000 and \$5,000, the Plan may make an automatic rollover of the participant's vested interest in his or her account to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan may make an automatic lump sum distribution to the participant equal to the participant's vested interest in his or her account. Distributions of a participant's account balance may be authorized at any time by the Plan administrator under certain hardship conditions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Scott Fetzer Company Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Plan Expenses*

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### *Transfers In/Out of the Plan*

During 2024 and 2023, \$2,422 and \$0, respectively, was transferred into the Plan from The Scott Fetzer Hourly Employee 401(k) Plan based on changes in certain eligibility criteria of the participants, as defined.

### *Subsequent Events*

The Plan has evaluated subsequent events through June 27, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2023, and interest and dividends and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company), the trustee.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the funds. The mutual funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

*Self-directed brokerage accounts (SDB Accounts):* Valued at the underlying values of the individual assets held within the brokerage accounts. The brokerage accounts primarily consist of common stock, mutual funds and unit investment trusts that are valued on the basis of readily determinable market prices.

*Collective trust fund - stable value fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value (NAV) of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. There are no redemption restrictions upon which the participant may redeem investments in the fund. However, the Plan is required to provide a one-year redemption notice to liquidate its entire investment in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan adopted the Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan With Cash or Deferred Arrangement plan document. Principal Life Insurance Company has obtained an opinion letter dated June 30, 2020 in which the IRS stated that the plan document is in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and operating in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### 7. Related-Party and Party in Interest Transactions

Principal Trust Company is the trustee of the Plan. During the years ended December 31, 2024 and 2023, administrative expenses paid to Principal Trust Company by the Plan amounted to \$144,066 and \$131,483, respectively. Therefore, these transactions qualify as party in interest transactions.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Delinquent Participant Contributions

During 2024 and 2023, the Company did not timely remit participant contributions totaling \$43 and \$73, respectively. The Company remitted the deferrals and lost earnings during 2024.
