NOTE A. DESCRIPTION OF THE PLAN

The following description of the SMC Global Holdings, Inc. (“Company”) Savings Plan and Trust (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor 401(k) profit-sharing plan as described under Internal Revenue Code Section 401(k). The Plan covers full-time employees of SMC Global Holdings, Inc. and its subsidiaries, St. Marys Carbon Co., Inc., Catalus Corporation and U.S. Resistor, Inc. who have at least six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective February 1, 2024, Catalus Corporation has been sold to a new company. All employees were terminated as of that date.

Contributions

The Plan is funded through employer contributions and pre-tax employee payroll deductions. Each year participants can elect to defer a percentage of their pretax annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company shall make contributions in an amount equal to 3% of compensation for persons who were active participants at any time during the plan year. Participants direct the investment of all contributions into various investment options offered by the Plan. The amount a participant may defer in any tax year is limited by law.

Participant Accounts

Each participant’s account is credited with the participant’s respective deferral, the Company’s qualified non-elective contribution and plan earnings. Participant accounts are charged with an allocation of certain investment and administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

NOTE A. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are immediately 100% vested in their total account, which includes employee deferrals, company contributions and earnings.

Payment of Benefits

On termination of service, a participant can leave funds in the Plan or receive a lump sum amount equal to the value of the participant's account. If the participant's account value is \$5,000 or less, the entire amount will be paid to the participant upon termination.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding at any given time. Loans must be repaid in level payments on at least a quarterly basis over a period no greater than five years unless used for the purchase of a primary residence. The remaining account balance will be used as collateral for any loan. The loans will bear interest at a rate commensurate with prevailing rates as determined by the plan administrator.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassification

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

Date of Management's Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company, the custodian of the Plan.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs available to the Plan.

The fair value of the pooled separate accounts and the common collective trusts is based on the market value of the underlying assets.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE E. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor, SMC Global Holdings, Inc., provides the Plan with accounting and administrative services for which no fees are charged. In addition, certain plan investments are shares of pooled separate accounts managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$31,413 for the year ended December 31, 2024.

Members of the management team are currently participants in the Plan, one member serves as the plan administrator and two other members serve as trustees.

The Plan has notes receivable from participants subject to specific guidelines as defined in the plan document (see Note A).

In addition, SMC Global Holdings, Inc. directly pays certain administrative expenses for the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE G. TAX STATUS

The Internal Revenue Service has determined and informed the custodian by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
