Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of R & R, Inc. Employees 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

R & R, INC. EMPLOYEES 401(k) PROFIT SHARING PLAN

September 30, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following brief description of R & R, Inc. Employees 401(k) Profit Sharing Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution 401(k) plan covering substantially all employees of R & R, Inc. and R & R, Inc. of PA (the Companies) who have completed a 3-month eligibility period and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may make pre-tax and roth voluntary contributions of up to 100% of their annual compensation, as defined in the Plan agreement. The maximum voluntary contribution was \$23,000 and \$22,500 for calendar years 2024 and 2023, respectively. The total annual participant voluntary contribution is adjusted annually by a cost of living factor. Participants who will be at least age 50 by the end of the year may make additional contributions of \$7,500 for calendar years 2024 and 2023, respectively. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Companies can make discretionary matching and profit sharing contributions to the Plan. During 2024, the Companies elected to match 50% of the first 4% of eligible compensation. All contributions are invested in a portfolio of investments as directed by the participants. Contributions are subject to certain limitations.

Participants' accounts – Each participant's account is credited with their voluntary contributions, the Companies' discretionary contributions, forfeitures of terminated participants' nonvested accounts and allocation of the Plan's net earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. The Companies discretionary contributions, if any, are subject to a three-year cliff vesting schedule.

Notes Receivable from Participants – Participants may borrow from their voluntary contribution fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from 1 to 5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

Forfeitures – Upon termination of a participant, the Companies' contributions to which the participant is not vested shall be used to pay Plan expenses or reduce the Companies' future contributions. Any nonvested profit sharing contributions shall be allocated to participants. Forfeitures for the year ended September 30, 2024 totaled \$27,821. Also, in 2024, \$77,035 from forfeited nonvested accounts was reallocated to participants in accordance with plan provisions.

Payment of benefits- Participants may receive a distribution of their vested account balance when employment is terminated or when they reach age 59 ½. Distributions to deceased, disabled, retired or terminated participants are made as soon as administratively possible.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are stated at estimated fair value. Mutual funds are stated at fair value based on quoted market prices. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, which represents contributions plus interest at the contract rate, approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of benefits – Benefits payments to participants are recorded when paid.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Expenses – Certain expenses to maintain the Plan are paid by the Company and are therefore, excluded from these financial statements. Investment related expenses and fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent Events – Management evaluated all activity of the Plan through June 25, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

We have been informed by the plan administrator that the trustee, John Hancock Trust Company, holds the Plan's investment assets and executes investment transactions. The trustee has certified as to the completeness and accuracy of the investments at fair value and contract value, notes receivable from participants, and investment income, as of and for the years ended September 30, 2024 and 2023.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of the mutual funds is based on quoted net asset values of shares held by the Plan at year end.

In instances whereby inputs used to measure fair value fall into different levels in the above fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgement and considers factors specific to each asset.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2024, the Plan terminated its prior contract with New York Life Insurance Company (NYL) and entered into a new traditional fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company (JH). JH maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by JH, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at September 30, 2024 and 2023, was \$3,983,023 and \$3,846,425, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a semi-annual basis for resetting.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANY (CONTINUED)

Certain events might limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE F – RELATED PARTY TRANSACTIONS

The Plan's audit fees are borne by R & R, Inc.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE H – INCOME TAX STATUS

In a letter dated June 30, 2020, the Internal Revenue Service has informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been restated since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as rate, market, and credit risks. Due the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE J – PARTY-IN-INTEREST TRANSACTIONS

Recordkeeping, custodial and other expenses paid by the Plan were incurred with parties-in-interest as defined in Section 3(14) of ERISA.

Certain Plan investments are units of pooled separate accounts managed by John Hancock Trust Company. John Hancock Trust Company is the Trustee and Record Keeper of the Plan. Since these parties are related, these transactions are considered party-in-interest transactions.
