Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Windham Brannon, LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

September 30, 2024

1. Description of the Plan

The following description of Windham Brannon, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Windham Brannon, LLC (the Company) who have attained twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of pre-tax annual compensation (as defined in the Plan document) and/or Roth contributions, not to exceed federal limits. For those participants who do not make an election, an automatic deferral of 5% of pre-tax annual compensation will apply upon meeting the eligibility requirements and will be increased by 1% per year up to a maximum of 10% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also provides for in-Plan Roth rollover contributions for eligible participants.

The Company may make a discretionary matching contribution to each participant based on his or her elective deferrals in a percentage set by the Company. For the year ended September 30, 2024, the Company elected to match 50% of participant contributions up to a maximum of 8% of the participant's pre-tax eligible compensation. Additional discretionary nonelective contributions may be made at the option of the Company. No such contribution was made during the year ended September 30, 2024. Contributions are subject to certain limitations.

Forfeitures

Forfeitures of terminated, nonvested participant accounts may be used to pay Plan expenses or to reduce future Company contributions. Forfeited account balances at September 30, 2024 and 2023 were \$8,459 and \$18,442, respectively. During the Plan year, the Plan used \$49,246 to reduce Company contributions and \$10,750 to reduce Plan expenses.

Benefit Payments

On termination of service due to separation, death, disability, or retirement, a participant may receive a full or partial lump-sum amount or installment payments (only for required minimum distributions) equal to the value of the participant's vested interest in his or her account. A participant may obtain an in-service or hardship withdrawal subject to certain conditions and penalties as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. At September 30, 2024 and 2023, loans had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years unless used for the purchase of a residence.

Principal and interest are paid through payroll deductions or by check. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received by the Plan. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain administrative expenses, including trustee and recordkeeping fees, have been paid by the Company. Participant initiated distribution fees are charged directly to the participant's account. All other administrative expenses and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and Plan earnings or losses in their account, allocations of the Company's discretionary nonelective contribution and is charged with certain administrative expenses. Allocations are based on participant earnings, as defined in the Plan document. Participants direct the investment of their account into various investment options offered by the Plan. The Company currently offers 22 mutual funds as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions. Company safe-harbor contributions, plus actual earnings thereon, are also immediately vested. Vesting in the Company discretionary matching and discretionary nonelective contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested in their Company contributions after six years of credited service or attainment of age 55, whichever comes first.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary matching and nonelective contributions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, as well as any investment-related expenses.

The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management of the Company evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through June 12, 2025, which is the date the financial statements were available to be issued.

3. Investment Information

All information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at September 30, 2024 and 2023, and net appreciation in fair value of investments and notes receivable interest income for the year ended September 30, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (Empower), the trustee of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan operates under a non-standardized, pre-approved plan document created by Empower. Empower received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter and has been amended since Empower received the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Party-In-Interest Transactions

Certain Plan investments include shares of mutual funds which are managed by Empower. Empower is a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.
