***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**NOTE 1**    Description of plan

The following description of the AllOne Health Resources, Inc. 401(k) Retirement Savings Plan (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1994, and amended, thereafter, several times, most recently for the Plan year on January 30, 2024. The Plan is a contributory defined contribution plan which covered all employees of AllOne Health Resources, Inc. and its wholly-owned subsidiaries AllOne Health EAP, All Points EAP & Organizational Services, LLC, Reach EAP, LLC, Lytle Behavioral Health, LLC and its subsidiary, Lytle Behavioral Health VA, LLC, Sand Creek EAP, LLC, Encompass EAP, LLC, Ease@Work EAP, LLC, Employee Resource System, Inc., Impact Solutions, Inc., Workplace Services Corporation, Life Expert, LLC, FEI Behavior Health, Inc, ACI Enterprise, Inc, Palmetto EAP, Triad Resource Group, LLC, Perspectives, LTD and Deer Oaks EAP Services, LLC, (together the "Company") who have completed one month of service and attained age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Participation

An employee who meets the eligibility requirements to become a participant in the Plan is allowed to participate on the first day of the month coinciding or following eligibility.

Contributions

There are several types of contributions that can be added to a participant's account: an employee salary deferral contribution, Company matching contributions, the Company's discretionary nonelective contribution, if any, and qualified nonelective contribution, if any. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Participants may contribute up to 100% of their annual pre-tax compensation by way of a salary deferral contribution. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic enrollment feature, participants will be notified approximately 30 days prior to when the Employer automatically deduct 3% from pay on a pre-tax basis as a deferral contribution, unless Participants direct the investment of all contributions into various investment options offered by the Plan. The Company makes a matching contribution in an amount equal to 3% of the participant's eligible compensation. Contributions are subject to certain IRS limitations.

Participants direct the investment of all contributions into various investments options offered by the Plan.

Each year, the Company, at the sole discretion of its Board of Directors, determines the amount of the discretionary nonelective contribution to be made from current or accumulated net earnings. There was no discretionary nonelective contribution made in 2024.

Participants' accounts

Each participant's account is credited with the participant's contribution, Company matching contributions, discretionary nonelective contributions, if any, and allocations of (a) the Company's qualified nonelective contributions and (b) Plan earnings (losses) and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances on specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested at all times in the participant's salary deferral account, rollover account, and the employer qualified non-elective account, plus actual earnings thereon, regardless of the number of years of service. If participants cease participation, other than by retirement, disability, or death, the vested interest in the Company's matching contribution and discretionary nonelective contributions, if any, plus actual earnings thereon, is dependent upon the years of credited service as follows:

Payment of benefits

Upon retirement, disability, or death, distributions will be paid as soon as administratively possible in a lump sum or as an annuity. Upon termination of service other than by retirement, disability, or death, a participant will receive a lump sum payment if the total of their vested account balance does not exceed \$7,000. If the vested account balance exceeds \$7,000, the assets will generally be held in a trust until the participant's normal or early retirement date. However, terminated participants may elect to receive their vested accounts following termination.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Borrowings are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 8.50% at December 31, 2024, which are commensurate with local prevailing rates when the borrowing was made. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans must be repaid within five years unless the loan is used to acquire a principal residence.

Forfeited accounts

At December 31, 2024 and 2023, the forfeited non-vested accounts amounted to \$209 and \$309, respectively. These accounts may be used to pay administrative expenses or to reduce

future Company contributions. In 2024, employer contributions were reduced by \$61,502, from forfeited non-vested accounts.

SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

**NOTE 2** Summary of significant accounting policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs used in determining valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. They are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price and are deemed to be actively traded.

Cash equivalents (money market): These represent money market funds which are valued at fair value, which is based on principal value.

Self-directed brokerage account: The self-directed brokerage account is a service offered to allow participants to invest in a wide array of securities. This account consists of mutual funds, common stocks, and cash that are measured at using observable date in active markets and quoted daily.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5** Related party and party in interest transactions

Certain Plan's investments are managed by Fidelity Management Trust Company (Fidelity), the trustee and therefore, these transactions qualify as party in interest transactions. The Plan issues loans to participants, which are secured by the balances in the participants' accounts, therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Service Agreement between the Company and Fidelity. Fidelity receives revenue from certain service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts that would be owed to Fidelity from the Plan for its administrative services to the Plan had the arrangements with the service providers not been in place.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employee receives compensation from the Plan. Substantially all administrative expenses are paid by the Company.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 6** Plan termination

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

**NOTE 7** Tax status

The Plan operates under a prototype standardized profit-sharing plan with a cash or deferral arrangement, which received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") indicating this prototype plan was an acceptable plan under applicable sections of the Internal Revenue Code ("IRC") for use of employers for the benefit of their employees. An employer who adopts this plan will be considered to have a plan qualified under Code Section 401(a), providing all the terms of the Plan are followed and the eligibility requirements and contribution or benefit provisions are not more favorable to officers, owners or highly compensated employees than for other employees. The Plan does not have its own determination letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is

qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8**    Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9**    Information certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA- required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).
