We have performed audits of the accompanying financial statements of 401(K) Profit-Sharing Plan for Employees of Heart of Florida United Way, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Note 1—Description of the Plan

The following description of the 401(K) Profit-Sharing Plan for Employees of Heart of Florida United Way, Inc. (the "Plan") provides only general information. Participants of the Plan should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Heart of Florida United Way, Inc. (the "Organization" or "Employer") that are age 21 or older. The Plan was established on January 1, 2006 and was restated as of July 25, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended on November 1, 2017, providing that, unless electing otherwise, each new and current participant is to be automatically enrolled in the Plan at a participant contribution rate of 2%. Also, unless otherwise elected, this participant contribution rate is to increase 1% per year until it reaches 7%. The provisions of this amendment are effective the earlier of November 1, 2017, the entry date of Plan participant or the date eligibility requirements are met.

Administration – The Plan is administered by the Organization, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Investment Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and fee structure.

Contributions – Plan participants contribute, on a pre-tax basis, up to 100% of their annual compensation to the Plan up to the maximum allowable pre-tax contribution, as determined by the Internal Revenue Service ("IRS"), which for the year ended December 31, 2024 was \$23,000 plus an additional catch-up contribution of \$7,500 for participants over age 50. Effective June 1, 2021, Plan participants may make after-tax contributions under IRS Roth guidelines. Participants may also contribute eligible retirement plan transfers and rollovers from qualifying 401(a), 401(k), 403(b), and IRA plans. However, the Plan will not accept any rollovers from a government 457(b) plan. Effective June 1, 2010, the Plan was amended to include those employees who are "Highly Compensated Employees" as defined in the Internal Revenue Code ("IRC") to be eligible to contribute to the Plan.

The Plan provides for an organization contribution equal to 5% of the participants' annual compensation. The contribution is made whether or not the employee is contributing to the Plan. To qualify for this contribution, participants must complete a year of service, defined as 1,000 hours within a 12 consecutive month period beginning on the anniversary of the day that the employee first performed an hour of service. Employee compensation in excess of \$345,000 in 2024 and \$330,000 in 2023 is not included for the purposes of determining Employer contributions. Any Employer contributions made on behalf of a participant for whom no investment direction is in effect shall be allocated to one of the Mutual of America Retirement Funds based on the appropriate retirement fund based on the participant's age, subject to the participant's right to transfer those funds in accordance with the Plan.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, and an allocation of the Organization contribution and Plan earnings and charged with withdrawals and administrative expenses and an allocation of Plan losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Employee contributions and rollover contributions plus or minus actual earnings or losses thereon have full and immediate vesting. Organization contributions plus or minus actual earnings or losses thereon vest according to the following schedule:

Less than 2	0%
2	40%
3	60%
4	80%
5 or more	100%

Participant accounts become fully vested regardless of the above vesting schedule upon death, disability, attainment of normal retirement age, or upon termination of the Plan. Participants will be credited with a year of service at the end of their first 12 months of employment provided they have completed at least 1,000 hours of service within that 12-month period.

Investment Options – Upon enrollment in the Plan, a participant may direct employee contributions in a variety of investment choices as more fully described in the Plan’s literature. Participants may change their investment options at any time.

Payment of Benefits – The entire vested balance of a participant’s account may be distributed upon termination of employment for any reason. The normal retirement age, as defined by the Plan, is 65. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in their account or annual installments over a period up to 15 years. If a participant terminates for other reasons, they may receive the value of the vested interest in their account as a lump-sum distribution. Vested benefits in amounts less than \$1,000 are distributed in a lump-sum amount without the participant’s election.

Forfeited Accounts – Forfeited nonvested accounts totaled \$11,078 and \$2,992 as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce future Organization contributions. During 2024, Organization contributions were reduced by \$60,781 from the use of forfeited non-vested accounts.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investments – Investments held by the Plan are reported at fair value.

The following is a description of the valuation methodology used for instruments measured at fair value.

Pooled Separate Accounts – These assets are not available in an exchange or an active market; however, as a practical expedient, the fair value is determined based on the net asset value of the underlying assets as traded in an exchange or active market. There are currently no redemption restrictions on these accounts and there are no unfunded commitments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties – Investment securities, in general, are subject to various risks, such as interest rate, credit and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Administration Expenses – Plan administration expenses are paid out of Plan assets, unless otherwise stated.

Subsequent Events – Heart of Florida United Way, Inc. has evaluated subsequent events through June 20, 2025, the date the financial statements were available to be issued and determined there were no events requiring recognition or disclosure.

Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company ("Mutual of America" or the "Qualified Institution") has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Cash equivalents and investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and investment earnings as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4—Party-in-interest transactions

Plan investments and cash equivalents are held and managed by Mutual of America, which qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management services of Mutual of America amounted to \$2,669 for the year ended December 31, 2024.

Note 5—Tax status

The IRS has determined and informed the Organization by a letter dated July 7, 2010, that the Plan is designed in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since 2010, but the Plan administrator believes the Plan continues to be operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified and tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

Note 6—Plan termination

The Organization believes the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.
