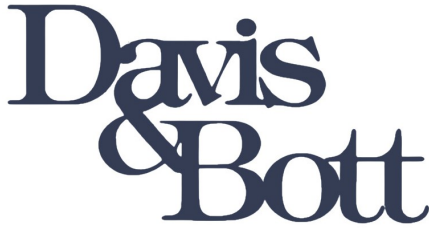

NOTE A. DESCRIPTION OF PLAN

The following description of the Associated Brigham Contractors, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of the Company who are not leased. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to 60 percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant contributions are matched by the sponsor at 100 percent of the first 3 percent of compensation contributed, and 50 percent of the next 2 percent of compensation. The sponsor may also make discretionary contributions to the Plan. Contributions are subject to certain limitations. All contributions are made in cash. Effective March 1, 2022, the plan was amended to allow Roth contributions.

Participant accounts. Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. There is immediate 100 percent vesting in the Company's matching contributions.

Investment options. Upon enrollment in the Plan, a participant may direct employee contributions in any of over 35 investment options.

Participants may change their investment options at any time.

NOTE A. DESCRIPTION OF PLAN (CONTINUED)

Funding. Employee contributions are generally sent to the Plan within a couple of days of amounts being withheld from employees. Employer contributions, if any, are transmitted annually by the filing date, including extensions, for the Company's federal income tax return.

Notes receivable from participants. Participants may borrow from their account. Participants are permitted to have only one loan outstanding at any one time and the maximum loan amount available is \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or one-half of a participant's vested account balance in the Plan, whichever is less. No loans are issued for less than \$1,000. Loan terms range from 1-5 years and may range from 1-10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prevailing rate. Principal and interest is paid ratably through payroll deductions.

Payment of benefits. In service withdrawals are allowed for qualified hardship as well as attainment of age 59 $\frac{1}{2}$. On termination of service, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over his or her life expectancy.

Plan expenses. Most of the expenses of the Plan are paid for by the Plan sponsor.

Date of Management's Review. Subsequent events were evaluated through June 26, 2025, which is the date the financial statements were available to be issued.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting. The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment valuation and income recognition. The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits. Benefits are recorded when paid.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the year then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The carrying values of receivables, if any, included in the accompanying statement of net assets available for benefits approximated fair value at December 31, 2024 and 2023, and are, therefore, not included in the following table:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consists of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 1 fair value measurements. Investments in regulated investment companies and money market funds are reported based on quoted prices in active markets.

NOTE E. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.
