## Independent Auditor's Report

To the Lord Abbett & Co. LLC Retirement Plan Committee

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

*Supplemental Schedules Required by ERISA*

The supplemental schedule of assets (held at year end) and schedule of delinquent participant contributions as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of the Plan

The following description of the Lord Abbett 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering employees of Lord Abbett & Co. LLC (the "Company"), a Delaware limited liability company. The Company established the Plan effective October 1, 1973 to provide retirement benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Lord, Abbett & Co. LLC Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan adopted the Merrill Lynch prototype Non-Standardized Profit Sharing Plan and Trust. The Plan's trustee is Bank of America, N.A. (the "Trustee") and the Plan's recordkeeper is Merrill Lynch Pierce Fenner and Smith, Inc.

#### *Contributions*

Each year, participants may contribute up to 60% of annual compensation to the Plan on a pre-tax basis to the extent permitted under Internal Revenue Code Section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a Roth 401(k) deferral. For participants that elect to make a Roth 401(k) deferral, such deferrals are subject to income taxes in the year of the deferral. In order for earnings to be distributed tax-free, they must be qualified. An individual is eligible to contribute to the Plan after the first day of the month following the completion of one month of service. An individual will be enrolled in the Plan automatically at a pre-tax contribution of 3% of the employee's compensation. An individual's pretax contributions will automatically increase by 1% per year until the pre-tax contribution equals 15% of the employee's compensation. The default investment for participants who are automatically enrolled is a managed account offered through the Advice Access program sponsored by an affiliate of the Plan's recordkeeper "PersonalManager™." The participants automatically enrolled in Advice Access have the ability to opt out of the program.

An individual is eligible to receive an employer match after completing one month of service. The amount of the employer match is determined by the Company each year. For the year ended September 30, 2024, the Company matched \$1 for every dollar contributed up to 2.5% of eligible compensation not to exceed the Plan's eligible compensation limit of \$170,000.

The Plan also provides for a 3% safe harbor contribution for each participant, as well as an additional discretionary employer contribution for employees who have completed one year of service. The discretionary employer annual contribution was 2% for the Plan year ended September 30, 2024. A participant must be employed on the last day of the Plan year in order to receive the discretionary employer annual contribution.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, allocation of the Company's matching, safe harbor and discretionary contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are vested immediately in their contributions and 3% safe harbor contributions made by the employer plus the actual earnings thereon. Vesting in the Company's discretionary contributions and the employer match is based on years of continuous service. A participant is 100% vested after three years of credited service.

### *Notes Receivable from Participants*

Effective October 1, 2015, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant having a vested benefit of \$1,000 or less will receive a lump-sum distribution of his/her vested benefit. On termination of service due to death, disability or retirement, a participant having a vested benefit greater than \$1,000 may elect either a lump-sum distribution at any time prior to age 65, or defer distribution of his/her vested benefit until the earlier of attaining age 65 or death.

A nonspouse beneficiary can elect to have eligible rollover distributions made in the form of a direct trustee-to-trustee transfer from the Plan to an Individual Retirement Account. The time period to elect the manner of payment for a distribution is extended for up to a 180-day period.

### *Forfeited Accounts*

At September 30, 2024 and 2023, forfeited nonvested amounts totaled \$166,019 and \$138,242, respectively. Forfeitures will be used first to reduce employer contributions. Any remaining forfeitures will be used to offset administrative expenses. Forfeited amounts of \$133,256 were used to reduce employer contributions for the Plan year ended September 30, 2024.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Administrative Expenses*

Certain administrative expenses of the Plan may be paid by the Plan through a "service based" pricing arrangement with the service provider. Under this arrangement, revenue paid to the service provider by mutual funds in which participant accounts are invested is used to pay for Plan services at rates the Company has negotiated with the service provider. The Company pays the balance of the Plan's administrative fees. If and to the extent that the total compensation the mutual funds pay the service provider exceeds the service provider's fees, the Plan may use such excess to: (1) pay certain Plan expenses (to the extent legally permitted); and/or (2) credit the participants' accounts. During the Plan year ended September 30, 2024, the Plan received a credit in the amount of \$140. As of September 30, 2024 and 2023, the Plan had an unused credit in the amount of \$811 and \$670, respectively.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### *Payment of Benefits*

Benefits to participants are recorded when paid.

### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### *Subsequent Events*

The Plan has evaluated subsequent events through June 24, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

**Self-directed brokerage account:** Account consists mostly of mutual funds that are valued on the basis of readily determinable market prices. Accounts also consist of cash and certificates of deposit funds which are valued at fair value by discounting the related cash flows based on current yield of similar instruments with comparable duration considering the credit worthiness of the issuer.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

For year ended September 30, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

#### 4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were invested in funds managed by the Company, which are included within the self-directed brokerage account. Therefore, some Plan investment transactions qualify as party-in-interest transactions. In the normal course of business, certain officers and employees of the Plan sponsor (who may also be participants in the Plan) perform administrative services related to the Plan's operations, recordkeeping and financial reporting. The Company pays these individuals' salaries and pays for a portion of other administrative expenses on the Plan's behalf. The forgoing transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory and administrative exemptions for the Internal Revenue Code ("Code") and ERISA's rules on prohibited transactions.

#### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### 6. Tax Status

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedures 2012-6 and 2011-49, the Plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. The Plan administrator believes the Plan is being

operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Certified Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at September 30, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended September 30, 2024, that are disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

### **9. Nonexempt Transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan transactions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the year ended September 30, 2024.
