Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Glass Lewis 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Notes to Financial Statements

1. Description of the Plan

The Glass Lewis 401(k) Plan (the Plan) was established by Glass, Lewis & Co. LLC (the Company), effective January 1, 2005, to provide retirement benefits and tax-deferred savings opportunities to eligible Company employees. The following description of the Plan, as amended and restated effective April 1, 2022, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan with a salary deferral arrangement qualified under the appropriate provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a Retirement Plan Committee, which comprises Company employees, and is responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus Trust Company (Ascensus) is the Plan's trustee and record keeper. Ascensus holds, invests and reinvests Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Employees, as defined by the Plan agreement, who have attained age 21, may become participants and are eligible to receive matching contributions on the first day of the month following the completion of four months of service. Participants employed at the end of the Plan year become eligible to receive Company discretionary non-elective contributions after completing one year of service from their date of hire.

Contributions:

Participants may contribute a percentage of their pre-tax or Roth after-tax annual compensation, as defined under the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make a matching contribution in an amount determined annually by the Company's Strategic Committee. Matching contributions are made based on a participant's annual salary deferral contributions. The Strategic Committee may also elect to make additional discretionary non-elective contributions to the Plan. The Company made matching contributions of \$316,201 to the Plan in 2024, of which \$30,438 was receivable at year-end. These contributions represent 50% of a participant's deferral contributions, up to a maximum of 3% of eligible gross annual compensation.

Participant Accounts:

Participant accounts comprise a salary deferral account, Company contribution account and, where applicable, a rollover account. Participant's accounts are credited with participant contributions, Company matching and any non-elective contributions, and earnings or losses. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are immediately vested in their contributions, plus actual earnings (less any losses) thereon. Company contributions, plus actual earnings (less any losses) thereon, become 25% vested after one year of service and 25% per year thereafter, and are fully vested after four years of service, or upon death, disability or reaching age 65.

Forfeitures:

The forfeited, non-vested portion of terminated participant account balances may be used to reduce Company contributions or to pay Plan expenses. There was no balance in the forfeiture account at December 31, 2024 and 2023, respectively. In 2024, forfeitures of \$12,122 were used to pay Plan expenses.

1. Description of the Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement. Note receivable transactions with participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participants are allowed to have two notes outstanding at any time. Participant notes are evidenced by a written note, bear a rate of interest equal to the prime rate published by The Wall Street Journal plus 1%, and collateralized by the vested participant account balance. The two notes outstanding at December 31, 2024 have interest rates of 9% and 9.25%. Repayment of principal and interest is typically made through payroll deductions

Payment of Benefits:

Benefits are recorded when paid. Upon termination, participants may elect to receive an amount equal to the value of their vested account balances. Benefits are paid in a lump sum payment or in installments, if elected by the participants. Vested account balances of less than \$5,000 may be paid in a lump sum payment without participant consent.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses:

Several of the investment fund options are subject to fees based on a percentage of invested assets, as disclosed in each fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain administrative costs, as determined by the Company, are charged to the Plan and paid from Plan assets. The Company pays all other expenses related to the Plan, which are not reflected in the Plan's financial statements. In 2024, forfeitures of \$12,122 were used to pay Plan expenses.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions will be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments consist of mutual funds, and a money market fund. These funds are valued at fair value using the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement: (continued)

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

4. Income Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Company believes the Plan is being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust, which forms a part of the Plan, is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, at December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Subsequent Events

Subsequent events have been evaluated through, July 1, 2025, which is the date the financial statements were approved by the Plan and available to be issued.
