Basis for Opinion

Notes to Financial Statements

September 30, 2024

Note 1 – Description of Plan

The following description of Black River Area Development Corp. 401(k) Plan (the plan) provides only general information. For a more complete description of the plan's provisions, participants should refer to the plan document and *Summary Plan Description*, which are available from the plan administrator. The Plan was most recently amended effective October 1, 2023, to adopt the Standard Retirement Services, Inc.'s ("The Standard") Defined Contribution Pre-Approved Plan.

- A) **General.** The Plan was established October 1, 2008. The Plan is a defined contribution plan covering all eligible employees of Black River Area Development Corporation (the Employer) who are age eighteen or older. On October 1, 2023, the Plan changed third-party administrators and adopted the Defined Contribution Pre-Approved Plan of The Standard. The board of directors of Black River Area Development Corporation controls and manages the operations and administration of the Plan. The Board reviews the plan performance and investment options periodically. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B) **Contributions.** Participants may contribute to the Plan by entering into a salary reduction agreement. Each year participants may contribute at least 1% but no more than 100% of their compensation, as defined in the plan, subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common trust funds, and a guaranteed contract. The Organization contributes a match equal to 200% of the participant's contributions that do not exceed 3% of participant's compensation received during the plan year. Additional profit-sharing amounts may be contributed at the option of the Organization's board of directors. Contributions are subject to certain limitations.
- C) **Participant accounts.** Each participant's account is credited with the participant's contributions, allocations of employer contributions, and plan earnings less administrative expenses. All accounts reflect the total amount of contributions allocated to such accounts and the earnings thereon, any payments or withdrawals on the participant's behalf from such accounts and any expenses of such accounts attributable to the participant's interest therein. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D) **Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus any earnings they generate is based on years of continuous service. A participant is 100% vested after five years of credited service. A participant will also become fully vested upon death, disability, or at age 55.
- E) **Participant loans.** Participant loans are not permitted under the Plan.
- F) **Payment of benefits.** Upon termination, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount or various annuity options. In-service distributions from a participant's account attributable to salary reduction contributions are permitted after a participant's attainment of age 59 1/2 or due to hardship.

G) **Forfeited accounts.** All forfeitures under the plan shall be held in a suspense account and first used to restore forfeited balances of reemployed participants, then to reduce administrative expenses of the plan and last, to reduce employer contributions. At September 30, 2024 and 2023, there were \$73,065 and \$-0-, respectively, in the forfeiture accounts. In 2024, employer contributions were reduced by \$2,718 from forfeited nonvested amounts.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are reported at fair value with the exception of the guaranteed contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The fair values of the registered investment company accounts (mutual funds) are computed using closing prices on nationally recognized stock exchanges or over-the-counter markets. Fair value of shares of the underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

The Plan holds a fully benefit-responsive group annuity contract with Standard Insurance Company. The contract is designed to provide principal preservation and a guaranteed minimum interest rate to participants. The group annuity contract is backed by the general account of Standard Insurance Company and is included in the financial statements at contract value, which represent contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Under the terms of the contract, participant-initiated transactions are permitted at contract value for events such as benefits paid upon retirement, termination of employment, hardship withdrawals, and death. Standard Insurance Company guarantees to pay the principal and interest credited to participants' accounts at the contract interest rate. The fair value is determined based on the present value of expected future cash flows, discounted at a rate commensurate with the risks involved and using relevant observable bond yield indices when applicable. As the contract is fully benefit-responsive, fair value is generally equivalent to contract value under plan operation. The investment offered under the group annuity contract is the Standard Stable Asset D.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the plan are paid by the plan sponsor. Total fees paid by the Plan for the plan year ended September 30, 2024, were \$28,461. These fees are included in plan deductions. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The plan administrator has evaluated events through June 18, 2025, the date the financial statements were available to be issued. The plan administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

Note 3 – Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and certified that the plan qualifies for a Section 103(a)(3)(C) audit. Accordingly, as permitted under such election, the following investment information was certified by Reliance Trust and The Standard; the custodian and third-party administrator respectively, and was not subjected to any auditing procedures performed by the independent public accountants.

- A) Total investments as shown in the accompanying statements of net assets available for benefits of \$3,833,213 as of September 30, 2024.
- B) Net investment income including appreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for benefits of \$617,319 for the year ended September 30, 2024.
- C) All investment-related information in the accompanying supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of September 30, 2024.

The Plan changed custodians on October 1, 2023, from Mutual of America Life Insurance company to Reliance Trust Company. The following investment information was certified by Mutal of America Life Insurance Company and was not subjected to any auditing procedures performed by independent public accountants.

- A) Total investments as shown in the accompanying statements of net assets available for benefits of \$3,072,551 as of September 30, 2023.

During the plan year ended September 30, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$559,320.

Participants direct the custodian regarding the investment of amounts held in their accounts.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs used for valuing assets are not an indication of the risk associated with investing in those assets.

Following is a description of the valuation methodologies used for assets measured at fair value. Changes in methodology occurred due to the change in third-party administrators and the composition of assets in the plan.

Mutual funds (Registered Investment Companies): Valued at the daily closing price as reported by the fund. Mutual funds are registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

Common trust funds: Composed of assets that are either priced by a pricing service or directly by the relevant mutual fund company trading partner.

Guaranteed contracts: Valued at contract value determined using unobservable inputs based on information supplied by the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The guaranteed contract is classified within Level 3 of the fair value hierarchy under Accounting Standards Codification (ASC) 820, because the fair value is determined using unobservable inputs and is based on information supplied by the issuer. The fair value of the group annuity contract approximates the contract value under normal circumstances because participants are permitted to receive benefits at contract value. However, if the Plan were to initiate a mass withdrawal or termination of the contract, Standard Insurance Company could invoke a Market Value Adjustment, which would adjust the amount paid to the Plan based on prevailing bond market conditions at the time of the withdrawal.

Note 5 – Investment Contract with Insurance Entity

The Plan has a fully benefit-responsive group annuity contract with Standard Insurance Company. The contract is designed to provide principal preservation and a guaranteed minimum interest rate to participants. The group annuity contract is backed by the general account of Standard Insurance Company and is included in the financial statements at contract value, which represent contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Under the terms of the contract, participant-initiated transactions are permitted at contract value for events such as benefits paid upon retirement, termination of employment, hardship withdrawals, and death. Standard Insurance company guarantees to pay the principal and interest credited to participants' accounts at the contract interest rate. The average yield credited to participants during the plan year was 1.87%. The minimum guaranteed interest rate under the contract is 1.00% per annum.

Note 6 – Operational Error Related to Participant Vesting and Forfeitures

During the plan year ended September 30, 2024, the Plan Sponsor identified an operational error related to the application of vesting provisions under the plan document. Specifically, several participants who had previously terminated employment and whose account balances were distributed during the current plan year were incorrectly treated as partially non-vested in employer contributions, resulting in an overstatement of forfeitures and an understatement of the participants' distributions.

In accordance with the Plan's vesting schedule, the participants should have been entitled to a greater portion of employer contributions than was allocated. The error resulted in a portion of employer contributions being improperly forfeited and excluded from the participants' distributions.

The Plan Sponsor has initiated corrective action to restore the affected participants' accounts to the correct vested balances, including estimated earnings, in accordance with the Internal Revenue Service's Employee Plans Compliance Resolution System (EPCRS).

The Plan Sponsor has reviewed internal controls related to the administration of vesting provisions and has implemented process improvements to prevent similar errors in the future. At this time, the Plan Sponsor believes this issue was isolated and does not represent a systemic compliance failure.

Note 7 – Party-in-Interest Transactions

The Plan incurs expenses related to general administration and recordkeeping. The Plan Sponsor pays these expenses and certain accounting and auditing fees relating to the plan. Plan management believes the Plan has no agreements or transactions with parties-in-interest that are prohibited under ERISA Section 3(14).

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note 9 – Plan Tax Status

The Plan Sponsor has adopted a non-standardized defined contribution plan as offered by The Standard. The Plan was most recently restated effective October 1, 2023. The Plan has received an opinion letter dated June 30, 2020, stating that the plan and trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended and restated subsequent to the date of the opinion letter, the Plan Sponsor believes the plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. As of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal form 5500 is generally open for examination by the federal taxing authority for a period of three years after the filing date or after the return due date, including all approved extensions. There were no tax audits in process at September 30, 2024 or 2023.

Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
