## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Teamsters Local 922 - Employers Health Trust

### Opinion

We have audited the accompanying financial statements of Teamsters Local 922 - Employers Health Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of September 30, 2024 and 2023, and the changes in its net assets available for benefits and in its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.



### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED SEPTEMBER 30, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of Teamsters Local 922 - Employers Health Trust (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

**General** - The Plan was organized in October 1979 under an agreement between Teamsters Local 922 and participating employers. The agreement provides for employer and employee contributions for members of Teamsters Local 922. The Plan provides medical, AD&D, long-term care, dental, and vision for members of participating employers covered by collective bargaining agreements, as specified in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Contributions to the Plan are made by individual employers under the provisions of a collective bargaining agreement and, under certain conditions stipulated in the Plan, employees may qualify to contribute on their own behalf.

**Benefits** - The Plan provides hospitalization, physician's care, dental, vision, disability, accidental death and dismemberment, and life benefits to eligible participants and their dependents in accordance with the Plan document. Benefits are recorded when paid by the Plan. The Plan is self-insured.

**Termination** - In the event the Plan is terminated, the Board of Trustees (Trustees) shall use any remaining funds to satisfy existing and arising claims for benefits under the terms of this Plan and to pay reasonable administrative expenses until such funds are exhausted.

**Stop Loss** - The stop loss insurance held by the Plan pays on claims over \$250,000 per individual. During the fiscal years ended September 30, 2024 and 2023, the Plan paid \$350,521 and \$282,364, respectively, in stop loss premiums. During the fiscal years ended September 30, 2024 and 2023, the Plan received \$159,499 and \$1,446,238, respectively, in stop loss reimbursements that are included in health care benefits expense in the statements of changes in net assets available for benefits.

**Other** - The Plan's Trustees, as Sponsor, have the right under the Plan to modify the benefits provided to members. The Plan may be terminated only by joint agreement between industry and union, subject to the provisions set forth in ERISA.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, incurred but not reported (IBNR), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Employer Contributions Receivable** - Accounts receivable are stated at the amount the management expects to collect from balances outstanding at year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by its investment advisers. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Reclassifications** - Certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

**Concentration of Credit Risk** - Financial instruments that potentially subject the Plan to concentrations of credit risk consist primarily of cash. The Plan currently holds cash with one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single financial institution. As of September 30, 2024, the Plan had a balance in excess of federally insured limits of approximately \$4.9 million.

**Administrative Expenses** - Administrative expenses are paid by the Plan.

**New Accounting Pronouncement Adopted** - During the year ended September 30, 2024, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The ASU requires nonprofit entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including employer



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

contributions. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events. The Plan adopted the ASU effective October 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

## NOTE 3. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Short-term investments:* Valued at cost which approximates fair value.

*U.S. Government agencies notes and bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities.

*Registered investment companies:* Stated at fair value which represents publicly quoted market prices as of the last business day of the year.

### NOTE 4. POSTRETIREMENT BENEFIT OBLIGATIONS

Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to participants' service rendered to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for 1) currently retired or terminated employees and their beneficiaries and dependents, and 2) active employees and their beneficiaries and dependents after retirement from service with the participating employers.

The actuarial present value of the expected postretirement benefit obligations is determined by an independent actuary and is that amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The actuarial present value of the expected postretirement benefit obligations is net of the actuarial present value of estimated future contributions, for postretirement benefits, expected to be received from participants based on the terms of the Plan document.

## NOTE 4. POSTRETIREMENT BENEFIT OBLIGATIONS (CONTINUED)

The Plan's actuaries, Bolton Partners, Inc., prepared the postretirement benefit obligation valuation for the fiscal years ended September 30, 2024 and 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

**Claims Incurred but Not Reported** - Plan obligations at September 30, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's management based upon the historical experience of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payments.

## NOTE 5. INCOME TAX STATUS

The Internal Revenue Service (IRS) has made a favorable determination on the Plan's tax status and has notified it that it is exempt from federal income taxes pursuant to Internal Revenue Code (IRC) Section 501(c)(9). The Plan sponsor believes that the Plan, as amended continues to qualify and to operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 6. LITIGATION

Based on the advice of Plan Counsel, there is no litigation, either pending or threatened, which would have a material adverse effect on the Plan's financial position.



## NOTE 7. SIGNIFICANT PLAN AMENDMENTS

There were no plan amendments during fiscal years ended September 30, 2024 and 2023.

Claims that have been processed and approved for payment at year-end, but not paid and claims incurred but not reported are not considered liabilities under GAAP and, therefore, are not presented as liabilities or claims paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

## NOTE 9. RISKS AND SIGNIFICANT UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.



## **NOTE 10. PARTY IN INTEREST TRANSACTIONS**

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. In addition, Morgan Stanley Smith Barney is the investment custodian for the Plan. These transactions are party in interest transactions under ERISA.

## **NOTE 11. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through June 23, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed a subsequent assessment of participant co-pays of \$353,659 and employer interest and liquidated damages of \$136,245. The probability of collection of these amounts is not known as of the date of this report and therefore no adjustment to or disclosure have been made to the accompanying financial statements.


