Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the AMPAC Fine Chemicals LLC Bargaining Unit 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, of Form 5500, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of September 30, 2024 presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Plan Description

The following description of the AMPAC Fine Chemicals LLC Bargaining Unit 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, as restated, for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan open to employees of AMPAC Fine Chemicals, LLC (the Company), a participating employer in the Plan, who are members of a collective bargaining unit.

The Plan was amended to conform with the Setting Every Community Up for Retirement Enhancement Act (the SECURE Act) which was passed into law in December 2019. Certain changes were made to the Plan in regard to the SECURE Act. The Plan now requires complete distributions to some beneficiaries of deceased participants within 10 years after death. Additionally, distributions to a participant must generally begin by April 1 of the calendar year following the year the participant turns age 72 (or, in some cases, when the participant retires, if later). Certain beneficiaries of participants who died during the years 2015 to 2019 were required to take distribution of their benefits by December 31 of the 5th year following the year the participant died. These participants can extend the distributions by one year. The Plan does not exclude part-time employees, but the Plan document was updated to comply with the expanded coverage of long-term part-time employees if the Plan so elects.

In December 2022, as part of the Consolidated Appropriations Act of 2023, SECURE 2.0 was passed into law. The Plan now allows participants who have attained ages 60 to 63 during the calendar year to defer a higher catch-up contribution of \$11,250 instead of \$7,500. In addition, the Plan now allows for participants to take distributions for qualified disaster relief if a participant is affected by a federally declared disaster. The qualified disaster relief distributions are exempt from the 10% early distribution tax penalty and may have the option to repay the distribution within three years. SECURE 2.0 allows Plans to adopt these provisions prior to the Plan being amended to include these Plan provisions in the Plan documents.

Employees are eligible to participate in the month following date of hire and are allowed to enter the Plan the first day of the month coinciding with or next following the date the eligibility requirements are satisfied.

Empower Trust Company, Empower Retirement LLC and certain affiliates serve as the trustee, custodian and recordkeeper (collectively Empower). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Fiduciary Committee is responsible of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

At times, employees change roles within the Company between bargained positions and salaried positions. For the year ended September 30, 2024, there were no participants who transferred their funds between Salaried and Bargaining plans.

Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Service (IRS). In addition, the Plan allows for catch-up contributions by participants 50 years and older before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan's provisions. For the year ended September 30, 2024, there was no incoming rollovers.

In addition to participant contributions, employees who are actively accruing credited monthly service within the Bargaining Pension Plan are eligible to receive a fixed matching contribution of 100% of the first 4.5% of compensation that is electively deferred. Employees who are not actively accruing credited monthly service with the Bargaining Pension Plan will be eligible to receive a fixed matching contribution of 100% of the first 6% of compensation that is electively deferred. For the year ended September 30, 2024, the Company made matching contributions of \$918,461.

In addition, the Company may make profit-sharing contributions at the Company's discretion. There were no discretionary profit-sharing contributions made for the Plan year ended September 30, 2024.

Participants direct the investment of their contributions, Company matching contributions and Company discretionary profit-sharing contributions into various investment options offered by the Plan. The Plan offers various mutual funds and a stable value fund as investment options for participants. Contributions are subject to certain IRS limitations.

Participants Accounts

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, the Company's matching contribution, the Company's discretionary profit-sharing contribution, Plan earnings, and is charged with benefit payments and an allocation of administrative expenses (loan and withdrawal fees). The allocations above are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, rollover contributions and Company matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution is based on years of continuous service. A participant vests 20% per year from years two through six of credited service. A participant's interest in the Plan becomes fully vested if employment terminates due to death, total and permanent disability or retirement at age 65.

Notes Receivable from Participants

In accordance with the provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between participant-directed investments and notes receivable from participants.

Loan terms range from one to five years or up to twenty years for the purchase of a primary residence. The loans are collateralized by the participant's vested balance in the Plan and bear

interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions. Outstanding notes receivable from participants totaled \$1,343,289 and \$1,286,095 at September 30, 2024 and 2023, respectively.

Payments of Benefits

Upon termination of service, due to death, disability, or retirement, a participant (or their beneficiary) may elect to receive the vested value of their account. If the vested value of a participant's account is less than \$1,000, his or her account will be distributed in a lump-sum payment. If the vested value of a participant's account exceeds \$1,000, he or she may elect to (i) receive a lump-sum amount or substantially equal payments over a specified term, (ii) elect to have all of the distribution paid in a direct rollover to another qualified employer plan or an individual retirement account, or (iii) a combination of the above. In certain circumstances, an in-service distribution is allowable under the Plan at the request of an employee.

Forfeitures

Forfeited amounts may be used to reduce employer contributions or pay plan expenses. For the year ended September 30, 2024, no forfeitures were used to reduce expenses. There was no forfeiture balance as of September 30, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies

utilizing information provided by the investment advisers and/or custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions

Participant contributions and any related employer fixed matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are classified as distributions on the basis of the terms of the Plan document. During the year ended September 30, 2024, delinquent loans of \$1,493, were classified as distributions.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. Fees related to the participant requested services and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment fees are based on a specified basis point per investment through the investments' earning from participants' accounts. Investment fees are included in net appreciation/ (depreciation) in fair value of investments.

Empower provides certain recordkeeping services to the Plan and receives revenue for such services. A portion of this revenue is paid directly to Empower, and a portion is allocated to the Plan expense account. The Plan may elect to pay Plan administrative expenses from this account. Any excess amounts not applied to the Plan administrative expenses may be re-allocated to the accounts of the participants in the event the expenses are not utilized by the Plan prior to the last day of the Plan year following the Plan year in which the allocation occurs. At September 30, 2024 and 2023, the Plan expense account balance totaled \$12,726 and \$7,093, respectively. For the year ended September 30, 2024, \$31,718 was applied against Plan administrative expenses.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level: 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level: 2 - This level consists of inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level: 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund

The Great Gray T. Rowe Price Stable Value Fund is a collective trust which is invested in the T. Rowe Price Stable Value Common Trust Fund. The stable value fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. There are no unfunded commitments

related to these investments. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The issuer also requires five business days' notification for large trades greater than \$1 million. This is a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related information included in the financial statements and ERISA-required supplemental schedule.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

6. Income Tax Status

The Plan was adopted from a non-standardized pre-approved plan document by Empower. The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020 that the pre-approved plan, as then designed, satisfies the applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since the date of the opinion letter, the Plan administrator and the Plan's management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision or liability for income taxes has been included in the financial statements.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no examinations for any tax period in progress.

7. Related Party and Party In-Interest Transactions

Expenses paid by the Plan to the custodian and to third-party administrator to manage investments during the year qualify as party-in-interest transactions. Fees for notes receivable from participants and distributions are also considered exempt party-in-interest transactions. The notes receivable are secured by the vested balances in the participants' account. For the year ended September 30, 2024, fees paid by the Plan for the investment management services and recordkeeping services amounted to \$40,726 and \$28,806 respectively.

8. Subsequent Events

The Plan has evaluated subsequent events through June 23, 2025, the date the financial statements were available to be issued.
