Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Boeing Intelligence & Analytics 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Boeing Intelligence & Analytics 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution 401(k) profit sharing plan covering all eligible employees of Boeing Intelligence & Analytics (the Company or BI&A). Employees who are not part of an excluded class become eligible to participate immediately upon attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration – Fidelity Management Trust Company (Fidelity) is the custodian and trustee of the Plan.

Contributions – Contributions to the Plan are in the form of salary reductions, which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 85% of their eligible compensation. Participants aged 50 or older are allowed to make catch-up contributions. Participants may elect to change contribution percentages to be effective the beginning of the next pay period after the request is received or as soon as administratively possible. The allocation of both their contributions and employer contributions to the Plan may be changed at any time and become effective on the day of the change or on the next business day, based on the day and time the request for a change is made in relation to the stock market close of business. The Plan allows active employees to contribute to the Plan from pretax compensation, after-tax compensation for Roth contributions, or a combination of both pretax and after-tax compensation. The Plan also accepts certain rollover contributions.

Under the terms of the Plan, the Company makes non-elective safe harbor contributions to the Plan equal to 3% of each eligible participant's eligible compensation. In addition, the Company may make discretionary non-elective contributions as determined by the Company's Board of Directors. During the year ended December 31, 2024, the Company made contributions of 7% of each participant's eligible compensation as discretionary contributions.

Participant accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) from the funds in which the account is invested. Participant accounts are charged with an allocation of certain administrative and investment-related expenses and participant-specific charges, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are fully vested in their rollover, elective, and safe harbor contributions allocated to their accounts, including accumulated earnings. Participants hired prior to February 1, 2008, are 100% vested in the discretionary contributions allocated to their accounts. Participants hired on or after February 1, 2008, vest in the discretionary contributions allocated to their accounts according to the following schedule:

Forfeitures – Forfeitures are the nonvested portions of a participant's account that are lost upon termination of employment. Forfeitures occur when a participant receives a distribution of their entire vested account or, if the participant does not receive a distribution, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and may be used to reduce future Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,346 and \$74,343, respectively. During the year ended December 31, 2024, \$336,700 in forfeitures was used to reduce Company contributions.

Withdrawals – Participants may elect to withdraw all or a portion of their vested account balance at any time on or after the day they attain age 59-1/2. If a participant is under age 59-1/2, withdrawals from pretax contribution accounts and Roth contribution accounts are subject to certain hardship rules as provided by the Plan. Vested discretionary contributions may be fully withdrawn upon termination of employment. Withdrawals of rollover contributions can be made at any time.

Notes receivable from participants – Participants are permitted to borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance at the time of the loan issuance and may have no more than two loans outstanding at any time. Loans may be further limited in accordance with Plan provisions. The interest rate on new loans is set every month based on the prime rate plus 1% as published by Reuters as of the close of business on the last business day of the calendar month immediately preceding the date of the loan. Interest rates on outstanding loans ranged from 3.25% to 8.50% at December 31, 2024, with loans maturing at various dates through August 2034.

Loan repayments are made through regular payroll deductions for a period of up to 60 months for general loans and over a longer period for loans used to finance the purchase of a principal residence. If a participant's employment terminates for any reason, and the loan balances are not paid in full by the termination date, the participant may continue to make monthly loan repayments until the loan is scheduled to be paid off. A loan will continue to be subject to default if a payment has not been made for 90 days, an outstanding loan balance remains 30 days after the scheduled payoff date, or the participant takes a full distribution of their account before the loan is paid off. If the loan defaults, the loan balance will become taxable income to the participant.

Benefit payments – On termination of service, a participant may elect to receive a lump sum amount equal to part or all of the value of the participant’s vested account balance, receive partial withdrawals, roll the account balance to another company’s qualified plan or an individual retirement account, or defer distribution until a later date (if the balance exceeds \$7,000).

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties – The Plan’s investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the financial statements.

Valuation of investments and income recognition – The Plan’s investments are stated at fair value. The Plan’s custodian and trustee, Fidelity, certifies the fair value of all investments. If available, quoted market prices are used to value investments. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Investments in the Plan are valued as follows:

Mutual funds and money market fund – Mutual funds and the money market fund held by the Plan, which are open-end funds registered with the U.S. Securities and Exchange Commission, are valued at the daily closing prices reported by the respective funds, reflecting the daily net asset value (NAV) at which these actively traded funds transact.

Collective trust fund – Units held in the collective trust fund are valued using the NAV of the fund as reported by the fund manager. The NAV is based on the fair value of the underlying assets owned by the collective trust fund, minus its liabilities, and then divided by the number of units outstanding.

Purchases and sales of securities are recorded on a trade-date basis, and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Necessary and proper expenses of the Plan are paid from the Plan's assets, except for those expenses the Company is required by law or chooses to pay.

Subsequent events – The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 – Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

Level 3 – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Plan is based on a non-standardized pre-approved defined contribution profit sharing plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 7 – Party-in-Interest Transactions

The Plan invests in shares of mutual, money market, and collective trust funds managed by affiliates of Fidelity. Therefore, these transactions qualify as exempt party-in-interest transactions.
