## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of MidSouth Satellite LLC 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MidSouth Satellite LLC 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 - Description of Plan**

The following description of the MidSouth Satellite LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan, as adopted January 1, 2016 and restated January 1, 2023, covering all employees of MidSouth Satellite, LLC (collectively the “Company”), who have met the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified retirement plans. Each year, the Company can make discretionary matching and non-elective contributions to the Plan. All investments are participant directed.

Newly eligible participants that have otherwise satisfied the eligibility requirements to participate in the Plan but have not made a salary deferral election or affirmatively elected in writing not to participate in the Plan are automatically enrolled. In 2024, new participants were enrolled at a rate of 4% of eligible compensation with no annual increase.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s discretionary matching contribution, (b) the Company’s discretionary non-elective contribution, and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Vesting** - Participants are immediately vested in their voluntary contributions and rollover contributions, if any, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**Participant Loans** - The Plan includes a provision allowing eligible participants to borrow from their fund accounts, a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. Participants cannot have more than two loans outstanding. Loans for the purchase of a primary residence may exceed the five-year term as deemed by the Plan administrator. The loans are not secured by the balance in the participant’s account and bear interest at a rate of one percent above the Prime Rate. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

**Payments of Benefits** - Upon death, disability, or termination of service, participants with a vested account balance exceeding \$5,000 may elect to receive either a lump sum payment equal to the value of his or her vested account balance or installments over a period of time, not to exceed the participant’s life expectancy. Participants with an account balance up to \$1,000 are paid in a lump sum as soon as feasible. Participant accounts with a value greater than \$1,000 and not exceeding \$5,000 will be directly rolled over into an individual retirement account designated by the Plan administrator, unless the participant affirmatively directs the distribution of his or her vested account balance. In-service distributions are permitted if certain criteria are met.

**NOTE 1 - Description of Plan - Continued**

**Administrative Expenses** - All administrative expenses may be paid out of the Plan unless paid by the Company. During 2024, expenses were paid the by both the Plan and the Company.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55,305 and \$44,773, respectively. These amounts will reduce future employer contributions and plan expenses. During 2024 and 2023, employer contributions and plan expenses were reduced by \$52,671 and \$27,025 from forfeited nonvested accounts, respectively.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable From Participants** - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through June 25, 2025, the date which the financial statements were available to be issued.

**NOTE 4 - Fair Value Measurements**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - Tax Status**

The Plan sponsor became a participating employer in a Non-Standardized Pre-Approved Profit Sharing Plan with CODA effective January 1, 2023, and is relying on its determination letter dated June 30, 2020. The Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe it is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions With Parties-in-Interest**

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan invests in a master cash account that is managed by Mid Atlantic Trust Company, a custodian of the Plan. In addition, the Plan allows participants to take out loans against their account balances and those activities are deemed party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 10 - Plan Termination**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.
