## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
Air Distribution Enterprises Inc. 401(k) Plan**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Air Distribution Enterprises Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

### 1. DESCRIPTION OF PLAN

The following description of the Air Distribution Enterprises Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on September 1, 1992, and most recently amended and restated as of January 1, 2022. The plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all employees of Air Distribution Enterprises Inc. (the “Company” or “Plan Sponsor”) and controlled affiliates, except union employees and nonresident aliens. Employees are eligible to make elective deferrals and receive safe harbor, non-elective and matching employer contributions upon attaining 21 years of age and completing six months of service. The effective date of participation for elective deferrals and safe harbor contributions is the first day of each calendar month of the Plan Year, coincident with or next following satisfaction of the eligibility requirements.

#### **Contributions**

The Plan allows pre-tax salary deferrals and roth contributions. Participants who have attained age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable.

The Company makes safe harbor contributions equal to 100% of a participant’s elective deferral that does not exceed 3% of compensation, plus 50% of the elective deferral that exceeds 3% of compensation but does not exceed 5% of compensation, as defined. For the year December 31, 2024, the Company made safe harbor contributions of \$418,493 to the Plan. The Company, at its discretion, may make non-elective and matching employer contributions to the Plan. For the year December 31, 2024, no non-elective contributions or matching contributions were made to the Plan. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant’s contributions and the Company’s safe harbor contributions, as well as an allocation of the Company's matching and nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided

from the participant's vested account. Participants direct their accounts into various investment options offered by the Plan. If no election is made by the participant, then the contributions are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"). The Plan has elected the American Funds Target Date Retirement Fund series as its QDIA.

### Vesting

Participants are vested immediately in their participant contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's non-elective and matching contributions portions of their accounts is based on years of continuous service as follows:

### Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate. The interest rates on outstanding loans range from 4.25% to 9.50% per annum. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to death, disability, retirement or for other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59½ or as a hardship distribution, as defined in the Plan document.

### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,238 and \$4,166, respectively. Forfeitures, if any, are allocated to reduce employer contributions or pay administrative expenses. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or pay administrative expenses.

### **Net Credit Account**

The Plan's recordkeeping service agreement with Capital Research and Management Company ("Capital Research") includes a Net Service Provider Credit provision, which provides income in situations where recordkeeping revenue earned in connection with Plan services exceeds agreed-upon compensation. Capital Research will deposit any excess revenue in an unallocated plan asset account ("Net Credit Account") in the plan. The Plan administrator can then use these amounts to pay qualified Plan expenses. For the year ended December 31, 2024, approximately \$11,003 in credits were earned by the Plan. For the year ended December 31, 2024, \$18,699 of credits were used to pay for Plan expenses. At December 31, 2024 and 2023, the Plan's Net Credit Account totaled \$3,472 and \$11,088, respectively.

### **Transfer from Other Plan**

Transfer from Other Plan represents the transfer of a participant's account balance due to a change in employment status. The participant's account and loan balance were transferred from the Custom Air Ventilation & Heating of Central FL 401(k) Plan.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation. Employer contributions from the Company are based off compensation paid to the participants during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

## **3. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the custodian of the Plan).

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Common Collective Trust***

Common collective trusts are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

#### **5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

American Portfolios Advisors is the investment advisor of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, fees of approximately \$38,900 were paid to American Portfolios Advisors.

Capital Research is the recordkeeper of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, fees of approximately \$100 were paid to Capital Research.

United Benefit Pensions Inc is the third party administrator of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, fees of approximately \$7,100 were paid to United Benefit Pensions Inc.

Lilling & Company LLP (“Lilling”) is the auditor of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, fees of approximately \$18,700 were paid to Lilling.

Participant contributions not transmitted by the Company within the time period set forth in the Department of Labor’s regulations CFR 2510.3-102 are considered nonexempt prohibited transactions under ERISA. Participant contributions remitted during the year that constitute nonexempt prohibited transactions are reported by the Plan in the accompanying supplemental schedule as required.

#### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **7. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
