Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hearsay Social, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 6, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the period January 1, 2024 to December 6, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Plan Termination

As further described in Note 3 to the financial statements, the plan sponsor authorized the termination of the plan effective July 31, 2024. All plan assets were subsequently disbursed on or before December 6, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented in the liquidation basis. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Hearsay Social, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan was established on January 1, 2011 by Hearsay Social, Inc. (the “Company”) to provide retirement benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. On August 1, 2024, the Company was acquired by Yext, Inc. In accordance with the acquisition agreement, the Plan was terminated with an effective date of July 31, 2024. Plan assets were disbursed to participants or rolled over to alternative retirement plans on or before December 6, 2024.

B. Plan Administration and Expenses

The Company designated Ascensus Trust Company to serve as directed trustee and third-party administrator responsible for maintaining participant records. Certain investment fund management fees and operating expenses are charged directly to the investment funds and are thereby factored into each investment fund as a reduction in investment return. Administrative fees for participant requested transactions including participant loan administration and benefit payment processing are charged directly to participants. Other costs incurred for administering the Plan are paid by the Company.

C. Eligibility

The Plan specifically excludes employees covered by a collective bargaining agreement, non-resident aliens, leased employees, temporary employees, interns, and contract employees. Substantially all other employees of the Company who have attained age 18 are eligible to enter the Plan immediately and those who do not make an alternative election will be auto-enrolled in the Plan at a 5% deferral rate upon satisfaction of eligibility requirements.

D. Contributions

Participants may elect to make pre-tax contributions to the Plan and/or elect to make Roth after-tax contributions. Each participant’s pre-tax deferrals and Roth contributions are subject to applicable Code limits. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Participants age 50 or older may elect to make up to \$7,500 of additional catch-up contributions in 2024. Participants are also allowed to make rollover contributions from other tax-qualified retirement plans.

The Company may make discretionary contributions as approved by the Board of Directors. No discretionary contribution was made for the 2024 Plan year.

E. Vesting and Forfeitures

Participants are immediately 100% vested as to voluntary contributions, rollovers and related earnings. Participants vest in Company discretionary contributions and related earnings as follows:

Forfeitures may be used to reduce administrative expenses and future Company contributions. There was no forfeiture balance as of December 6, 2024 or December 31, 2023 and no forfeitures used during the period January 1, 2024 to December 6, 2024.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions and the participant's share of Plan earnings or losses and expenses. Plan investments are based solely on participant directions. The contributions of auto-enrolled participants who decline to make an investment election are invested in the Vanguard Target Retirement Fund appropriate for the individual's age and projected date of retirement.

G. Payment of Benefits

Participants are eligible for benefits upon attainment of age 59½, retirement, disability or termination of service. Normal retirement age under the Plan is age 65. Participants may elect to receive benefits in a lump sum or partial payments. Hardship distributions are permitted under limited circumstances as provided by the Plan subject to the approval of the plan administrator. Benefits are recorded when paid.

H. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$5,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Such loans bear interest at available market financing rates and are secured by the participant's account balance. A loan must be repaid to the Plan within a five-year period unless the loan is used to acquire a principal residence in which case the repayment period may be extended. The plan administrator approves the specific terms and conditions of each loan. Principal and interest are paid ratably through payroll deductions.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Financial Accounting Standards Board (FASB) issued authoritative guidance that requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. As such, the financial statements are prepared on

A. Basis of Accounting (Continued)

the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The December 6, 2024 and December 31, 2023 financial statements are prepared on the liquidation basis of accounting in accordance with U.S. GAAP.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

The Plan holds a variety of investments, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PLAN TERMINATION

The Board of Directors of the Company authorized the termination of the Plan effective July 31, 2024, preceding the acquisition of the Company by Yext, Inc. Upon the effective date of plan termination each participants' account balance became 100% vested. The Plan continued to be administered in accordance with the Plan document until all assets were distributed or transferred. Plan assets were disbursed to participants or rolled over to alternative retirement plans on or before December 6, 2024.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments offered under the Plan are issued by the Vanguard Group, an affiliate of the trustee. Purchases and sales of these funds and payments of direct and indirect administrative and investment management fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements including investments held at December 6, 2024 and December 31, 2023, and net appreciation of investments, dividends and interest for the period January 1, 2024 to December 6, 2024 was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are based on quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at fair value based on closing market prices for the shares held by the Plan at year end. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date. The following table summarizes Plan investments at December 31 based on the inputs used to value them:
