INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Piedmont Community Actions, Inc. 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Piedmont Community Actions, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Piedmont Community Actions, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Piedmont Community Actions, Inc. 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Piedmont Community Actions, Inc. 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore it is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events considered in the aggregate that raise substantial doubt about Piedmont Community Actions, Inc. 403(b) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule labeled the Schedule of Assets Held for Investment Purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1) PLAN DESCRIPTION

The following description of Piedmont Community Actions, Inc. 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions:

General – The Plan is a single-employer defined contribution plan with a 403(b) arrangement. The Plan was established by Piedmont Community Actions, Inc. (“PCA” or “the Plan Sponsor”). The Plan was restated effective January 1, 2009, to comply with final 403(b) regulations.

Administration – The Plan is sponsored and administered by PCA, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The third-party administrator of the Plan is responsible for testing, vesting determinations, Form 5500 report, administration of distributable events, and record keeping. Voya Financial, Inc. (“VFI” or “the Trustee”) serves as trustee and custodian of the Plan’s assets at December 31, 2024 and 2023.

Participation – The Plan is a contributory, defined contribution plan with a 403(b)-arrangement covering all employees who are employed on a regular basis and work more than 1,000 hours annually. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participant Eligible Compensation – Participants’ compensation is calculated as gross wages, bonuses, overtime, and commissions.

Contributions – Each year, participants must contribute a minimum of 3.0% of pretax annual compensation, as defined in the Plan. Participants may contribute additional elective deferrals above the 3.0% minimum. Also, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 during a calendar year are eligible to make catch-up contributions. The Plan Sponsor contributes at the option of its Board of Directors, subject to certain limitations. Participants who are at least 21 years old become eligible for the Plan Sponsor’s contributions after 6 months of service. The Plan Sponsor’s contributions may be used to match a specified percentage of the compensation that a participant contributes to the Plan. Participants direct the investment of their contributions, and any related Plan Sponsor matching contributions, into various investment options offered by the Plan Sponsor.

Participant Accounts – Each participant's account is credited with the participant's contributions and rollover contributions, Plan Sponsor's contributions, and investment earnings. The benefit to which the participant is entitled is the benefit that can be provided by the participant's vested account.

Participant Loans – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$15,000 or 50% of their vested balance. The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 3.98% to 4.57%, which are commensurate with local prevailing rates. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Based on management’s evaluation and experience, no allowance for loan losses has been recorded at December 31, 2024 and 2023.

Payment of Benefits – On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. If a participant's vested account balance is \$1,000 or less, the participant will receive a single-sum payment at termination.

Under the terms of the Plan, participants may receive the balance in their account after termination of service. Participants may receive any or all of the vested balance in their 403(b) account to satisfy a heavy and immediate financial hardship, upon retirement, or upon termination of service.

1) **PLAN DESCRIPTION, Continued**

Vesting – Participants are immediately vested in their voluntary contributions and the Plan Sponsor’s contribution plus actual earnings thereon.

Other – The Plan contains provisions for limitations affecting highly compensated employees and maximum annual additions to participants’ accounts for any plan year.

Forfeitures – Participants are immediately vested in their voluntary contributions and the Plan Sponsor’s contributions plus actual earnings thereon. Therefore, there were no forfeitures for the years ended December 31, 2024 and 2023.

Benefits – Benefits are recorded when paid.

2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

General – The accompanying financial statements have been prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (“FASB”), which establishes generally accepted accounting principles (“GAAP”) that are followed in reporting the statement of net assets available for benefits and the statement of changes in net assets available for benefits. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (“ASC”). The Codification replaced and incorporated (but did not change) accounting guidance previously issued by various accounting sources through specific pronouncements.

Investments – Investments are stated at quoted market values as established on national securities exchanges. Investment transactions are accounted for on the trade date. The cost of units of investment vehicles sold is computed on an average-cost basis. All investments are comprised of contributions deposited therein, plus interest credited to the accounts and transfers from other separate funds, less withdrawals, and transfers to other separate funds. Appreciation and depreciation of fair values are included in arriving at the individual account balances at year-end.

Estimates – The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such a change could materially affect the amounts reported in the financial statements.

3) **FINANCIAL INFORMATION FURNISHED BY THE TRUSTEE**

The Plan Sponsor has assigned fiduciary responsibilities to VFI, who holds the Plan’s assets and executes its transactions. The Trustee has prepared the following information with respect to assets, liabilities and changes in net assets and participants’ equity included in the accompanying financial statements and supplemental schedule and have furnished it to the Plan administrator together with a certificate that such information is complete and accurate. Such certification is required under the methods of compliance with the Department of Labor’s rules and regulations for Reporting and Disclosure under ERISA Section 103(a)(3)(C), as elected by the Plan administrator.

5) FAIR VALUE OF INVESTMENTS

The Plan follows the ASC *Fair Value Measurements* guidance. This guidance defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements.

This guidance defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. It also establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The guidance describes three levels of inputs that may be used to measure fair value. Level 1 inputs represent fair values obtained using quoted prices in active markets. Level 2 inputs represent fair values obtained from observable market data but not from quoted market prices. Level 3 inputs represent unobservable inputs that are supported by little or no market activity and are generally based on the entity's own assumptions.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. At the discretion of VFI, certain securities may be valued on the basis of market valuations provided by independent pricing services when such prices are believed to reflect the fair value of such securities. Values provided by the pricing services, as well as values determined by the Trustee, are generally determined as follows:

- Securities traded on exchanges are valued at closing market prices. When no trades are reported by the exchanges, they are valued at the most recent bid quotation.
- Securities traded in the over-the-counter market are valued at their last sale or bid price.
- Government and agency obligations are valued based upon bid quotations for identical or similar obligations.
- Certificates of deposit and other short-term money market instruments are generally valued at cost, which approximates fair value.
- The investments of the Fixed Account are generally valued at an amortized cost which approximates fair value as long as a substantial portion of its assets are redeemable at par on demand. If adjustments to value the fund's investments at fair value are necessary, such adjustments are charged to income from investment activities.

6) TAX STATUS

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRS Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Plan obtained a determination letter in 1976, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRS. The Plan has been amended since receiving the determination letter. However, the Plan Sponsor and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS Code.

7) PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate its contributions at any time, amend elective provisions, amend the Plan itself, or terminate the Plan, subject to provisions of ERISA. Upon termination, each member or former member or beneficiary entitled to participate in the Plan shall have a fully vested, non-forfeitable right to the entire amount of his account balance.

8) ADMINISTRATION OF THE PLAN

Certain administrative functions are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. Administrative expenses for the custodian's and administrator's fees are paid directly by the Plan Sponsor.

9) RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The amount of net assets available for benefits per the financial statements at December 31, 2024 and 2023 agrees to the amount reported on Form 5500.

10) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

11) PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

The Plan Sponsor has assigned fiduciary responsibilities to Voya Financial, Inc., who holds the Plan's assets and executes its transactions. This company is considered to be a party-in-interest. Fees paid by the Plan for the investment management services provided by Voya Financial, Inc. amounted to \$13,771 and \$11,924 for the years ended December 31, 2024 and 2023, respectively.

12) SUBSEQUENT EVENTS

The Plan Sponsor has evaluated subsequent events with respect to the Plan through June 13, 2025, the date the financial statements were available to be issued. There were no matters requiring recognition or disclosure.
